We are aware that our old and water damaged toys do not create a good impression to newcomers. As one of the more remote communities in the area, village groups of this nature are essential to keep people socialising and forming friendships within the village rather than travelling to nearby towns to toddler groups. The beneficiaries are the babies and toddlers (under 3's) that attend the Minety Toddler Group and their carers, approx 15 children and 10 carers currently.

It is harder to attract new members though due to the state of the toys which are rusty and mouldy due to a leak in the shed, and this is an area that would immediately show a benefit if we had new toys and equipment and new storage. We are always keen to increase numbers and we feel sure that new equipment will assist in this process.
