WE ENJOY BEING AT THE HEART OF THE COMMUNITY IN THE TOWN HALL AND OUR LOCATION IS ALSO A FACTOR IN WHY PARENTS CHOOSE OUR SETTING. HOWEVER OUR RENT IS VERY HIGH AND SUBSEQUENTLY WE HAVE NO SPARE FUNDS TO UPDATE OUR EQUIPMENT. THERE IS NO OUTDOOR SPACE AT THE PRE SCHOOL BUT IN ACORDANCE WITH THE EARLY LEARNING FOUNDATION STAGE THERE MUST BE AN EMPHASIS ON PHYSICAL ACTIVITY WHICH 'HELPS PUPILS GAIN CONFIDENCE IN WHAT THEY CAN DO AND ENABLES THEM TO FEEL THE POSITIVE BENEFITS OF BEING HEALTHY AND ACTIVE' QCA 2000.
