The main beneficiaries of this project will be the members of the two adults sides plus withing six months of the completion of the work, the club's then under 15 side. This will also give the club more training options by it being able to use more of the space during the season. An added benefit is that this work is to be done on a small part of the cricket club's outfield which will mean some modest improvements to that part of the cricket field. The direct beneficiaries will be some 30 members of the senior teams along with 16 under 15 players plus 18 cricketers. The work the club has embarked on in improving the senior pitch has come not only from the club's wish and need to improve the pitch but also as a result of occasional criticism from opponents and referees about the pitch. It is appropriate to mention that at the end of each of the last two seasons, we have excavated parts of the pitch, levelled the ground and improved drainage at a cost to the club of over £2100 without any outside financial assistance.

There will be no additional maintenance costs other than usual maintenance ie fertiliser, cutting etc.

It is acknowledged that initially the two senior sides will benefit from the work but, as mentioned earlier, the current under 14 side will doubtless be needing the pitch as the team develops to under 15 and under 16 football over the next two seasons.
