As an organisation member, the bowls club is similarly committed and bowls covers all age groups. Prior to losing its previous 3 rink green to development in 2007, the club used the Marlborough green for two years and now has a new 6 rink green for 2010. Current membership of 35 is expected to double in 2010 following the return to Ramsbury and a much better than previous facilities. Members are currently aged from 25 to 91 and it is a mixed club which competes in a mixed league. Partnership agreements with the local Shortmat bowls club, Fire Brigade and Scout Group are expected to increase the number of younger players. With 11 coaches the club is well placed to train new players. A new bowling green mower is essential to enable use of the green in 2010. Such mowers are expensive due to short grass length necessary and the cutting speed (200 cuts per metre). Current club reserve funds have been used towards the cost of the new green and pavilion but a number of members are prepared to donate money towards the cost of a mower which will unfortunately amounts to only 50% of the cost.

The mower is expected to last for at least 20 years and maintenance/servicing costs will be allowed for when assessing the 2010 subscription rates. The cutting is carried out by a voluntary team of ten members on a rota system and the purchase will include certified instruction of this team by the manufacturer to conform to Health and Safety and Insurance requirements.
