The Friendship Club is a relatively new venture which meets weekly on a Tuesday morning. The doors are open to all people from the local area, with different backgrounds and all ages and abilities are encouraged to attend and catered for. The usual attendance is anything up to 20 people, all from the local area, but predominantly from Marlborough. The age range of usual attendees would be from 34 to 84 plus and whilst most of those would generally be female, males do attend and are always welcome. The group offers mutual acceptance, support and friendship as well as an opportunity for those less able to take on positions of responsibility in a safe environment and thereby gaining a degree of self worth and personal pride. Should it be required, details of regular attendees could be supplied.
