## 1. PURPOSE OF THIS REPORT

The purpose of this document is to highlight the progress made on the actions in the Four Rivers and Stonehenge Community Plans.

## 2. BACKGROUND

During the summer of 2003, the South Wiltshire Strategic Alliance distributed a community questionnaire to 49,000 households in South Wiltshire. The following numbers of questionnaires were returned from each community area within the Northern Area:

Four Rivers	1,818 questionnaires
Stonehenge	4,164 questionnaires

The results of the questionnaires, coupled with public meetings and workshops, identified a number of priorities across the Northern Area. Priorities ranked for each community area were as follows:

FOUR RIVERS	STONEHENGE
1. Looking after the roads	1. Looking after the roads
2. Housing local people can afford	2. Vandalism & Anti-social Behaviour
3. Public transport	3. Reducing Crime
4. Reducing crime	4. Cleanliness of roads, streets and open spaces

6. Cleanliness of roads, streets and open spaces	6. Housing local people can afford

The priorities identified have been allocated into 8 themes, which reflect the policy themes in the Wiltshire Community Strategy. These themes are:

Countryside and Land-Based Issues; Crime and Community Protection; Culture; The Economy; Education, Skills & Learning; Housing and The Built Environment; Social Care and Health; and Transport. An additional theme of Access to Services has also been used.

The draft community plans were subjected to extensive consultation with key local stakeholders and organisations. The final draft for the Stonehenge plan was approved by the Northern Area Committee on 14<sup>th</sup> October 2004 and the final draft for Four Rivers was approved by the Western Area Committee on 7<sup>th</sup> October 2004. Both plans were published in January 2005. The plans cover a five year period, 2004-2009.

The purpose of the plans is to publish the results of what local people want to see, as well as influencing partner organisations of South Wiltshire Strategic Alliance to address priorities in the community plan areas.

### **3. MONITORING THE PLANS**

It has been agreed that the Alliance will provide six-monthly monitoring reports for all six Community Plans and report to each Area Committee.

There was no community planner in post in the Four Rivers area from Jan-Oct 2005 due to a secondment. The post of community planner for the Stonehenge area has been vacant since March 2005.
