### 1. PURPOSE OF THIS REPORT

The purpose of this document is to highlight the progress made on the actions in the Four Rivers and Stonehenge Community Plans Community Plans.

### 2. BACKGROUND

The draft community plans were subjected to extensive consultation with key local stakeholders and organisations. The final draft for the Stonehenge plan was approved by the Northern Area Committee on 14<sup>th</sup> October 2004 and the final draft for Four Rivers was approved by the Western Area Committee on 7<sup>th</sup> October 2004. Both plans were published in January 2005. The plans cover a five year period, 2004-2009.

### 3. MONITORING THE PLANS

It has been agreed that the Alliance will provide six-monthly monitoring reports for the Community Plans and report to each Area Committee. Progress was also reported at The Alliance Conference in February 2006. We are additionally using The Citizen and for the first time parish magazines, to let people know what is happening. By obtaining and monitoring updates on the actions in the community plans, and publishing them, we are identifying progress towards each action and demonstrating accountability. We make it clear which organization has done the work - the Alliance does not take credit for the work of others, but uses the update reports as a tool to inform on progress locally.

This time, in seeking an update from partnership organisations, we have requested that wherever possible, they provide quantified information, and provide the update in the context of 'what difference has this made to people's lives'. Also included are examples of other successes or new relevant activities, which are being carried out by partner organisations.

The practical benefits in monitoring the actions in the community plans, ensures that they do not fall off the radar. If actions have been achieved, then that is good news for the community, if not, then we can identify why not and possibly take action to address this. Sometimes, however, actions in the community plans will have changed or not be relevant anymore. When we come to the next cycle of community planning, we will be better positioned to know what actions have been achieved and why those not achieved have failed.

The first monitoring report was presented to NAC on 15 December 2005, and the following issues were raised:

**Action 122: A dog warden on the Nine Mile River site in Bulford.**

Issue: Major problem with dog fouling at Bulford and Figheldean. Please can something be done about this.

Officer Response: No further action possible. Resources not available within Environmental Services.

**Action 131: 'Rethink Rubbish' Directory.**

Issue: Please can we have a small, concise leaflet telling people what they need to know about recycling, not a lengthy document. Explain what can be recycled, how and what it costs.

Update: WWT really appreciated this constructive feedback. They are currently developing a directory for the Mere and Tisbury areas, and as a result of NAC comments plan to incorporate a pull-out quick reference guide as part of that directory. When they come to review the Amesbury directory, they will take the NAC feedback for this area too.

**Action 244: Identify need for new footpaths and cycle ways.**

Issue: The Stonehenge plan already identified some footpaths that are needed. We can't be expected to wait until the outcome of the parish planning process before anything is done about allocating funding to these schemes!

Update: Awaiting response from WCC

**Action 244a: Provide new footpaths and cycle-ways in the area.**

Issue: There is an urgent need for a footpath from Bulford to Solstice Park. Pedestrians are in danger walking on the road in the dark.

Update: Awaiting response from WCC

**Action 266: Keep the opening of Wilton Railway Station and the introduction of a London Waterloo service and Cardiff to Portsmouth service high on the agenda of the Regional Transport Strategy.**

Issue: Please can we also keep the opening of Porton railway station on the agenda?

Update: Awaiting response from WCC

**Other Issues Raised:**

Issue: Bulford crossroads are very dangerous. Please can we have an update on what is happening on plans for a roundabout? There has been an increase in traffic in the past two years since last survey done.

Officer Response: 3 years ago Bulford crossroads was on WCC's list of accident cluster sites - having had 3 accidents. The site was investigated by WCC officers outside the JTT, and the type of collisions that had been occurring were not conducive to carrying out major work. One option deemed viable, was a potential scheme involving a double mini-roundabout. However, WCC has a limited road safety budget for accident sites, so has to prioritise its resources on its top accident cluster sites. Last year, for instance, schemes that were delivered were for sites that had a history of between 5-15 accidents over the past 3 years. The accident record at Bulford crossroads has improved in the last three years, with only 1 accident recorded in a rolling 3 year period, so (as it has dropped down the priority list) it would not be considered that any action is necessary to alter the road layout for road safety reasons.

If any future development occurs in the vicinity, WCC would look to try and deliver a double mini-roundabout by way of developer contributions. WCC did seek to secure improvements for the Bulford area as part of the Project Allenby MoD development, but their traffic modelling showed very small increases in traffic growth arising out of the development, so could not justify any works at this location other than an improved speed limit gateway on Salisbury Road on the entrance to Bulford to mark the start of the 30mph limit.

## South Wiltshire Strategic Alliance Access to Services Survey

### Summary Results From People's Voice Survey, October 2005

Over 500 respondents from across the district were asked to indicate how easy they found it to access the 15 public services below. Services have been ordered according to their ease of access for the district as a whole (easiest to access first). Note that there are significant differences for each community area, with access to services overall being easiest in the City and most difficult in the Mere and Nadder Valley community areas.

Council offices have scored poorly overall. However, the breakdowns highlight a difference of 15% in the ease of access figures between the council office and library in Mere, and a 37% difference in Stonehenge. In both these areas the two services share a common location and broadly similar opening hours - which makes one question how the respondents interpreted the question.
