Report subject: Community Safety in the Northern Area

1. Report Summary:

To inform Committee Members about ongoing community safety work in the northern area and to describe the structures and processes in place.

2. Background - Community Safety Issues in the Northern Area:

- 2.1. South Wiltshire is a safe place to live, with Wiltshire having one of the lowest crime levels across the country. The Community Safety Partnership is tasked with reducing crime, disorder and anti-social behaviour and in particular working towards achieving a 12.5% reduction in the Wiltshire British Crime Survey Comparator Crimes by 2007/2008. The Partnership is already well on the way towards achieving this, having reached a 10% reduction in 2005/06 compared to baseline figures.
- 2.2. In the most recent Crime and Disorder Audit (2004) and subsequent strategy (Reducing Crime and Combating Drug Misuse in Wiltshire 2005-2008), Amesbury West featured as the 3rd placed ward for recorded levels of crime (2002/03 figures behind St Martin & Milford and St Edmund & Milford) and interestingly was the highest rated ward for violent crime and domestic violence (although this crime never features through consultation exercises), 3rd placed for domestic burglary (although figures are not significantly large) and theft and handling offences, 2nd for criminal damage offences.
- 2.3. The Amesbury community area (Northern area) as a whole usually features behind Salisbury community area as the 2nd highest area for reported incidents of anti-social behaviour this is approximately 22% of the total reported incidents.









3. Work and structures in recent years:

As a result of early Community Planning processes in South Wiltshire a Northern Area Community Safety Partnership was set up some years back supported by Community Planning Staff. The then Head Teacher at Stonehenge School played a key role in leading and chairing this group. As a result the South Wiltshire Community Safety Partnership financially supported some projects targeted at tackling certain crime related problems – in particular a surveillance camera project with potential elderly victims of distraction burglaries. This Partnership would appear to have waned somewhat in the last couple of years.

More recently the Anti-Social Behaviour Reduction Officer working in partnership with local Police staff, has liaised primarily with the Northern Area Committee over issues of anti-social behaviour. Training was provided for community representatives and councillors about their responsibilities under Section 17 of the Crime and Disorder Act and about their role in tackling anti-social behaviour back in 2004 and since then a number of presentations have been provided to the Northern Area Committee around dealing with incidents. Information packs and incident log sheets have been developed and distributed. Many incidents have been dealt with within the area, in conjunction with those communities concerned.

Community safety staff were also instrumental in assisting Amesbury Town Council with the implementation of an Alcohol Exclusion Zone for the town back in 2003 in response to alcohol related nuisance.

The Community Safety Partnership also supports and funds (through a Home Office allocation) a variety of pan-district projects and initiatives accessible to all. These include the Alcohol Referral Programme for Offenders and Victims, a scheme whereby offenders are referred to the Salisbury Alcohol and Drug Advisory Service (ADAS) as part of their bail conditions, to try to reduce alcohol related re-offending, Street-based Youth Work aimed at identifying and working with young people at risk and out on the streets, and the use of Anti-Social Behaviour Orders, Acceptable Behaviour Contracts and other powers to disperse and deal with intimidating groups and individuals.

4. Current Work:

The Anti-Social Behaviour Reduction Officer is currently involved in a major piece of work tackling anti-social behaviour problems in Durrington. An action plan has been developed in involving many agencies both local and statutory. By way of an example of the level of detail involved in this work a copy of the action plan is attached as Annex A.

In addition work is being planned aimed at tackling issues related to the late night economy and alcohol related nuisance in Amesbury town centre.

5. Future Developments:

The most significant development for the Northern Area at present is the introduction of the Neighbourhood Policing Team initiative from October 2006. This will mean the role out of a dedicated and accountable team for the area who will work closely with the other agencies to tackle crime, community safety and neighbourhood problems. The areas will also benefit from additional Police Community Support Officer resources and discussions have already taken place with regards to funding and recruitment for the Northern Area is well underway. It is anticipated that the Northern Area Committee will have a role to play in this process.

In addition the Amesbury Market Towns Partnership (AMTP) is a community partnership funded through the Market and Coastal Towns Initiative. A group of residents, business people, Councillors and community groups have come together to prepare a community strategy for the area through consultation with residents and key stakeholders. At present there do not appear to be specific community safety issues that have emerged through this consultation process, however it is anticipated that such issues will be an integral part of the final strategy and therefore will require action and resources.

6. Recommendation(s):
