1. PURPOSE OF THIS REPORT

The purpose of this document is to highlight the progress made on the actions in the Four Rivers and Stonehenge Community Plans since the previous update on the 18th May 2006.

2. BACKGROUND

The draft community plans were subjected to extensive consultation with key local stakeholders and organisations. The final draft for the Stonehenge plan was approved by the Northern Area Committee on 14th October 2004 and the final draft for Four Rivers was approved by the Western Area Committee on 7th October 2004. Both plans were published in January 2005. The plans cover a five year period, 2004-2009.

3. MONITORING THE PLANS

It has been agreed that the Alliance will provide annual monitoring reports for the Community Plans and report to each Area Committee. Progress was also reported at The Alliance Conference in February 2006. By obtaining and monitoring updates on the actions in the community plans, and publishing them, we are identifying progress towards each action and demonstrating accountability. We make it clear which organization has done the work - the Alliance does not take credit for the work of others, but uses the update reports as a tool to inform on progress locally.

In seeking an update from partnership organisations, we have requested that wherever possible, they provide quantified information, and provide the update in the context of 'what difference has this made to people's lives'. Also included are examples of other successes or new relevant activities, which are being carried out by partner organisations.

The practical benefits in monitoring the actions in the community plans, ensures that they do not fall off the radar. If actions have been achieved, then that is good news for the community, if not, then we can identify why the action has not been achieved and take appropriate action to address this issue. In some instances, however, actions in the community plans will no longer be relevant or will have been completed prior to the current update and their status between updates will not change. In other cases, actions are aspirational or more long-term, so may not show much progress from year to year. When we come to the next cycle of community planning, we will be better positioned to know what actions have been achieved and why those not achieved have failed.










4. PRIORITIES BY LOCAL RESIDENTS

On the 11th September 2006, The Wiltshire General Household Survey was sent out to a random sample of 3,500 people throughout Wiltshire. The survey is carried out every three years by Wiltshire County Council and the Department for Communities and Local Government (DCLG) and is intended to collect information on a range of topics from people living in private households in Wiltshire. The information is used by central and local government departments and other organisations for planning, policy and monitoring purposes, and to present a picture of households, families and people in Wiltshire.

Questions in the survey are set down by the DCLG in order to remain consistent across all county councils in the UK. A report presenting the results of question 2 of the survey which asked 'Which things do you think most needs improving in this local area?' provided the following results for Amesbury;



5. UPDATE ON COMMENTS AND QUESTIONS

The second monitoring report was presented to NAC on 18th May 2006, and the following issues were raised:

Action 55: WCC is looking at options for re-location of the Youth Centre, including the potential of old Court Room as a youth venue.

<u>Issue:</u> Members indicated that they would like to receive an update on the potential use of the Old Court Room as a youth venue.

Officer Response: The refurbished Old Court House has been completed and will open as a Youth Development Centre on July 10 2007.

Action 79: Moped access project provides opportunity to secure employment or further education and mopeds allocated to those with the greatest need.

<u>Issue:</u> Members would very much like the Moped Access project to continue and feel as much pressure as possible should be exerted to ensure this is the case.

Officer Response: External funding ceased in September 2004 and the project has not been renewed. Mopeds are still used for motorcycle training through the Momentum project (encouraging responsible road use), however these are not loaned out to young people as they are probably not roadworthy.

Action 254: Work with WCC and bus operators to explore the scope for integration of rural bus services into Wilton Park & Ride.

<u>Issue:</u> Members suggested that Wilton Park and Ride site should also be used for parking at Salisbury Station. Councillor Edge suggested a number of alternative uses for Park and Ride sites in Salisbury District, e.g. for school use and also consideration of the extension of opening hours. Members agreed that it would be useful for Councillor Edge to put his suggestions forward for consideration by the Environment and Transport Scrutiny Panel. Officer Response: There has been no progress with this action since 2006. This question

Officer Response: There has been no progress with this action since 2006. This question refers to use of the Park and Ride sites for other purposes. This is more a matter for District Council so WCC have no comment.

Action 285: Wiltshire County Council Travelwise team to work with schools through school travel plans.

<u>Issue:</u> Members queried whether the school travel plans were bearing any fruit. The Area Coordinator informed Members that a Review of School Transport was currently being undertaken and would be considered by a future Environment and Transport Overview and Scrutiny Panel meeting.

Officer Response: As of April 2007, 60% of schools in Wiltshire have a School Travel Plan. The results from the review are as follows;

As set out under the LTP4 target and indicators in the Local Transport Plan 2, WCC aims to reduce car usage on the school journey as follows:

Young Assessors - a ongoing programme for young people involved in the quality assurance of projects (young people involved county-wide). Arts Awards - WYAP involved in the delivery of the award at bronze, silver and gold level to accredit young people's achievements in the arts.
