THESE INCLUDE REDUCED HEATING BILLS DUE TO HIGHER THERMAL INSULATION, A REDUCTION IN THE CO2 FOOTPRINT OF THE HALL AND THE REMOVAL OF A SAFETY HAZARD DUE TO AGEING, NON-SAFETY GLASS. THE BENEFICIARIES INCLUDE ALL CURRENT & FUTURE USERS OF THE HALL - WHICH EMBRACE ALL AGES, GENDERS AND ETHNICITIES - AND COVERS A DIVERSE RANGE OF SOCIAL, SPORTING, EDUCATIONAL AND COMMUNITY ACTIVITIES. ON AVERAGE, SOME 1,000 PEOPLE UTILISE THE HALL'S RESOURCES EACH MONTH - WITH AGES RANGING FROM 3 YEARS OLD TO 90+. NEW DOUBLE GLAZED UNITS WILL INCREASE THE USAGE OF THE RECENTLY REFURBISHED KITCHEN AND IMPROVE THE AESTHETIC APPEARANCE & FUNCTIONALITY OF THE ROOM. IT IS THE INTENTION OF THE TRUSTEES TO GRADUALLY REPLACE ALL OF THE 1960's SINGLE GLAZED UNITS IN THE HALL ON A PLANNED BASIS OVER THE NEXT 5 YEARS.  BURBAGE VILLAGE HALL IS A REGISTERED CHARITY - No 305478

THERE WILL BE NO ONGOING PROJECT DRIVEN COSTS RESULTING FROM THIS PROPOSAL AS THE TRUSTEES DO NOT OPERATE A DEPRECIATION POLICY IN THEIR ACCOUNTING SYSTEM. IN FACT, THE VILLAGE HALL WILL SECURE AN OVERALL REDUCTION IN ANNUAL REVENUE COSTS DUE TO A LOWERING OF ITS HEATING & FUEL BILLS. IT IS THE POLICY OF THE FINANCE SUB-COMMITTEE OF THE VILLAGE HALL TO RETAIN APPROXIMATELY ONE FULL YEAR'S OPERATING COSTS IN RESERVE TO ACCOUNT FOR CONTINGENCIES/EMERGENCIES - IN LINE WITH PRUDENT FINANCIAL MANAGEMENT GUIDELINES RECOMMENDED BY THE CHARITY COMMISSION.
