# **Amended condition**

06/01065/FUL - Land Rear of 1 To 1b Sarum Avenue, Melksham

The Committee agreed with the Officer's recommendation subject to the following conditions:

Before the development is occupied, the access and car parking areas shall be surfaced in a bound material (not loose stone or gravel) to the satisfaction of the Local Planning Authority and shall be maintained as such thereafter.

REASON: In the interests of highway safety.

POLICY: West Wiltshire District Plan - 1st Alteration - Policy C31A.

The first floor window in the elevation facing 1 to 1b Sarum Avenue shall be obscure glazed prior to the first occupation of the development hereby permitted and shall be maintained as such at all times thereafter.

REASON: In the interests of amenity and privacy.

POLICY: West Wiltshire District Plan - 1st Alteration - Policy C38.

## **Applications Deferred**

## 05/00807/FUL - Land rear of 95 to 133 Frome Road, Trowbridge

Officers recommended that planning permission be granted at a future date in the event of the Development Control Manager being satisfied as to the prior completion of a legal agreement. However the Committee resolved to defer the application to enable a site visit and for further consideration to be given to:

- 1. Further negotiations with County Highways Authority for a contribution towards traffic calming measures in Frome Road.
- 2. Proposals for ensuring improved access for existing residents.
- 3. The provision of further details of the proposed boundary treatment.
