EVERLEIGH & OTHERS – Full planning application for the construction of a military track (Eastern Access Route) and associated hardstanding on the Salisbury Plain Training Area.

3. The development hereby permitted shall not be commenced until details of the proposed public footpath route have been submitted to and approved in writing by the local planning authority. Details shall include proposed materials and the gradient of the proposed ramp.

REASON:

To ensure that the steps and ramp will be constructed safely and appropriately for public use.

4. Before the construction of any wall(s) and railings is commenced details of the design, height position and materials of which they are to be constructed shall be submitted to and approved in writing by the local planning authority. Development shall be carried out in accordance with the approved details.

REASON:

In the interests of visual amenity.
