4. UNREASONABLE & PERSISTENT COMPLAINANT POLICY

The Director of Community Services presented Members with a policy that addressed the nuisance of a small number of unreasonable & persistent complainants. Members learnt that the policy had originated from the Local Government Ombudsman and could also be used as guidance for Parish and Town Councils wishing to produce a policy of their own. After consideration it was

RECOMMENDED

THAT the Council adopt the Unreasonable and Persistent Complainant Policy with the following additional recommendation:

“That the policy be amended to ensure a complainant’s Ward Member(s) is/are informed when action is initiated in accordance with the policy.”

5. DRAFT PROGRAMME OF MEETINGS 2007-2008

The Committee considered the suggested dates for meetings in the 2007-2008 year, and were given revised dates for the Planning Policies Executive Committee (4th April 2008 moved to 27th March 2008), and the Human Resources Committee (14th June 2007 moved to 21st June 2007).
