This has minimal cost to Tidworth Town Council. However, there are several specific work requirements stipulated by the Diocese one of them being maintenance/upkeep of monuments. Sadly nine monuments were vandalised/graffitied and when being cleaned lettering has been damaged or erased. Therefore funds are required for the restoration of the monuments. Tidworth Town Council have taken on the Chapel and this particular project as it feels it is of great importance to Tidworth's heritage and provides historic knowledge to the community and do not want an important part of both the past and future to be lost. Upon transfer of ownership to Tidworth Town Council the Chapel was subsequently deconsecrated and classed as a listed building with Historical Interest Grade II by Land Registry.
