The benefits include creating a real network of Arts groups with the aim of involving more people actively as both participants and audiences for the cultural activities in the Community Area. There is a need for better publicity and our proposed website needs to be more regularly updated to ensure publicity for all activities with involvement from the Development Worker. The other way of increasing public awareness is by taking part in Community Events to publicise the work of the BA14 Culture Group and also current cultural activities in the Community Area. We want all groups to be able to access these activities and we are aware that those who are less well off can be excluded because of cost of both performances and transport. We believe that people can get huge benefits from participating in cultural activities by developing new skills and their own creativity which can increase their self esteem and thus quality of life.

The numbers are hard to estimate but working with the cultural groups we will endeavour to establish the increase in numbers taking part and attending activities as part of the evaluation of our project.

This programme of work linked to the Awards for All work is the first step in our Cultural Strategy. Its success will we believe develop more volunteer support for aspects of this work. However for further development which is needed we intend to bid for a 3 year development programme to follow this first year. It is likely that we bid to the Arts Council and other funding bodies to fund this work. We are aware that the Trowbridge Community Area is presently considered by many to be a cultural desert and we intend to change this.
