The development and promotion of the group will increase the partnership's ability to help form new Neighbourhood Groups. The TNP has already has success in encouraging the formation of new Neighbourhood Groups and its membership has increased from 4 to 11 TARAs and RAs. TNP enables the groups to discuss current issues and to give guidance on funding solutions. There is strength in numbers and TNP has more success in attracting relevant officers from WC, TTC and other agencies to address common concerns/ issues. Joint funding by WC/TTC has led to more dropped kerbs, neighbourhood policing has been strengthened particularly on anti-social behaviour. The total membership of the 11 groups is in excess of 300 but the groups cover areas with a total population of about 10,000 and covers all age group etc

Grant funding will be sought from a range of grant givers and TTC has a grants officer who will assist with this. The group wishes to develop training for its members and some is provided through Selwood Housing and TTC

The partnership has representatives from all its 11 member associates and works with WC, TTC, the Police, Fire and Rescue to address current issues . Neighbourhood policing has progressively improved, most recently with the introduction of the Policing Pledge where the real concerns of obstruction of officers from NPTs has now been positively addresses, the Parish Steward's work is identified and monitored leading to tidier local areas; joint funding of dropped kerbs by WC/TTC has doubled the number of dropped kerbs with TNP identifying priorities. This will be repeated. By working with other Associations in partnership local citizens have a stronger voice.
