Updates

Following the previous Westbury Area Seminars on 16 February and 28 April a number of issues were raised. This paper has been put together to update members on the progress with those issues.

Publication of the location of Household Recycling Centres and the flytipping hotline

Westbury Area Seminar at its meeting on 28 April 2005 resolved that:

That West Wiltshire District Council looks at increasing the publicising of the location of Household Recycling Centres and the flytipping hotline telephone number

Louise Knox, Communications Officer, provided the following statement:

West Wiltshire District Council tries to promote the existence of the Household Recycling Centres in at least two of every three West Wilts Matters. When informed of this resolution the summer West Wilts Matters had already been written, however this information will be included in the Autumn West Wilts Matters, together with the fly tip hotline.

The County Council also publicises the Household Recycling Centres through the Wiltshire Waste Partnership.

Household Recycling Centre

At the meeting of Westbury Area Seminar on 16 February 2005 the committee recommended that Cabinet be requested to give consideration to the provision of a household recycling centre in Westbury. At the meeting on 9 March Cabinet considered the recommendation and resolved that:

"Wiltshire Waste Partnership be asked to provide a Household Recycling Centre in Westbury ASAP" '.

The Wiltshire Waste Partnership considered the provision of a household recycling centre in Westbury at its meeting on 14 April 2005. The exert of the Wiltshire Waste Partnership minutes referring to this request is as follows:

A report prepared by Hills, together with a location map of existing facilities, was considered. It was agreed that the provision of an HRC at Westbury could not be supported at this time in view of the location of existing services and the result of the cost benefit analysis provided by Hills Waste.
