Dear Sirs

Re: Licensing Act 2003 - Formal Warning Notice

I am writing to inform you that it has been brought to our attention that your premises are serving Late Night Refreshment after permitted licensing hours.

Serving after permitted hours is an offence under the Licensing Act 2003. **This means that all customers must have left your premises by closing time and no customers must be in your premises awaiting their order.**

Should evidence be produced showing that your premise is in breach of its Premises Licence, we will have no hesitation in commencing with prosecution proceedings.

Concern has also been raised about the amount of litter in the area from fast food wrappers, under Section 93 of The Environmental Protection Act you can be required to clear up any wrappers/containers on the street outside of your premises. Could you please arrange to do so on a daily basis.

The penalty for conviction for offences under the Licensing Act 2003 is up to £20,000, up to 6 months imprisonment or both.

If the doors are shut customers often remain inside and area served though no further customers are let in. On 25/04/2010 on 2 occasions friends of customers inside the premises were seen to place new orders after 3am by either shouting to people inside or phoning them. This has also been seen on previous occasions though dates are unknown.

the chest by [redacted] who was stood on the door, at the same time [redacted] was being pulled backwards by door staff. [redacted] and [redacted] had to activate their emergency buttons to request backup as more door staff appeared.

The door staff appeared out of control and showed total disregard to police. The door staff appeared to believe that they thought they were above the law and could say who could and couldn't be arrested. All the door staff at [redacted] were totally un-professional.

I am the above named person and I live at the address shown overleaf. I am making this statement about an assault of my boyfriend _____ outside Chic-o-land in Chippenham at about 2.20 am this morning Friday 4th June 2010. The attackers were Paul FISHER, someone called Tony and another male. I have been in a relationship with _____ for about 10 months, during that time I have never witnessed him get into any fights or anything like that. I would describe him as being a soffie. On Thursday 3rd June I went into town with _____ AND MY _____. We went to _____ which is a nightclub in _____ Chippenham. We got there about 10.30 pm. _____ joined us at about 11 pm he was with _____ and _____. They are friends of _____. The club was very quiet when we arrived. There were only two other person inside and that was Paul FISHER and someone called Tony. I don't know Paul FISHER personally _____ has mentioned him before and I've seen him out and about in Chippenham previously, I was up the bar getting myself a drink of coke as I was walking across the dance floor to go back outside to see _____ approached me and said that Paul FISHER had been putting his hand up her skirt. He kept trying this when he was walking past. I did not witness this. I said I would have a word with him about it. I know that Paul FISHER fancies _____ but _____ does not fancy him. I went over to Paul FISHER and said "Can you leave _____ alone?" He said "Why would I I've got a missus." I then went back to _____ to make sure she was ok. Within about thirty seconds Paul FISHER came over he started shouting, I told him to leave _____ alone. Paul FISHER was quite aggressive and was shouting. He was getting closer and closer trying to get to _____. I was stood in between them and fearing what Paul FISHER was going to do I pushed him back. I used my right hand and held out my right arm to check him back rather than any forceful push. _____ went off to the toilets. I started talking to _____. Because _____ mates came over I went back indoors. After about 45 minutes I saw his mates come back into the club but I couldn't see _____. I walked out to see where _____ was and he was surrounded by Paul FISHER and his mates. I got between them and took hold of _____ and walked him away. _____ told me that Paul FISHER was expecting me to apologise. It got to about 2.15 am just as we were about to leave when Louie came over and said that Paul FISHER and his mates were planning on beating _____ and _____ up. We went to Chic-o-land New Road, Chippenham. There was only _____ and I that went to Chic-o-land. We were inside Chic-o-land when Paul FISHER and his mates turned up. Paul FISHER said to _____ "Why were you getting gobby?" I said "He wasn't."

[REDACTED] kept saying it so [REDACTED] told him to "Fuck off." [REDACTED] was telling [REDACTED] "to get outside." [REDACTED] was grabbed and being pulled outside by Paul FISHER. I could see as soon as [REDACTED] was outside he was being punched in the head and face by Paul FISHER he was also being hit by someone else but I'm not sure who that was. [REDACTED] ended up on the floor he wasn't moving. I was screaming and went over to [REDACTED] and shook him. He wasn't responding. He was unconscious. There was blood coming out of his nose and mouth. I think Paul FISHER ran off around the corner. He came back and Paul FISHER started kicking [REDACTED] I thin more in the body. [REDACTED] was still unconscious at that point. [REDACTED] was kicked two or three times. Paul FISHER was definitely kicking him and I think it was Tony that was kicking him but I'm not sure. When [REDACTED] was initially being punched I was stood in Chic-o-land about 10 feet away. I was only about four feet away when [REDACTED] was being kicked. Someone pushed me away I was still screaming. It took about ten minutes before [REDACTED] came round. I called 999 for an ambulance.

At this point Paul FISHER came back and Tony was still there. As I was on the phone [REDACTED] was being punched again by Paul FISHER. As [REDACTED] was trying to stand up Paul FISHER punched me in the head. My head jolted and my head was quite painful. I would say that [REDACTED] had been punched about 10 or my times. At no point did I see [REDACTED] fight back. My head is quite tender where I was hit. All punches to [REDACTED] were with clenched fists and were very forceful.

Throughout the evening I drank five vodka and cokes. On a scale of 1-10, 1 being completely sober and 10 being completely drunk I was about a 2-3. The whole incident lasted about 15 minutes. The farthest I was stood away was about 10 feet I could clearly see [REDACTED] being assaulted there were other people around but I could easily see what was going on at all times. I have seen Paul FISHER around before and I would recognise him again. The ambulance arrived and [REDACTED] was being treated. Whilst I was standing with a paramedic Paul FISHER came up to me. I just told him to "Fuck off." I told the paramedic that this person was Paul FISHER. The Police arrived. I would describe Paul FISHER as a white male, 19-20 years old about 5'5" tall skinny build, short spiky brown hair, round face wearing a long sleeved v neck baby blue jumper. I would describe Tony as being a white male, 19-20 years old, 5'7"- 5'8" tall skinny build short brown hair, I think he was wearing a dark jacket. I would recognise him again. I think there was another male called Gareth which I've just remembered, he is a white male, 18-19 yrs old, 5'6" tall quite chubby, wearing a white hoodie with blue stripes. I think it was an 'Adidas' one. I'm not sure what his involvement was.

At 1300 hours on 04/06/2010, DC Hitchcock attended Chick-o-land to request a copy of CCTV from that morning. There was a single member of staff present, Mr Fazal 'Alex' FAIZ. FAIZ refused his date of birth. After total denial of seeing or being aware of any incident in his store, Mr Faiz then said police didn't need his CCTV as the incident happened outside the store and this was clearly his main concern, that the incident remained unconnected with his premises. Mr Faiz

Mr FAIZ informed me he was unable to burn it off as the DVD writer wasn't working. Mr FAIZ also refused me access to the CCTV and was not able to supply a reason why. Eventually, Mr FAIZ implied that any officer must be accompanied by a member of staff at any one time. DC Hitchcock pointed out the area in which Mr FAIZ was working at the time was next to the CCTV. Mr FAIZ refused to let DC Hitchcock view the footage for around 15 minutes.

Mr FAIZ continued to refuse entry and was unwilling to provide a future date when the footage could be viewed. DC Hitchcock then informed Mr FAIZ that a warrant may have to be obtained in order to gain access. Access was then allowed to the store.

Mr FAIZ, having denied any knowledge of an incident in his store that morning, then brought up the CCTV at the exact time in question and was able to point out persons involved before any incident had occurred on the footage. Mr Faiz is seen to run across the shop at the time, and attempt to shut the door but cannot, because the victim is unconscious within the doorway. He was clearly far more involved than he let on.

At all times during the enquiry, the store was quiet, no food was being produced, the phone did not ring and there were no distractions.

The CCTV evidence is crucial in this investigation and Mr Faiz was unnecessarily obstructive.

Police attended Chicoland in Chippenham to view footage of a disorder that may have taken place in the shop. Whilst viewing the footage in the company of the Manager it was established that their CCTV system runs an hour behind. Police requested to view CCTV from the 10 September 2010 from about 0250hrs (time on their CCTV system being 0150hrs) The manager got the footage on the screen. There was no sign of a disorder in the shop however being that it was actually 0250hrs there were a lot of people in the shop coming in and out and people were still being served and food was being cooked. There was no sign of the shop closing or staff making people aware that they would be closing within 7 minutes. The Police Officer confirmed again that it was 0250hrs and at this point the manager became very agitated and then changed the subject stating that he wanted to make a complaint about an officer who keeps being rude to him and his staff. The Manager then fast forwarded the footage to approximately 0302hrs and there was no change regarding people being served or the shop being closed. The Manager then said that one of his colleagues had dropped chips on the floor ordered by a customer and he had to cook more. The result of the enquiry was that there was no footage of a disorder in the shop but it was clear that people were still being served at a time when the shop should have closed its doors.

At 03.05 hours on the 12/09/10 I pulled up outside premises Chicoland High Street Chippenham, which were in darkness, [REDACTED] was already there and had seen two males in the shop still being served. I went into the shop which in was locked, once inside I saw at least one young male who was at the counter who was being served hot food. We spoke to Fazal, I advised him that the premises should have been closed to members of the public by 03.00 hours in accordance with his licence, I explained that has he had previously been warned on several occasions it was his responsibility to ensure that he complied with his licence, and that this matter would be dealt with the following week.
