Our precept for the village is \hat{A} £38000 and to fund the whole project would be over 50% of the annual budget. The majority of the budget is already committed and due to the economic climate, we are mindful of asking for an increase in the precept to cover this project.

Bromham BMX Bike Track

6. Project summary:

This project is to construct a BMX track, approximately 40m x 20m, built from 600-1000 tonnes of subsoil,20 tonnes of crushed rock and clean stone/flex coil for drainage. It would take an estimated 3 weeks build time. The edges would have concrete and the track a gravel surface. With periodic maintenance, this would be expected to last 20 years. The aim of the project is to fulfil a local need for recreational facilities that is, in the main, targeted at the young people of Bromham. However, the facility will have no restrictions and will be available at no cost, for all the community to use.

The current village recreational facilities are limited to a small playarea for under 11's only. and a tarmac area with two basketball hoops for older children. There is a tennis court, run by the tennis club that has a charge for use. It was felt that the current facilities did not address the needs of the youth of the village and a survey was undertaken in the local area of which there were 155 responses supporting the creation of a bmx bike track in the village. Further consultation was undertaken regarding the design and position of the track at an open village meeting. This was attended by 56 adults and 17 under 18yrs, of which there was overwhelming support for a bmx bike track. We also have a facebook page with over 80 likes and growing. The committee for the project is an active group of local people, with the project lead undertaken by a Parish Councillor. Through the newly formed Youth Council, younger members of the village will have a forum to discuss and input into the project where their views will be sought. Meetings of the Youth Council will take place during Youth club and be attended by the project lead who will facilitate the meetings and take ideas back to the Parish Council. Although set up in the first instance for the Bike Track project, the Youth Council will be led by the young persons attending and encouraged to discuss items that affect their generation. Any issues raised can be fed back to the Parish Council by the attending Parish Councillor. This proactive step by the Parish Council will give an opportunity for the younger residents of the village to be more engaged with their community and enable them to bring about a change, thus showing local government in a more positive light and how it can be relevant to the them. The provision of these facilities will primarily benefit the younger residents of the village as it will provide a local meeting place for children and teenagers. Additionally, it will encourage children to be more active and to participate in a sport, thus enjoying the benefits of the outdoors and keeping fit and healthy. Keeping the facility cost free and accessible will enable children to use the bike track when it suits them, and as frequently as they like. The local primary school has 85 pupils and there a similar number of teenage children resident, as well as any adult that wishes try out their riding skills as there is no upper age limit. We feel this bmx track will be a welcome addition to the existing recreational facilities and will provide a much needed alternative to the traditional open sports field, plus the opportunity to participate in an Olympic sport in our own community.

The members of the youth council will be those children that are involved in the bike track project and can report at their meetings whether the anticipated benefits are being achieved to the link Parish Councillor in attendance, who can take this to the full Parish meetings.

This request is for cital funding for a bike track that is designed to last for approximatly 20 years with minimal maintenance which can be planned for in the future from the parish precept.

Wiltshire Museum has the best Bronze Age collection in Britain. We want to inspire visitors to the Stonehenge and Avebury World Heritage Site with the stories of the people who built and used these iconic monuments. Our project features the unique gold and amber finds that define the Bronze Age $\hat{a} \in Wessex \hat{a} \in \mathbb{T}^{M}$ culture. The opening of the new Stonehenge Visitor Centre in 2013 will change the dynamics of the way that people visit Stonehenge, and we want to be ready to bring more people into the heart of Wiltshire. Specifically, we are seeking support for the production of display blocks within showcases, specialist wire mounts for objects and 2 display cases. 14. How will you monitor this?

We have commissioned a full evaluation of the project, using a methodology recommended by the Heritage Lottery Fund. This will include extensive qualitative work, including interviews and surveys, as well a quantative measure such as monitoring visitor numbers.

15. If your project will continue after the Wiltshire Council funding runs out, how will you continue to fund it?

The aim of the project is to appeal to visitors to the new Stonehenge Visitor Centre, encouraging them to visit Devizes to see the new Prehistoric Wiltshire Galleries. Our aim is to triple our visitor numbers, and this will have an impact on local businesses – increasing spend in local shops and restaurants and increasing bed-nights. English Heritage will be marketing the museum alongside the new Visitor Centre, and they are working with us to make the collections that we are lending to the Visitor Centre highly visible. The project will make the museum more sustainable and bring economic development to the Devizes area.

16. Is there anything else you think we should know about the project?

This application is for a discrete part of a major redevelopment to create new Prehistoric Wiltshire Galleries. The overall project cost is over £500,000, with funding from the Heritage Lottery Fund (£370,000), English Heritage (£100,000) and North Wessex Downs AONB LEADER Funding (£27,000) as well as a number of donations and a legacy. The Museum is also making a substantial investment, particularly in terms of staff time and other resources.
