# 8. Please tell us WHO will benefit and HOW they will benefit from your project benefit your local community?

The marguee with its lighting and generator will be a tremendous community asset that will be used by the clubs, societies and charitable organisations within the Colerne community. Specifically it will be used to accommodate stalls and host the annual celebration of National Armed Forces Day. In addition it will be used for the May Fair, Rugby Club and Football Club annual fund-raising events, the Royal British Legion for Remembrance Parade and also for Scouting groups, the Church and other groups. All the above help provide opportunities for integration between generations in the community, developing harmony and embracing diversity. The purchase of a community Marquee, which will be available for the forthcoming National Armed Forces Day on the last Saturday in June, has been fully supported by the Ministry of Defence. They have committed £1,500 to the project. This has been done because of the significant value the event adds to the community. Colerne has hosted a National Armed Forces Day event every year since the National day of celebration was initiated 8 years ago. The event is has become one of the most well supported community cohesion activities held in the village annually, with all community groups and generational groups congregating together at a single focal point, the school. It brings both the local military community and the village community together in a way that cannot be replicated. The purchase of the marquee for that annual event alone warrants support - its availability for use by other groups throughout the year and adds even more weight to the justification and value of its purchase for the community. Consideration was given to hiring a marquee or perhaps loaning one from within the community. However, given that its primary uses will be for national events, it was considered

unlikely that other facilities would be available on the days in question and that to hire such a facility would be cost prohibitive year on year, while the purchase of a marquee with its own lighting and power source in the form of a generator, coupled with and the proper management of its use, would provide a facility that the community will be able to use for many years to come.

#### 9. How will you monitor this?

The management and coordination of the marquee's use will be the responsibility of the Friends of Colerne School who will be the nominated custodians of the facility on behalf of the community.

### 10. If your project will continue after the Wiltshire Council funding runs out, how will you continue to fund it?

The Marquee is seen as an enduring community asset that will be of significant value and utility to the community for many years to come. It is proposed that the facility be made available for hire to private groups with the intent being to use the monies raised to fund any repairs and maintenance to the marquee and also create a replacement fund so the facility can be replaced in the future at the end of its life.

Planned work will include restoring the names of the fallen, renovation of the pedestal and steps and sympathetic cleaning of the stonework.

Everyone, from the youngest to the oldest person from all civilian and service families in the community will benefit. The War Memorial represents continuity, heritage and history. It instills honour, loyalty and selflessness. The restoration will ensure that the War Memorial in the historic Market Place of Colerne rightfully remains pre-eminent. Potentially overshadowed by memorials to Saint Aldhelm and Richard Walmsley Esq a local benefactor, the War Memorial is not only a core for reflection and remembrance for older members of the community but also teaches younger members and children that everyone has the potential to achieve and make contribution to the greater good of the community. Each year the War Memorial is not only the focus for Remembrance Day where the civil, religious and service communities, young and old join to pay their respects to the fallen, but also the core of Armed Forces Day celebrations. The locally-based 21 Signals Regiment recognise the Memorial as the appropriate backdrop to their homecoming and post-operation medal parades. Additionally it is the focal point for visitors to the village which supports local commercial interests. The restoration will be conducted by local conservation stonemasons.

This will be monitored by members of the societies that attend the events and the Royal British Legion Branch.
