Vital equipment requires replacing to enable this local charity based pre-school to maintain a safe, bright, inspiring environment for local families to benefit from the government funded pre-school education. As we are based in a hall used by many other local groups, our equipment must also be fully mobile and easy to store. We would like to replace old display boards that help create separate learning areas as the existing boards are becoming immobile and dangerous. We also need to replace old and damaged play mats with easy to store, clean lightweight ones.

Why can't you fund this project from your reserves:

The majority of our free reserves has been generated by our own fundraising activities, we have an active committee who regularly hold fundraising activities for equipment and improvements (such as the recent installation of wrought iron railings around the hall which were installed at the request of the pre school). The 50% of the funding for this new equipment that is to be provided by ourselves will be financed by previously raised funds in our reserves. We are keen not to use all of our free reserves as we are aware of potential costs for building maintenance work that may required on St Mary's Hall. The current owners, the Scout Group, do not have funds available for resolving damp issues, guttering etc. We cannot afford for the building to close due to these issues and we are currently investigating remedial works to be carried out. The Pre School will also be helping to fund new equipment (oven and fridge) for the planned kitchen refurbishment out of our fund raised reserves.

Cross Hayes Pre School is a local charity providing vital pre-school facilities to the centre of Malmesbury. We currently provide spaces for up to 50 children, aged 2 to 4, to enable local families to benefit from government funded pre-school education. The Pre School is open Monday to Friday during Wiltshire LEA term times, from 09:15 to 13:15, with extended days currently offered on Monday and Wednesday from 09:15 to 14:45. We are the most frequent user of the hall. These basic fixtures and fittings will enable the school to make our space welcoming, safe and inspiring for our children. These low level (child height) display boards will provide distinct learning zones to support each part of the Early Years Foundation Stage curriculum and provide space to display the children's work, explain the world around them and inspire their creativity. The existing equipment was purchased second hand by ourselves over 3 years ago and is now in severe need of replacement. It is becoming increasingly difficult to move the boards as castors break (as we are required for other users of the hall). More modern boards are also of a safer design for the children. The replacement mats are required simply because of the age of the old mats, also purchased second hand 3 years ago, are heavy, dirty and beginning to tear apart. Clean, bright, lightweight mats will be an integral part of the pre-school environment, making it a pleasant place for the children to learn in.
