#### 1. Waste Contracts Task Group

## **Membership**

### Background:

During 21 November Environment Select Committee (ESC), the Committee resolved to establish a 'Waste Contracts' task group. This proposal came about as a result of the ESC-Executive Annual Meeting on the 'Waste' portfolio; where it was agreed that it would be useful to establish a task group to look into the Waste Contracts.

It is recommended that this task group begin after the 'Waste Management Strategy' report is received by the ESC in January 2018 and, should the Committee be willing to endorse the task group at present, membership could then be advertised, with a view to membership being confirmed ahead of January 2018.

The aim of the task group would be to help support the delivery of the Business Plan 2017-27 objective(s) of high recycling rates and reducing litter. It is anticipated that the task group would primarily be considering the development of the Council's commercial waste policy, the implementation and performance of the Council's new waste contracts commencing in July 2018 and the performance of the contract for managing council-owned Household Recycling Centres.

#### **Proposal:**

 To approve the establishment of a Waste Contracts Task Group with the membership and terms of reference to be agreed, with findings and recommendations brought to the Environment Select Committee prior to referral to Overview & Scrutiny Management Committee.
