1. Background

Young people have considered this application and identified it as a priority for Area Board funding.

- 2.4. Councillors will need to ensure that young people have been central to each stage of this Youth Grant Funding application.

Project Description

Marlborough's Local Youth Network funded a pilot project through the first half of 2018 to run monthly youth clubs in Baydon, Ramsbury, Ogbourne St George and Lockeridge. Following evaluation, the club at Lockeridge was by far the most successful in terms of numbers of young people attending each month, regularly having more than 10 and up to 20 young people.

Building on this success, the local parish council would like to continue this activity for their local young people. They have chosen to engage the same professionals that ran the pilot club – Innov8 Sportz and Jenny Bowley – to run a monthly youth club to be based at Kennet Valley Hall. Their application covers the cost of employing these professional workers for 12 months and other costs of putting on activities for the young people.

LYN Recommendation:

Marlborough Local Youth Network were pleased that the pilot of the rural youth clubs was

successful in Lockeridge and that local young people were keen for it to continue. The LYN is happy to support the new youth club being set up, however it did have concerns. The LYN encourages new activities for young people to be set up and can provide funding for these activities to establish themselves. In certain cases, the LYN is happy to provide further funding for subsequent years but want to see that provision is in place for the group to become more and more self-sustainable, so that LYN funding is not expected or needed year after year.

Speaking with the applicant, it was clear that the local parish council and volunteers could not commit to giving support to the club until it was set up and running. Marlborough LYN would like to offer the Lockeridge youth club funding for the first six months so that the club can establish itself and be seen as a successful place where local young people want to go. Marlborough LYN can then offer the second six months of funding on condition that it gets proper assurance that the parish council will adequately fund the club alongside local fundraising efforts so that the club can continue after this 12 months of LYN funding runs out. Also that the club is resourced with regular volunteers who are undergoing onthe-job training so they have the experience to take over running the club if or when professionals like Innov8 and Jenny Bowley are no longer involved.

6. Project summary:

Our aim is to provide a much needed Youth Club to cover the rural villages of West Overton Lockeridge Fyfield and East Kennett. The rural villages have little by way of facilities to cater for the growing number of children in years 7 - 11 now living in the villages. The young people are reliant on parents to taxi them to and from Marlborough and surrounding towns for entertainment and socialising as there is only a limited bus service available during

the daytime only. Our aim is to provide a monthly Youth Club combining sport which would be provided by a local provider and a planned series of alternative activities which would allow the young people to socialise develop social skills take part in new skills and work with their local community.

13. Please tell us about your project:

Our aim is to provide a much needed Youth Club to cover the rural villages of West Overton Lockeridge Fyfield and East Kennett. The villages have little by way of facilities to cater for the growing number of children in years 7 - 11 now living in the villages and there is no public transport available on an evening to enable them to access entertainment and activities within the nearby towns and the opportunity to meet socially with other similar aged youths. Earlier this year a Youth Club pilot scheme was run at the Kennet Valley Hall in Lockeridge which proved to be extremely popular and successful with some sessions attracting as many as 20 young people although the overall footfall was much higher than this. We received excellent feedback from the young people from the scheme with many who responded asking for a permanent youth club to be established. The most popular activities were cooking and graffiti art which we would look to either repeat or hold similar activities. We would like this year to follow a similar model as the pilot scheme which will keep the young people engaged

in different activities give them the opportunity to socialise to take part in new skills develop social skills and work with their local community. If we can obtain funding for the next 12 months it will allow the Parish Council working group time to plan ahead find and train volunteers and with the help of the young people organise and hold fundraising activities to keep the group active and sustainable. We will also look to use local activity providers wherever possible. By obtaining funding for this year and fundraising for subsequent years we will aim to keep the cost to the young people to an absolute minimum this will be done by way of asking for a small voluntary donation in order to make it affordable to all. If sufficient funds can be raised to cover the full cost of the project there will be no contribution requested. The use of a fully trained Youth Worker and Innov8sportz will ensure that all individual needs are catered for all sessions are inclusive and the hall has a disabled access ramp as well as a disabled toilet. The sessions will be promoted through the schools on local social media the local parish magazine flyers and of course by word of mouth from the young people themselves. The Parish Council have agreed to pay for the hire of the hall this year and have formed a working group in order to facilitate the Youth Club. An application has also recently been submitted to Tesco Bags for Help for additional funding.

14. Monitoring your project

How will you know if your project has been successful?

The project will run initially for 12 months for which we have applied for the funding. As long as we have a group of youths regularly attending and enjoying the sessions we will know the project has been a success. We will ask for regular feedback from the young people to include which activities they have enjoyed the most and any activities they would like to see provided and involving them in the planning process will ensure the young people remain interested and engaged. The Working Group will meet regularly to assess the group and plan ahead for the following year.

15. Safeguarding

By initially using a fully trained youth worker and a sports company specialising in working with young people who are all fully DBS checked we will be confident that we will be providing a safe environment for all. All external services and volunteers will be required to be fully DBS checked and provide evidence of this prior to working with the young people. Any new volunteers will be DBS checked provided with safeguarding training and receive a copy of our safeguarding and child protection policy. all policies will be reviewed on a regular basis and DBS records kept up to date. In accordance with NSPCC guidelines there will never be a ratio greater than one worker to 10 young people. The Parish Council working group will be ultimately responsible for Safeguarding. None of the services provided will require online access.
