









Existing North Elevation

North elevation

- · Poor brickwork condition
- · Modern cementitious render
- Partial failure of roof



North-West corner

- Very damp brickwork below floor level
- Missing mortar joints (typical)
- Poor brickwork condition generally at low level (typical)
- · Shallow 'foundations'



West elevation

- Very damp & damaged brickwork below floor level Missing mortar joints (typical) Poor brickwork condition generally at low level (typical)


 Deflected ridge line


 Vine growth in masonry



South-West corner

- Eroded/missing mortar joints behind tank
- Cementitious pointing 'repairs'
- Vertical crack between South and West elevations

















Location Plan – Ogbourne St Andrew






Order Plan







Order route leaves byway OSTA6 at point A on the order map.














Point B of the order plan- the application route meets its junction with bridleway OSTA29 continuing north west and north



Representations and Objections

- 31 User evidence forms submitted claiming use of the application route
- 13 Of those users claim use on horseback or bicycle (use in the manner of a public bridleway)
- 28 Users in total claim use on foot.
- 1 Objection received to the order



Key Points

- Route used **as of right** from 2000-2020
- As of right = without permission, secrecy or force.
- No definitive evidence of landowner's lack of intention to dedicate the route
- Order capable of confirmation on balance of probabilities.
