# Appointment of Committees and Review of Allocation of Seats on Committees to Political Groups

1. This report guides the Council in constituting and re-appointing committees and following the legal requirements in allocating seats to political groups.

## **Legal Position**

- 2. Under the Local Government & Housing Act 1989 ("the Act") and subsequent Regulations, ("the Regulations"), the Council must review the representation of the different political groups on committees at the Annual Council meeting.
- 3. It is open to the Council when carrying out a review, to adopt some arrangement other than that prescribed by the Act and the Regulations. Notice of such a proposal would have to be given in the Summons, and a decision would need to be made with no one voting against it. The remainder of this report assumes that the Council will not want an alternative arrangement to that prescribed by law.

### **Political Groups**

4. There are currently 4 political groups on the Council. The respective strengths of those Groups are as follows:

Name of Group	No. of Members in Group
Conservative	61
Liberal Democrat	27
Independent	7
Labour	3

- 5. Under the regulations, two or more Members may form and register a group by notice to the Proper Officer.
- 6. This report has been prepared on the basis of the strengths of the various political groups as they currently stand as set out in paragraph 4 above.

## **Principles**

- 7. The Act sets out four principles which must be followed so far as reasonably practicable. They are:
  - a) Preventing domination by a single group: All the seats on a committee should not be allocated to the same political group.

- b) Ensuring a majority group enjoys a majority on all committees: If one political group has a majority in the full Council, that political group should have a majority on each committee.
- c) Aggregating all committee places and allocating fair shares: Subject to the above two principles, the total number of seats on all the committees of the Authority allocated to each political group should be in the same proportion as that political group's seats on the full Council.
- d) Ensuring as far as practicable fairness on each committee: Subject to the above three principles, the number of seats on each committee of the Authority allocated to each political group should be in the same proportion as that political group's seats on the full Council.

## **Application of Principles**

- 8. The Council must review the establishment of its committees in accordance with the principles laid down in the Act.
- 9. Immediately after this is done, each political group should state the names of the Members it wishes to take its allocated places on committees, including substitutes, and when those wishes are known, the Council is under a duty to make the appointment of those Members as soon as practicable.
- 10. It is a legal requirement however that the Council formally approves the appointment of Members to committees and therefore it is essential that each political group notifies Democratic Services of their nominated Members to serve on committees.

#### **Members not in a Political Group**

11. In the case of Members who are not members of a political group, a proportion of seats on committees equal to the proportion of Council members who do not belong to a political group, has to be reserved, with appointments to these seats being made by the Council at its discretion. There are no ungrouped members on this Council at this time.

- 13. Outside the scope of this report are the Cabinet, the Health and Wellbeing Board and Local Pension Board as the political proportionality rules do not apply to these bodies. The membership of the boards will be included for noting in this report, along with the non-committee bodies of the Corporate Parenting Panel and Safeguarding Children and Young People Panel.

#### **Area Boards**

- 14. Area boards are appointed by the Council under Section 102 of the Local Government Act 1972. These are constituted as area committees within the meaning of Section 18 of the Local Government Act 2000 and regulations made under that section for the purposes of discharging functions delegated by the executive (or not otherwise reserved). They are not subject to the rules on political proportionality. A list of these area boards is set out at Appendix 1 to this report.
- 15. All unitary Members representing the electoral divisions covered by the area board will be appointed to their respective area board.
- 16. Marlborough, Pewsey and Tidworth are established as a single area committee known as the Eastern Wiltshire Area Committee. The area committee appoints three subcommittees, each of which operate as an area board, known as Marlborough Area Board, Pewsey Area Board and Tidworth Area Board respectively.

#### **Local Pension Board**

17. Under the Public Service Pensions Act 2013 and consequent amendments to the Local Government Pension Scheme Regulations 2013, each administering authority is required to appoint a local pension board to assist the administering authority to comply with relevant legislation and guidance, and to ensure the effective and efficient governance and administration of the Local Government Pension Scheme. Such Boards are constituted entirely under the Public Service Pensions Act 2013 and are not local authority committees

#### **Health and Wellbeing Board**

18. Under the Health and Social Care Act 2012, the Council is required to appoint a Health and Wellbeing Board that works with partners, including the GP led Clinical Commissioning Group (CCG), to prepare a Joint Health and Wellbeing Strategy for the Council and the CCG and to encourage the delivery of integrated services. The Board is to be regarded as an ordinary committee of the Council and is therefore appointed by the Council, reports to the Council and with membership, as defined by the legislation, agreed by the Council.

#### Children's Select Committee

19. This Committee must include nominees of the Church of England, the Roman Catholic Church and a number of elected parent governor representatives (historically there have been 3 appointed representatives – one from each school sector). They will be voting members. In accordance with the principle set out at 7(b) above the majority group are entitled to appoint additional Members to ensure it enjoys a majority. The Council also has discretion to appoint an unlimited number of co-opted members onto this committee as representatives of children's organisations/agencies (historically this has been on a non-voting basis).

#### **Joint Committees**

#### Police and Crime Panel

- 20. The Wiltshire Police and Crime Panel as constituted under the Police and Social Responsibility Act 2011 is a committee of Swindon and Wiltshire and the two councils are required to meet a "balanced appointment objective" whereby its members reflect both the geographical and political nature of the two councils plus the skills and experiences required to fulfil the Panel's functions. Wiltshire's Police and Crime Panel comprises 11 Elected Members, plus two independent members, with the ratio of Elected Members 7:4 in favour of Wiltshire Council.
- 21. The membership of the Wiltshire Police and Crime Panel must reflect the political proportionality of the two councils when taken together.
- 22. Swindon's current political composition is as follows:

Conservative: 34 Labour: 23

23. When taken with the political composition with Wiltshire Council the allocation is:

Conservative	95	7 seats (6.742)
Lib Dem	27	2 seats (1.916)
Labour	26	2 seats (1.845)
Independent	7	0 seat (0.497)

24. Swindon is entitled to appoint 2 Conservatives and 2 Labour Members, leaving Wiltshire to appoint 5 Conservatives and 2 Lib Dem..

## Wiltshire Pension Fund Committee

25. The Wiltshire Pension Fund Committee must also reflect the proportionality of both Wiltshire and Swindon Borough Council when taken together. The Committee is constituted by five Wiltshire Council Members and two Swindon Borough Council Members. In addition to the seven elected members, there are also two voting and two non-voting representatives co-opted representatives.

Conservative	95	4 seats (4.290)
Lib Dem	27	1 seat (1.219)

Labour	26	1 seat (1.174)
Independent	7	1 seat (0.0.316)

26. Swindon Borough Council is therefore entitled to appoint one Conservative and one Labour Member, leaving Wiltshire Council to appoint three Conservative, one Lib Dem and one Independent.

## **Dorset and Wiltshire Fire Authority**

27. The political proportionality requirements of the Local Government and Housing Act 1989 applies to appointments to the Fire Authority. Wiltshire is entitled to appoint 6 members to the Fire Authority, based on the respective strengths of the political groups the allocation of places is:

Conservative	61	4 seats (3.735)
Lib Dem	27	2 seats (1.653)
Labour	3	0 seat (0.184)
Independent	7	0 seat (0.429)

## Method of Calculating the Allocation of Places to Political groups

- 28. The principles in paragraph 7 can be applied in the following sequence:
  - i. Calculate the total number of seats with votes on all the ordinary committees and any Joint Committees.
  - Calculate the proportion that each political group forms of the total membership of the Authority. Reserve an appropriate number of seats for ungrouped members.
  - iii. Apply those proportions to the total number of ordinary committee seats to give the aggregate entitlement of each group; the requirement to apply the proportions "so far as reasonably practicable" can be met by rounding down fractional entitlements of less than half, and rounding up entitlements of a half or more; if this results in a greater aggregate than the number of seats available, the fractional entitlement(s) closest to a half should be rounded in the other direction until entitlements balance the available seats.
  - iv. Apply the proportions to the number of Members on each ordinary committee to give provisional entitlement to seats on that committee.
  - v. If the provisional entitlement gives only one group seats on the committee, adjust the entitlement so that the next largest group has a seat (thus applying principle (a) in paragraph 7).
  - vi. Finally, adjust the seats on each committee so that the total allocated to each group is as near as possible to their aggregate entitlement, whilst preserving the results reached at steps (iv) and (v) (thus applying principle (c) in paragraph 7).

- 29. The Council is free to adopt any aggregate number of places on ordinary committees so long as it follows the principles in paragraph 7 and the sequence in paragraph 27. A draft scheme of committee places will be published as an appendix.
- 30. A numerical guide to proportional representation on Committees is included at Appendix 2 to reflect the Council's updated political composition.

  - 4) To re-appoint the Local Pension Board established under the Public Service Pensions Act 2013 and consequent amendments to the Local Government Pension Scheme Regulations 2013.
  - 5) To appoint members to the Dorset and Wiltshire Fire Authority, in accordance with the guidance set out in this report.
  - 6) To approve a scheme of committee places which sets out the number of seats available to members of the Council and to political groups (Appendix 3).

## **Appointment of Councillors to Committees**

#### Introduction

 Following on from the decision to formally re-appoint committees and allocate seats to political groups, the Council must formally agree the appointment of councillors and substitutes to those Committees in accordance with the scheme of committee places that is agreed.

## **Appointment of Councillors and Substitutes**

- 2. Each political group should state the names of the councillors it wishes to take its allocated places on committees and when those wishes are known, the Council is under a duty to make the appointment of those councillors as soon as practicable.
- 3. It is a legal requirement, however, that the Council formally approves the appointment of councillors to committees and therefore it is essential that each political group notifies the Democracy Manager (Democratic Services) on behalf of the Proper Officer of their nominated councillors to serve on committees by noon Monday 16 May 2022. Group Leaders may also wish to bear in mind the advantages of achieving a geographical spread of appointees particularly for area planning committees.
- 4. The Constitution currently provides that the Council will appoint substitute councillors to serve on each committee. Each political group is currently entitled to appoint up to four substitutes where it has a councillor on that committee. As with nominations of committee members (see paragraph 2 above) it is essential that each political group notifies the Democracy Manager (Democratic Services) on behalf of the Proper Officer of their nominated substitute members to serve on committees.
- 5. Councillors are encouraged to make use of the substitute system to ensure committees are fully represented in the case of absences by the appointed members. If a councillor finds that they are unable to attend a meeting, then they should contact Democratic Services to make their apologies and state who will substitute for them at that meeting.

#### Committees of the Council

6. There are specific issues that need to be considered under the appointment of councillors.

- 7. The statutory rules regarding senior officers appointments embodied in the Council's Constitution require the Officer Appointments Committee to include at least one member of the Executive.
- 8. The Staffing Policy Committee requires two members of the Cabinet be included, as Cabinet representation is required on its sub-committees by the Council's constitution and the Local Authorities (Standing Orders) (England) Regulations 2001.
- 9. The Standards Committee allows for up to 8 non-voting co-opted members to be appointed, half of which must be town or parish council representatives. In May 2021 Full Council agreed that 4 co-opted members should be appointed, and delegated the appointment to the Standards Committee to appoint for the remainder of the council term.
- 10. As part of the Council's arrangements for dealing with Code of Conduct complaints, the Council is required to appoint at least one Independent Person whose views must be sought and taken into account before the Council makes a decision on an allegation it has decided to investigate. The Council in May 2021 appointed three Independent Persons for a four year term.
- 11. The Children's Select Committee must include nominees of the Church of England, the Roman Catholic Church and a number of elected parent governor representatives (historically there have been 3 appointed representatives one from each school sector). These would be voting members. The Council also has discretion to appoint an unlimited number of co-opted members onto this committee as representatives of children's organisations/agencies (historically this has been on a non-voting basis).
- 12. Wherever possible the members of Area Planning Committees should be made up of local councillors. The geographical consideration does not apply to the Strategic Planning Committee where applications of a more strategic nature are determined and where members are expected to apply a more strategic approach.
- 13. All unitary councillors representing the electoral divisions covered by an Area Board will be appointed to their relevant area board as set out in Appendix 1 to this report.
- 14. Para 6.2.2 of Part 2 of the Constitution states that the chairmen of each Scrutiny Select Committees should have a seat on the Overview and Scrutiny Management Committee. It has also previously been considered appropriate that the Chairman of the Financial Planning Task Group should also have a seat on the Overview and Scrutiny Management Committee. Similar conventions have previously been in place in respect of the chairmen of the 4 Area Planning Committees having a seat on the Strategic Planning Committee. Group Leaders are therefore asked to consider these conventions when submitting their nominations for committee places.
- 15. The Wiltshire Pension Fund Committee comprises five Wiltshire Councillors, two voting members from Swindon Borough Council (appointed by Swindon Borough

Council), two voting Employer Representatives and two non-voting employee representatives (one representing Wiltshire Council employees, one representing Swindon Borough Council employees).

16. The Local Pension Board is constituted entirely under the Public Service Pensions Act 2013 and is not a Committee of the Council. The rules on political proportionality do not apply.

#### **Matters for Decision**

- a) To appoint councillors to serve on those committees in accordance with the agreed scheme of allocations, until the next occasion membership is reviewed under the provisions of the Local Government & Housing Act 1989.
- b) To appoint substitute members (to a maximum of four per group) to the committees referred to in (A) above.
- c) To appoint those councillors representing electoral divisions to their respective area boards as set out in Appendix 1 to this report.
- d) To note that following delegation by Full Council the Standards Committee appointed the following persons as non-voting co-opted members of the Standards Committee for the remainder of the council term:

#### Item 15 - Members' Questions

## From Cllr Bridget Wayman, Nadder Valley

To Councillor Richard Clewer, Leader of the Council and Cabinet Member for Climate Change, MCI, Economic Development, Heritage, Arts, Tourism and Health & Wellbeing

#### Statement

Wiltshire Council and the other Councils with the Cranborne Chase Area of Outstanding Natural Beauty match fund the Defra contribution of core funding to the AONB (as it does to North Wessex Downs and Cotswolds AONBs).

The Glover Review proposed that there should be a doubling of AONB grants from Defra because there is such a disparity in funding between National Parks and AONBs, despite them having the same 'great weight' afforded to their landscape importance.

Unfortunately, Defra have announced only a small additional grant for 22/23 which is likely to remain at that level for 23/24 and 24/25. In the case of the Cranborne Chase AONB the Defra increase is £32,750.52. Defra is expecting the additional grant allocation to be added to the core funding element of the AONB budget, but for that to be possible the additional grant needs to be matched by the constituent local authority contributions which, in Wiltshire Council's case would be £6,700.76.

I have asked the Leader to increase Wiltshire's contribution by the £6,700.76. Although I am not aware of the amounts that would also be required to match fund the additional Defra grant to the other two AONBs, I know that the Cranborne Chase AONB forms the largest contribution by Wiltshire Council and would anticipate that the total additional contributions to all three AONBs would be considerably less than £10,000.

The Leader has responded that budgets are incredibly tight this year as inflationary increases are higher than budgeted, so any increase to core budget funding for AONBs is unlikely.

I understand that a new procurement exercise for the supply of electricity to Council premises has recently been completed and a premium of £75,000 for green energy is to be paid. If Wiltshire Council did not pay that premium a saving of £75,000 could

be made and the additional funding to the AONBs would be easily affordable and the difference could be used to offset other Council financial pressures.

From the work that our AONBs undertake across a very large part of Wiltshire's land mass in increasing biodiversity and restoring nature, amongst other things, the benefits of the additional funding to their core budgets would be of far greater benefit than a green premium on our electricity bill.

## **Question (22-09)**

Would the Leader please commit to fund the additional small sums required to match Defra's funding for the AONBs in Wiltshire?

#### Response:

Defra notified Wiltshire Council that Ministers had approved the protected landscapes grant settlement for 2022-23 in mid-March, after Council budgets had been approved. The national AONB budget has been increased by an additional £1million per year for the next three years (years 2 and 3 being indicative). This represents a 14.7% increase on the 2021/22 budget (excluding in-year top ups). In addition, individual AONB's have annual Farming in Protected Landscapes awards which for Cranbourne Chase is £453,974 for 22/23. The additional Defra funding allocated can be either used for core costs or for projects, subject to match funding, and so will not be lost.

The council's utilities budget is separate from AONB funding. The uplift for the council's green tariff in 2022/23 is about 1.28% of our estimated £5.9m electricity bill. The green tariff helps the council to meet its climate strategy commitments, encouraging the supply of renewable energy and ensuring that our electricity is zero carbon.

## **Question (22-10)**

a) Wiltshire Online: According to Gigaclear some areas in North & West Wiltshire which were in the timetable for inclusion in the project won't now be done as they've been 'de-scoped'. Was this done unilaterally or in conjunction with WC?

## Response:

Gigaclear's proposed reduction in scope is being done unilaterally and not in conjunction with Wiltshire Council.

The funding for the superfast programme was provided by BDUK with a deadline of 31 March 2020. This deadline was subsequently extended to 31 March 2022.

As of 31 March 2022, there were properties undelivered by Gigaclear within the programme. There is no further public funding available under this scheme and so these properties must now be built commercially or picked up through another publicly funded programme.

As there are properties undelivered which cannot claim public funding, these will need to be descoped from the contract. Descoping of any properties is undertaken through a Change Request which is approved by BDUK and not Wiltshire Council. Wiltshire Council's role is to assure the accuracy of the information provided.

Wiltshire Council has continually sought to challenge Gigaclear to ensure delivery under the contract, and we have triggered all performance mechanisms available to us. In response, Gigaclear have committed to delivering part of the planned rollout commercially, and other properties have already been delivered by other providers. Some properties have not been connected as the landowner refused the necessary wayleave permission.

Wiltshire Council has advocated to BDUK that the properties left outstanding by Gigaclear should be supported under Project GIGABIT which is due to commence this year. It will be for BDUK to determine the scope of the Project GIGABIT roll-out.

b) Have there been any changes to the payments made to Gigaclear as a result?

## Response:

The contract pays by number of premises connected, so Gigaclear will not be paid for premises which are not delivered. As such, there will be a reduction in funding paid to Gigaclear.

The final amount is subject to change following the Change Request process as approved by BDUK but will still reflect the reduced number of properties delivered.
