De-Delegated DSG & Block Transfer Consultations 2024/25	
25 responses – significantly in favour of electing to continue with full de-delegation for centrally provided services.	
14 responses – majority support to continue with de-delegating funding to ensure School Improvement services continue following the loss of the LAMB Grant	
16 responses – overwhelming support for a transfer of funding from Schools Block to the High Needs Block, with the majority supporting a transfer of 0.5%. A block transfer decision would be looked on favourably by the DfE as part of the Safety Valve work and would be linked to support for mainstream schools.

9.	Maintained Schools – Support for Deficits (GD) The DfE announced £40m support for schools with deficit budgets. £20m for local authorities – Wiltshire's share is £405k. GD's paper outlined a number of options to distribute the funding to schools. There was much discussion around the grant itself and the best recommendation for Schools Forum, but the group felt option 1 was the fairest, using a straight line allocation method to all 12 schools with deficits. (Wiltshire has been awarded the funding based upon the size of the cumulative deficits and therefore the current schools in deficit are the reason that the £405k of funding has been awarded) The group were concerned at the deficit situation and MT reassured them all schools concerned will supported by GD and his team, all with Recovery Plans. In each case there is a 'story' behind why the school is in deficit and all deficit schools are supported with their financial planning. GNS asked – does it need to be spent this year? GD confirmed it was a 23/24 grant and any unspent monies would be transferred to the DSG reserve (deficit). GD to amend paper to recommend option 1	GD
