# INTENTION - PROPOSED WAITING RESTRICTIONS ALFRED STREET, WESTBURY, BRATTON ROAD, WESTBURY

### **Purpose of Report**

To:

- (i) Consider the comments received following the formal advertisement of proposed waiting restrictions at Alfred Street and Bratton Road, Westbury.
- (ii) Recommend the making of the Traffic Regulation Orders (TROs hereafter) on Bratton Road, Westbury as advertised.
- (iii) Recommend the making of an amended TRO on Alfred Street, Westbury to omit the proposed restriction opposite the junction of Glovers Row.

#### Consultation

Consultation has been undertaken with:

- The elected Wiltshire Council Member
- The elected Westbury Town Council through the statutory TRO consultation process
- Members of the Westbury Local Highways & Footways Improvement Group (LHFIG)
- Emergency services through the statutory TRO consultation process
- Members of the public through the statutory TRO consultation process

The proposed TROs were subject to formal consultation between 15 December 2023 and 15 January 2024. During the consultation period a total of eleven items of correspondence were received in response to the Council's proposals. Of those items relating to the Alfred Street proposals, one expressed support for the Council's proposals, and nine objected to the Council's proposals. One item of correspondence related to Bratton Road and objected to the proposals.

#### **Options Considered**

To:

- (i) Implement the proposed TROs as advertised.
- (ii) Amend the proposed TROs in consideration of the comments received.
- (iii) Abandon the proposals.

#### **Reason for Decision**

The proposed waiting restrictions will help the Council to meet its statutory duty of ensuing that the right of passage along the public highway is not impeded.

The proposals are in accordance with Outcomes 2 and 3 of the Council's Business Plan.

The proposals have been prioritised by the Westbury LHFIG as a project for 2023-24 and supported by the Area Board.
