#### **ROAD TRAFFIC REGULATION ACT 1984**

1. THE COUNTY OF WILTSHIRE (PEARCE WAY AND SYCAMORE DRIVE, LAVERSTOCK AND FORD) (RESTRICTED ROADS) ORDER 2013

2. THE COUNTY OF WILTSHIRE (PEARCE WAY, SALISBURY AND LAVERSTOCK AND FORD) (40 MPH SPEED LIMIT) ORDER 2013
3. PEARCE WAY, LAVERSTOCK AND FORD – PEDESTRIAN CROSSING

#### **Purpose of Report**

To consider 204 objections and one letter of support in relation to the proposed reduction of speed limit (to 30 mph) and introduction of a Zebra crossing on Pearce Way, Salisbury.

#### Consultation

Consultations (at pre-consultation and full consultation stage) have been undertaken with the Fire, Police and Ambulance Services and also with the relevant bus companies. The Town and Parish Councils have been consulted. Correspondence has been received and acknowledged from the local Wiltshire Council Member. Advertisements have been posted in the local press and notices posted in prominent positions on the site.

To:

- (i) Implement proposals as advertised.
- (ii) Not implement proposals.
- (iii) Implement proposals with amendments.

#### **Reason for Decision**

#### **Speed Limit**

To ensure that vehicles travel at the most appropriate speed for the road conditions, accommodating the increase in vehicles and pedestrian movements connected with the approved housing scheme known as the Hampton Park II development.

## Zebra Crossing

To ensure the safety of pedestrians crossing Pearce Way.
