1.	Chairman's Welcome and Introductions				
	The Chairman welcomed everyone to the meeting of the Westbury Area Board.				
2.	Apologies for Absence				
	An apology for absence was received from Michael Franklin, Partnerships Community Engagement Manager, Wiltshire Fire & Rescue Service.				
3.	<u>Minutes</u>				
	Resolved:				
	The minutes of the previous meeting held on 10 December 2015 were agreed as a correct record and signed by the Chairman.				
4.	Matters Arising				
	• Child Poverty At the last meeting of the Area Board, the Chairman reported the success of a Workshop on the attainment of disadvantaged children, which had been held at Matravers School on 13 October 2015. Following on from this an action plan was being drawn up which so far included the establishment of cooking clubs, information technology workshops together with other leisure and recreational activities. Champions had been appointed to explore the possibility of other activities which might be popular and then to liaise with the Chairman and Community Engagement Manager to take forward.				
	• Dilton Marsh – Weed Killing A the last meeting, Cllr JA Moody from Dilton Marsh Parish Council referred to the poor maintenance of roads particularly in the Dilton Marsh area and the amount of weeds ha needed clearing. The Area Board requested that details of a weed killing programme be made available at the next meeting.				
	Wiltshire Council was reviewing its services as it shaped the future of its highway programme from April 2016. Following feedback from town and parish councils, part of that programme would be reintroducing the Parish Steward Scheme. There would be 18 stewards appointed serving their own group of parish and town councils in the county. It would replace the community days scheme where a group of officers provided one day's work of activities within an extended time period.				
	Under the new scheme, parishes would have regular visits for minor works providing a much more frequent service. The parish stewards would report issues and undertake repairs and maintenance themselves, meaning they would be a 'one stop and done' service. The stewards would help prioritise the needs of their patch including roads, pathways, drainage and verge maintenance. Their remit could include painting				

	railings, highways strimming and undertaking minor pothole repairs.				
	Over the next few months, parish and town councils would be advised of the new arrangements and attendance programmes.				
	People who wished to report a highways issue could do so using the MyWiltshire App, by the <u>council website</u> or by calling 0300 456 0105.				
	• NHS Health Checks At its meeting on 10 December 2015, the Westbury Area Board received the Chairman's Announcement about NHS Health Checks.				
	However, during discussion some members noticed that it was stated that everyone between the ages of 40 and 74, who had not been diagnosed with certain conditions or was otherwise ineligible, was invited every five years to have a free NHS Health Check. They asked that an enquiry be made if those over the age of 75 years were likewise eligible and, if not, why?				
	The NHS health check was intended for people up to the age of 74, invitations being sent during the month/year of their 40, 45, 50 etc. birthday. Surgery's already offered over 75's regular health checks (in some cases annually), and that was why the 5 yr invitation process stopped at 74.

	• Wiltshire Passenger Transport Review Wiltshire Council was undertaking a review of Wiltshire Council supported bus services as part of a wider review of all areas of Wiltshire Council's passenger transport remit.				
	The Council had already completed a pre consultation assessment, (details can be found via this link (<u>www.wiltshire.gov.uk/localtransportplan3</u>).				
	A broader consultation was now taking place to hear the views of residents. The Council had made no decisions and would like to see how far members of the public agreed or disagreed with the presented options, or make alternative suggestions. Consultation documents could be viewed from the 11 January 2016 on the Council's consultation portal http://consult.wiltshire.gov.uk/portal .				
	Hard copies of the consultation material including questionnaires were available at local libraries and at main council offices from the 11 January				

	2016. Questionnaires were also available on buses operating a journey that was funded by Wiltshire Council, and could be sent out on request.				
	The consultation will be open until to 5pm on the 4 April 2016.

7.	Partner and Community Updates				
	The Area Board received the following updates from key partners:-				
	• Wiltshire Police Inspector James Brain, Community Policing Team Inspector, Trowbridge & Warminster, introduced and explained the Police report based on what was happening in the Westbury Community Area, ful details appeared in the agenda pack				
	He explained that the Community Policing Team pilot had now complete its 10 week mark and the general feedback was positive. The Chi Constable has stated that this 'one team' approach, which was bein further developed, was the most effective way to deliver local Policing ar he had instigated a scoping exercise with a view of rolling out this Policin model across the entire Force Area later in 2016.				
	Inspector Brain reported that Sergeant Pete Sparrow, his Communit Policing Team Deputy, had moved to another area of the Force as Acting Inspector and had been replaced by Sergeant Louis McCoy, who had previously worked in the Chippenham area and had 13 years of Policing experience in a variety of roles across Wiltshire Police.				
	The Chairman introduced and welcomed Carolyn Deverall, Out of Co Disposal Manager, who was attending to explain Restorative Justice. S explained that the Office of the Police & Crime Commissioner had fund the post of Restorative Justice Co-ordinator and the Wiltshire model w still being developed. However, to date there had been some positi outcomes with some conversations having taken place with both victir and offenders. It was stressed that any conversations with either pa were carried out on a purely voluntary basis.				
	• Wiltshire Fire & Rescue Service The update report was received and noted.				
	The Chairman introduced and welcomed Chief Fire Officer Darren Gunter,

	currently CFO for Dorset Fire & Rescue Service but Chief Fire Officer for the new combined Dorset & Wiltshire Fire & Rescue Service from 1 April 2016. Mr Gunter was attending the area board meeting in order to explain the new service.
	Mr Gunter illustrated his talk by showing a short film entitled <i>Changing & Saving LivesTogether.</i> He explained that the public would not notice any change in the service provided except for the name. Both services already did more than just put out fires and undertook a range of prevention activities. The Service intended to:-
	 work in some key areas, such as identifying those people who might be cold in their homes during winter and support and signpost them to other agencies to take action.
	 work with public health partners to reduce avoidable illnesses.
	 work with families and individual young people to support them in making safer and healthier choices.
	This was reflected in the following four priorities;
	1) Help individuals to make safer and healthier choices.
	2) Protect individuals and the environment from harm.
	3) Be there when needed.
	4) Make every penny count.
	It was noted that a new safety centre was to be provided in Swindon and it was suggested that this might be better strategically provided to cover the whole area to be covered by the combined authority in or near Salisbury. Mr Gunter informed the meeting that there already existed a safety centre in Bournemouth and he hoped that it might be possible to provide an additional centre in Salisbury to cover the Trowbridge & Salisbury area.
	Mr Gunter also explained that the government had moved responsibility for the Fire & Rescue Service to the Home Office from the Department for Communities & Local Government. The move would deliver the government's manifesto commitment to deliver greater joint working between the police and fire service. It would pave the way for improvement in local fire and policing by providing clear leadership, supporting greater collaboration and delivering value for money for taxpayers. It would also allow the government to share good practice more effectively on areas such as procurement and prevention. The government recently consulted on proposals to enable Police and Crime Commissioners to take on greater responsibility for fire services at local level.
	The Chairman thanked Mr Gunter for his interesting and informative

presentation.

- **BA13+ Community Area Partnership** An update report which was received and noted.
- Healthwatch Wiltshire An update report was received and noted.
- Wiltshire Clinical Commissioning Group An update report was received and noted.
- Town and Parish Councils
 - (a) **Westbury Town Council** Cllr David Bradshaw, Mayor, reported on recent work and activities carried out by Westbury Town Council, which included:
 - Setting the town precept for 2016-17 at £394,427 (Band D charge £87.75), this being the total money the town council receives to spend on its services. This represented an increase of 26p per week on the tax for a band D property.
 - The Council's Delegation of Services Working Group were currently in discussions with Wiltshire Council with regard to taking over responsibility for certain services, such as allotments in Queen's Road and flower beds in the town centre. The Town Council had agreed to accept the transfer of the public toilets in High Street and Warminster Road by a seven year lease with effect from 1 April 2016.
 - The Town Council was currently advertising for two town caretakers to supplement the services provided by Wiltshire Council. Their remit would be to litter pick in the town centre, keep footpaths clear of litter, dog mess and cutting back brambles, cleaning road signs and bus shelters and some weeding and small maintenance tasks.
 - Arrangements were being made for the beacon on the White Horse to be lit on the Queen's Birthday, 21 April 2016, by the Lord Lieutenant of Wiltshire.
 - It was reported that the road from Hawkeridge Road to the end of The Ham to the entrance of the West Wilts Trading Estate would be closed from 29 February to 29 April 2016 for roadworks, the alternative route being through the Trading Estate.
 - (b) **Dilton Marsh Parish Council** Cllr Alison Irving reported that to celebrate the Queen's Birthday there would be a community picnic on the playing field. The Parish Council would be contributing with other parishes in the area to taking over responsibility for the Speed Indicator Device (SID).

	(c) Bratton Parish Council Cllr John Bartram reported that plans were being developed to celebrate the Queen's Birthday on 21 April. Bratton Parish Council would also be contributing to the transfer of responsibility for the SID and was participating in the development of the Community Emergency Plan.
	(d) Edington Parish Council Cllr Mike Swabey stated that Edington Parish Council was also involved in the development of the Community Emergency Plan and was participating in the process of compiling a Neighbourhood Plan.
	Wiltshire Wildlife Trust Ltd Jessica Thimbleby, from the Wiltshire Wildlife Trust Ltd reported that Wiltshire Wildlife Trust Education Officers had continued running their waste workshops at primary schools in Westbury. In November the team spent the day at Matravers School running an Eco Dragons Den which asked students to think about local environmental challenges and develop an idea, campaign or prototype to help resolve the issue - winning ideas included a machine to help with dog fouling and a campaign to clean-up local rivers.
	The Trust had run sessions for local Rainbows, Brownies, Cubs and Guides helping them achieve badges by completing activities such as making bird feeders and other items out of waste. Staff from the Waste & Recycling Team at Wiltshire Council joined Wildlife Trust's Waste Team and knocked on 559 doors in Westbury to answer resident's questions about recycling and to make sure they knew what could be recycled in their black box and blue-lidded bin. A clothes swap was run at Suave and also a Christmas Jumper making workshop.
	As the project was due to an end in Westbury, the Trust would be launching a cotton bag competition, sponsored by Hills, which would give each primary school pupil in the town a bag on which to design an environmental message. The Trust would also be running a Spring Seed event at half-term on 18 February 2-4pm in the library, making seed bombs among other planting fun. The Trust was working with local groups to complete the wall-hanging and writing a toolkit for community groups to use to encourage recycling and reducing waste in their area.
8.	Delivery and Demand of New Housing
	Nicole Smith, Head of Housing Operations, Wiltshire Council, made a presentation in which she explained the demand for affordable housing in the Westbury Community Area.
	She explained that national housing policy was to:
	 Increase owner-occupation including low cost options Make best use of existing social housing stock Reduce burden on public sector (housing benefit bill)

	Increase supply of new homesPromote independent living in the community
	Wiltshire's priorities were:
	 Ensuring there are a range of housing options available to meet needs Promoting home ownership housing Enabling provision of homes for the most vulnerable To help people to achieve independence and choice enabling them to live at home for longer To improve the quality and make best use of existing stock
	The following would be used to assist in assessing the need for additional housing:
	 The core strategy Strategic Housing Market Assessment Town and parish surveys Under-occupation and overcrowding data Demographic trends & census updates Existing stock information Re-let supply Housing register
	It was pointed out that Westbury Community Area had, at 13.3% of all households, average levels of social rented accommodation compared with the Wiltshire average of 14.7%. The current highest demand was for one-bedroom affordable homes (28 households) and the next highest was for two-bedroom homes (20 household) which had been constant in the last few years.
	Nicole Smith explained that the next steps were:
	 Commissioning research at community area level Developing housing strategy & agreeing priorities Work with local communities & partners to understand local need and deliver new homes Consider options to increase choices for those not able to meet needs in open market Respond to national policy changes
9.	Update on Tarmac Site
	The Chairman introduced Jonathan Toyne, Senior Estates Manager and David Daniels, PR Consultant working for Tarmac where were attending to explain Tarmac's proposals for the demolition of its former cement works to the north of Westbury.
	Mr Toyne explained that in September 2015 Tarmac announced that it wished to

	demolish the Company's former cement works at Westbury. The demolition activities, as explained in the submission to Wiltshire would be as follows:-
	 Early demolition of all redundant production facilities associated with the former cement works phased around the ongoing local distribution of cement from the site.
	 Targeted water sprays and water curtains to be used to contain dust emissions.
	 Hazardous materials to be removed under controlled conditions in advance of demolition commencing.
	 Use of pulverising and shearing techniques rather than impact equipment to minimise noise.
	 Demolition of the chimney by controlled use of explosives.
	Mr Toyne pointed out that the demolition of the chimney would take place towards the end of the six month programme and would possibly take place in July or August 2016. It would be necessary to liaise with Network Rail as to precisely when the demolition could take place bearing in mind the very close proximity of the main railway line from London to Devon and Cornwall.
	It was noted that a meeting would be held at The Laverton, Westbury on 17 March in which the proposals would be fully explained to the public.
	Mr Toyne went on to explain that it was planned to publicise the actual demolition of the chimney and hoped that it could be regarded as a special event with possibly a celebrity or a school child activating the demolition.
	The Chairman, on behalf of the Area Board, thanked Jonathan Toyne and David Daniels for attending the meeting to explain the proposals.
10.	Legacy Campaigns Presentation 2016
	Liam Cripps, Area Engagement Manager, informed the Area Board of the legacy campaigns planned for 2016.
	They included:
	 Clean for The Queen – national campaign to be launched in March and end in May. The Queen's 90th birthday celebrations Cycling and walking events including Cycle Wiltshire Big Pledge – make a difference to your health and wellbeing – be part of the Road to Rio Challenge The Olympic and Paralympic Games in Rio de Janeiro
	There would be celebrations across the UK throughout the year including a

concert, birthday parade and giant street party. Communities all over the country would be holding street parties to coincide with one taking place on The Mall on Sunday 12 June. In preparation for the street parties there would be Clean for The Queen tidy up of local areas, which would involve litter picking around community areas.

Westbury residents were all encouraged to hold a street party and organise a Clean for The Queen day - there were guides available with all the information and advice needed to get started. This year the Olympics and Paralympics was due to take place in Rio de Janeiro, Brazil throughout August and September. There were a number of ways to get involved and support this global sporting event in Wiltshire.

School games would be held across the county. Individual and multiple schools would be putting on outdoor athletic events for their children, interschool games allowing children from different schools to compete against each other, meet new people and have fun doing sport. Wiltshire Council would once again be handing out grants to up and coming athletes in the county through Funding Future Olympians and Paralympians grant scheme. The annual fundraising dinner would be taking place in March, and the public was being encouraged to donate a raffle or auction prize for this fantastic cause.

Cycle Wiltshire would once again take place in Salisbury on 7th and 8th May and the event village would have a Rio theme for this year. Members of the public were being encouraged to participate in the sportive or enjoy a great family fun day out at the event Big Pledge 'Road to Rio'. The Big Pledge 2016 was focussed on getting people active and making a difference to their health and wellbeing. As it is an Olympic year the theme for this year's Big Pledge was 'Road to Rio' which would take place from 3 June – 29 July 2016. Participants would complete varied distances on 'The Road to Rio' by walking, swimming, running or rowing . Entrants could take part as an individual, group or community, and this year all 18 community areas in Wiltshire would be in competition to see who could travel the furthest and make it all the way to Rio de Janeiro.

Liam Cripps explained that key events would be launched within a month and he appealed for help in organising these events and activities.

11. <u>Campus Working Group</u>

The Chairman provided a verbal update at the meeting.

It was noted that Cllr John Thomson and associate director Laurie Bell recently visited Westbury to discuss future options for the town, but in particular the provision of a community hub. Currently, Westbury was not one of the seven approved campuses, however, having visited the town and looked at the possible options, Cllr Thomson and Laurie Bell agreed that plans to make improvements to the existing library building to provide a community hub should be progressed. It was considered that this would deliver a positive interim solution whilst the neighbourhood plan was developed, which would reflect the

	regeneration of the town in the context of future development and growth.					
	Subject to feasibility, the plans for the library would look to include the provision of flexible community space, an automated system that extended operating hours and allowed self-access by the local community, the provision of a stair lift to improve accessibility and redecoration as required. The provision of a new community hub was supported by Cllr John Thomson and he recognised the need to increase the offer to local residents in Westbury.					
	The Chairman advised that the plans would be presented at a future area board meeting and confirmed that parish councils in the Community Area would be involved in the provision of the community hub.					
12.	Development of Youth Activities in the Westbury Community					
	Phoebe Brazier, Community Youth Officer, presented an update from the Local Youth Network, which had been circulated with the agenda pack.					
	Consideration was given to five grant applications for youth activities.

13.	Community Area Grants					
	Consideration was given to a report by the Community Engagement Manager in which councillors were asked to consider funding from the 2015/16 Area Board Grants Budget, all of which met the grants criteria. After receiving brief					

statements from the applicants giving reasons for the requests:

Resolved:

(1) Application 1668 - 656 Squadron Association

To refuse the application for a grant of £835.00 to upgrade the 656 Squadron Association website on the grounds that, although the application meets the grants criteria and although the website is administered in Westbury, there is limited direct relevance to the local area and therefore the impact for the community could not be justified.

(2) Application 1678 – West Wilts Society of Model Engineers

To approve a grant of £850.00 towards a new Pillar drill for West Wilts Society of Model Engineers training workshop.

(3) Application 1575 – Dilton Marsh Local History Society

To approve a grant of £1,000.00 towards a project to map the timeline of the village history.

(4) Application 1717 – Westbury Shed

To approve a grant of £957.00 towards the cost of building a shed on allotments off Queen's Road, BA13 3NN for Westbury Men's Shed, a local group to promote general wellbeing and healthy lifestyles for retired and other men who were looking to use their time constructively and enjoyably.

Health and Wellbeing Group?

The Council is proposing that each Area Board establishes a Health and Well Being Group. Health and Wellbeing Groups are intended to provide a community led local forum to facilitate the coordination of joined up services for older people living within a community area. They are intended to gather the views of local older people and ensure these views are represented at the local Area Board. The groups will focus on working with community commissioners to identify the needs of a local population and support the development of services that will meet these needs.

What will they be expected to do?

It is anticipated the groups will identify how best to co-ordinate support for vulnerable people in their area in a way that that is more inclusive than the current good neighbour service and makes best use of the existing community capacity.

Each Health and Wellbeing Group will reflect the needs of its local community and different area boards plans will reflect this however the intention is that the Health and Wellbeing Group will ensure wellbeing and community resilience is a key priority for Area Boards and the Group will support community initiatives.

It is anticipated that Health and Wellbeing Groups will draw on local resources and assets in order to generate support for local initiatives. Funding previously used to commission the Good Neighbours Service will be devolved (ring fenced) to the Area Boards to support local initiatives identified by the Health and Wellbeing Groups.

Health and Wellbeing groups can respond to local challenges and make the best use of local assets including local knowledge, resources and voluntary organisations.

The Council Adult Care Community Commissioners can work closely with members, customers and key stakeholders to respond effectively to local needs while coordinating county wide solutions where required.

The groups will promote links between universal services (including leisure and libraries) and services that support specific customer groups including older adults or those with a disability.

Chairman's Announcements

Who would be part of a Health and Wellbeing Group?

This would be decided by each Area Board. It is suggested that the Community Engagement Manager, the Older Peoples' Champion, Unitary and Parish Councillors, CCG Care Coordinators, Healthwatch, Representatives from the Voluntary Sector should be included.

When can an Area Board commence work on Health and Wellbeing Groups?

Anytime. A number of Area Boards have already planned meetings to start their Health Well Being Groups. In approximately 6 /9 months' time there will be a review of progress being made to establish these groups and a report highlighting good examples of the work being undertaken

We will continue to balance our resources against the threats, harms and risks in your community, working in line with our control strategy to address the issues that matter to you. We have moved away from a statistics lead report but be assured, if it is happening in your community and affects you, we will tell you.

The end of March will see us entering the pre re-election period for the Police and Crime Commissioner, also known as purdah. It is important to stress that it is business as usual for the Wiltshire Police. Your local CPT are apolitical and we are here to work with our communities to address the issues that are most important to you, as I am sure you will appreciate it is not for us to comment on the upcoming elections.

I would like to take this opportunity to introduce you to Horizon. Being a victim or witness of crime can be distressing and traumatic.

From October 2014, we were given the responsibility for delivering non-specialist services to victims of crime. Horizon Victim and Witness Care has been established to ensure that every victim of crime benefits from the best possible integrated support service according to their needs.

Horizon have been designed to provide the help and support needed relevant information and advice with links to other partner organisations that can assist you.

Horizon Victim and Witness Care is a new team of police staff which will help to provide a co-ordinated, consistent end-to-end service for victims and witnesses. This is from their first point of contact with Wiltshire Police, through the whole criminal justice process.

Working with partner agencies, Horizon will provide an enhanced service to support victims and witnesses when they need it most.

How can they help?

- A dedicated Victim and Witness Care Officer to victims of crime identified as most vulnerable
- Support and guidance throughout the criminal investigation process
- Simplified process for victims
- Greater level of co-ordinated end-to-end care for victims who need it most
- A schedule of contact between the victim and Wiltshire Police victims will be able to say when and how they wish to be contacted
- Signposting to relevant national and local services where appropriate
- Improved quality of outcomes for victims and witnesses, working closely with key partner agencies
- If you require further practical and emotional help, we can refer you on to Victim Support

The victims and witnesses eligible for an enhanced service are:

- Vulnerable victims
- Intimidated victims
- Persistently targeted victims
- Victims of serious crime

These victims will be allocated a dedicated Victim Care Officer who will conduct a detailed assessment of their needs.

The Victim Care Officer will provide a single point of contact for the victim or witness to receive information and updates on their case. Victim Care Officers will agree a schedule of contact with the victim and be able to signpost them to partner agencies and more specialist local and national services when appropriate, such as Wiltshire Bobby Van Trust.

Wiltshire Control Strategy

We are continuing to base our Policing activities on the control strategy and working with the 4 P's, Prevent, Pursue, Protect and Prepare. Under this strategy we are looking to maintain our consistent approach to addressing the threat, harm and risk that causes the greatest harm to your communities and this is a daily evolving situation that requires a degree of fluidity. We have chosen not to include the diagram setting out our control strategy in this report but I need to emphasis that this is key in how we go about our daily business. A cross cutting theme of the control strategy is our young people and those who are more vulnerable and need safeguarding. In addition, those who are victims of domestic abuse are all in deserving need of a professional response and support. Our control strategy

A team of people with learning difficulties have taken part in this new project to check the quality of residential care homes providing support for other people with learning difficulties. For the team of Quality Checkers who took part it meant an opportunity for training, learn new life skills, and to take part in a project which is designed to improve services. The team visited 11 care homes and spoke to residents, empowering them to speak out about their experiences. On the whole they were impressed with what they saw and heard and produced informative reports which included recommendations for improvements after each visit.

Developing mental health services for veterans

The NHS has launched a national engagement on mental health services for veterans.

The engagement will run until 31 March 2016 and aims to capture views and experiences of these services from a range of stakeholders, including veterans who have or have had a mental health illness, their families and carers, service charities, commissioners and providers offering treatment and support in this area.

Findings from the engagement will help to ensure that future mental health services for veterans are accessible, provide high-quality and sensitive care, treatment and support, and best meet the needs of veterans, regardless of when they leave the armed forces.

Currently, the NHS commissions 12 mental health services across England for veterans. These were set up in 2010 following publication of "Fighting Fit: a mental health plan for servicemen and veterans". The contract on these services are due in 2016/17 and this provides the NHS with a significant opportunity to ask people about their views and experiences of the current services. This will also allow the NHS to explore why some veterans have not sought or received support and treatment.

The NHS wants to hear from people who have served in the armed forces and have used or are currently using NHS veterans' mental health services. We also want to hear from family members and carers of veterans who have or have had mental health difficulties, as well as staff and organisations that are providing mental health care, treatment and support for veterans and their families.

New provider for adult community health services in Wiltshire

Wiltshire Clinical Commissioning Group has awarded Wiltshire Health & Care the contract to provide adult community health services in Wiltshire for the next five years.

Wiltshire Health & Care is a new organisation formed by Great Western Hospitals NHS Foundation Trust, Salisbury NHS Foundation Trust and Royal United Hospitals Bath NHS Foundation Trust.

The new contract is due to start in July 2016, and will mark the start of an exciting period of change, where more care will be delivered closer to local communities, people will be supported to maintain independence and reliance on hospital services will be reduce.

As part of the CCG's five year plan to bring health care closer to home, the changes to adult community health services will ensure that the focus is very much on patient centred care with GP

practices firmly at the heart of community provision. Delivered through integrated community teams across the county, Wiltshire Health & Care will support Wiltshire CCG to meet the challenges of an ageing population and to enhance partner working across the health economy to provide a health service fit for tomorrow.

Pilot out of hours service for unwell children

A new pilot service for an out of hours GP service for children has been launched with the aim of avoiding unnecessary A&E attendances. Parents of children aged 0-10 can now book a same day appointment to see a GP at the Salisbury Walk In Health Centre.

The extended service provides health advice and treatment for minor illnesses and injuries and provides parents with a local alternative to A&E when their child is ill and their surgery is closed.

The pilot service, which is already helping to reduce some of the pressure seen at our A&E departments over the winter months, will run until the end of March 2016. It is available for children under the age of 10, and is open Monday to Friday 18:00 – 22:00 and Saturday and Sunday 16:00 – 20:00 by contacting the 111 telephone number.

If necessary, the call handler will advise parents to contact the Walk In centre to make a same day appointment. If however, the child has an obvious serious or life threatening condition; parents are advised to call 999.

Stay well this Winter campaign

Wiltshire Clinical Commissioning Group are part of the **Stay Well This Winter** national campaign to raise awareness of what you can do to stay healthy this winter and what services are available if you need additional help.

The national **Stay Well This Winter** campaign started on 5 October 2015 and will run until 27 March 2016 and will also be providing advice to those with long-term health conditions, over 65s, pregnant women and parents of under-sevens.

Get the jab, get Flu Safe

NHS Wiltshire CCG is encouraging people to have their flu jab. Flu is a highly contagious infection that anyone can catch, but it can be very serious for some. For most people flu is a relatively mild illness from which they recover within a week or two – yet every year people, especially those at risk, become seriously ill because they don't get their free flu jab.

Flu is not the same as a cold and it affects people of all ages. If you or someone you care for is in any of the at-risk groups listed below you can get a free flu jab from your GP.

- everyone aged 65 years and over

- Have your flu jab. Everyone over 65, or with a wide variety of health conditions, is entitled to one free of charge. Immunity takes effect almost immediately, so even though a flu outbreak is currently well underway, you can still protect yourself by getting the jab – just call your GP to make an appointment.
- 3. If you do fall ill with flu, it's best to stay at home. Flu is caused by a virus, and cannot be treated with antibiotics so a visit to your GP is not necessarily the best course of action.
- 4. Vomiting and diarrhoea bugs caused by norovirus are common and very infectious. This can be a very unpleasant condition, but the best advice is to stay at home and drink plenty of fluids until the symptoms pass. Norovirus is highly infectious, with an incubation period of between one and three days. New Daisy service on target for summer opening

A brand new building, which will provide specialised services for individuals with complex learning disabilities and challenging behaviour, is now near completion and will open this summer.

The facility, called 'The Daisy' and based near Green Lane Hospital in Devizes, has been commissioned by NHS Wiltshire Clinical Commissioning Group and services will be provided by Avon and Wiltshire Mental Health Partnership NHS Trust (AWP). People will receive person-centred care and support within a local residential setting, allowing them to live as independently as possible within a community setting. Each individual living area will be fully equipped with a kitchen, en-suite bathroom and lounge area and people have contributed to the design of their own living areas by choosing their colour schemes and soft furnishing – a home from home.

The community aspect of this build will allow people living there to engage with the surrounding area, and involve them at the heart of the community. People will be supported to maintain their family relationships, build a fulfilled life through participation in the community, such as education, sports and leisure and they will be able to access mainstream services when required to ensure that their health and social needs are meet.





Wiltshire's plan to tackle obesity: have your say

Wiltshire residents are being asked to have their say on NHS Wiltshire Clinical Commissioning Group (CCG) and Wiltshire Council's plan to tackle the issue of obesity in the county.

Obesity impacts on everyone, so the CCG and council are keen to hear from as many people as possible to get their feedback on this draft strategy ahead of the consultation deadline on 30 April.

In Wiltshire, 29.3% of children aged 10 to 11 years are overweight or obese, along with 63.6% of adults.

The draft strategy is based on feedback from last year's Wiltshire obesity Summit and on evidence of what works in preventing and addressing the challenges posed by obesity.

The strategy aims to halt and then reverse the obesity situation in the county, and will complement and build on work already underway to support Wiltshire residents to achieve and maintain a healthy weight.

Attention Deficit Hyperactivity Disorder (ADHD) in Wiltshire

The contract for ADHD services in Wiltshire is currently held by Avon and Wiltshire Mental Health Partnership Trust (AWP) and this contract is due to finish at the end of March 2016.

Whilst a review of the whole contract is being undertaken, a temporary ADHD contract with AWP has been negotiated to run from 1 March until 31 August.

This extension will ensure that a large proportion of the current services can continue until a permanent two year contract can be agreed, and during this period AWP will continue to provide an ongoing service for:

- Existing patients who have already been assessed and diagnosed
- Existing patients who require ongoing follow up and prescribing
- Patients already being cared for under the shared care process
- Urgent and/or prioritised new referrals as approved by the CCG Exceptions Panel

The new contract will start on 1 September 2016.



Developing mental health services for veterans

The NHS has launched a national engagement on mental health services for veterans.

The engagement will run until 31 March 2016 and aims to capture views and experiences of these services from a range of stakeholders, including veterans who have or have had a mental health illness, their families and carers, service charities, commissioners and providers offering treatment and support in this area.

Findings from the engagement will help to ensure that future mental health services for veterans are accessible, provide high-quality and sensitive care, treatment and support, and best meet the needs of veterans, regardless of when they leave the armed forces.

Currently, the NHS commissions 12 mental health services across England for veterans. These were set up in 2010 following publication of "Fighting Fit: a mental health plan for servicemen and veterans". The contract on these services are due in 2016/17 and this provides the NHS with a significant opportunity to ask people about their views and experiences of the current services. This will also allow the NHS to explore why some veterans have not sought or received support and treatment.

The NHS wants to hear from people who have served in the armed forces and have used or are currently using NHS veterans' mental health services. We also want to hear from family members and carers of veterans who have or have had mental health difficulties, as well as staff and organisations that are providing mental health care, treatment and support for veterans and their families.

Executive Summary

Wiltshire Council is undertaking a major programme of investment in highway maintenance over six years, which is delivering a significant improvement in the condition of the county's highway network.

The flooding in 2013/14 had an adverse effect on road conditions, but the additional investment through the Council's 'Local Highways Investment Fund 2014 - 2020' has arrested this deterioration, and the county's road conditions continue to improve.

The investment has been targeted at those roads in worst condition, and includes minor roads as well as the main roads. The programme is just reaching the end of its second year, and has already seen a substantial amount of work completed (see **Appendix 1**).

In 2016/17 it is proposed to increase expenditure on treating the smaller sites, many of which have been outstanding for some time, and to reduce the number of larger surfacing sites.

A list of potential sites for next year has been prepared for each community area (see **Appendix 2**). The site list is based on the existing condition of the roads and the anticipated deterioration in the future, and the area boards are invited to consider the proposals.

It should be noted that the list will probably need to be reviewed during the year as the rate of deterioration of individual roads does vary because of weather and local conditions.

There has been an extensive programme of integrated transport, traffic management and safety schemes carried out in recent years. (See **Appendix 3**). The Community Area Transport Groups (CATGs) have had a vital role in helping prioritise schemes.

The Council is in the process of identifying a 'Resilient Road Network' (See **Appendix 4**), which will form the core network where specific measures would be considered in order to ensure the continuing availability of this route in extreme weather conditions.

Proposals

Area Boards are asked to note the work completed so far in connection with the 'Local highways Investment Fund 2014 – 2020', and consider the list of proposals for highway maintenance in their areas for 2016/17.

The Area Board are requested to note the proposed 'Wiltshire Resilient Road Network', and are invited to comment on the proposed network and any sections of the route of particular concern in their area.

Reason for Proposal

Wiltshire Council has a major programme of investment in highway maintenance over six years, which is already delivering a significant improvement in the condition of the county's highway network.

The views of the Area Board are important in helping identify local priorities for road maintenance, and future programmes of work.

Purpose of Report

1. To advise the Area Board regarding progress on Wiltshire Council's Local Highways Investment Fund 2014 – 2020, and to review the local highway maintenance priorities for 2016/17.

Relevance to the Council's Business Plan

2. The Council's Business Plan sets out the vision to create stronger and more resilient communities. It includes three key priorities and twelve actions that the Council will deliver over the next four years. One of the twelve actions is to 'invest additional money between 2014 -17 to reduce the historic backlog in highways maintenance'.

Background

- 3. Expenditure on highways maintenance declined substantially during the 1990's, and there was underinvestment in roads maintenance nationally for many years. There was an increase in spending from 2000/1, with the introduction of Local Transport Plan funding, but there was still a large backlog of maintenance required on the network.
- 4. In 2014 Wiltshire Council started a major programme of investment in highway maintenance over six years to bring about a significant improvement in the condition of the county's highway network.

Main Considerations for the Council


Local Highways Investment Fund 2014 - 2020

5. The investment is being targeted at those roads in worst condition, and includes minor roads as well as the main roads. Assessments based on road safety information and road condition data has been used to prepare annual lists of priority sites for treatment which are presented to the Area Boards for consideration.

- 6. Some roads need to be treated as priorities in order to address skid resistance and safety problems. As well as addressing the roads in worst condition, improvements are being made to the drainage and footways to bring them up to standard.
- 7. In addition to the larger sites, the Council has also been repairing smaller localised sites which are suffering from deterioration, or which need repairs. This programme of pothole and defect repairs will continue across the county in response to local damage identified through the Council's regular inspections or reports from the public and road users.


Condition of Roads in Wiltshire

- 8. The condition of classified roads is measured by technical surveys carried out using vehicle mounted laser scanners to a methodology established by the Department for Transport (DfT). These reflect the overall road condition and have been reported as National Indicators for a number of years.
- 9. The condition of the classified roads in Wiltshire has improved considerably since 2009/10. The flooding in 2013/14 clearly had an adverse effect on the road network, but the additional investment through the Council's Local Highways Investment Fund has helped stem this deterioration.
- 10. The investment made by the Council over the years has seen a reduction in the length of A Class road where treatment should be considered:



Percentage of A Class Roads in Wiltshire in poor condition

11. The B and C class roads have also improved. There has been a reduction in the percentage of road where treatment should be considered in recent years:



Percentage of B and C Class roads in Wiltshire in poor condition

- 12. The condition data on the unclassified roads is not as robust as for the classified roads, but indications are that these roads are also starting to improve. Data is being collected on the unclassified road network using the same methodology as for the classified roads, but this will take a few years to achieve the same level of detail. Initial analysis of this data indicates that approximately 6% of the surveyed unclassified network is in poor condition.
- 13. The road conditions in Wiltshire have been compared to other south-west counties. Conditions of the A class roads in Wiltshire, based on the 2013/14 figures published by DfT, are broadly similar to those in Dorset and Somerset, but not as good as those in Devon and Cornwall. The B and C Class roads, which are an important part of the network in Wiltshire, have been better than those of the adjoining counties for a number of years.

Highways Maintenance Programme

- 14. There has been considerable maintenance work carried out on the highway network in Wiltshire in the last two years as part of the Council's Local Highways Investment Fund. The list of local sites completed is included as **Appendix 1**.
- 15. During 2015/16 there were a number of sites which it was not possible to complete. These were primarily surface dressing sites, sometimes referred to as 'tar and chip', which is a cheap cost effective way of treating rural roads. However, it does need the underlying road structure to be in good condition as it provides a thin surface to improve skid resistance and seal the road construction, but does not add significantly to the strength to the road.

- 16. In the event the extent of structural repairs required on some of the minor roads proved larger than anticipated, and some surface dressing sites had to be deferred. The process has to be carried out during a short period in the summer, and it was not possible to complete the full programme of works last year.
- 17. There were a few sites which had to be postponed because of public utilities work. This was to avoid the road being dug up soon after being laid. The intention is that that any public utility mains and cables should be laid completed before the road is resurfaced.
- 18. A list of potential sites for next year has been prepared for each community area (see **Appendix 2**). The site list is based on the existing condition of the roads and the anticipated deterioration in the future, and the area boards are invited to consider the proposals.
- 19. In view of the general improvement in road conditions, and the current financial restrictions, it is proposed to defer some of next year's investment until following years. This will reduce the number of larger surfacing sites being undertaken next year, but those where road safety is a serious consideration will still be prioritised.
- 20. The new contractual arrangements following the end of the current highways contract has enabled the Council to establish a direct contract with the surfacing sub-contractor. This has seen an improvement in service with more certainty of delivery with a good quality of work.
- 21. An area where delivery has improved significantly in recent months is with regard to the smaller sites where there is localised damage and potholes. These can be particularly difficult because they often need road closures and diversions to enable the works to be carried out safely. Programming these works, and integrating them with works by other on the network, is a challenge, but good progress is now being made.
- 22. It is proposed to increase the budget for this type of work substantially in 2016/17 in order to address some of the smaller sites which it has not been possible to progress in recent years. It is intended that the local Highways staff will have greater input in identifying priorities, potentially with the CATGs also being involved. The procedures will be developed in more details over the next few months.
- 23. The Council has been carrying out footway and drainage works in conjunction with many of the surfacing sites, but there is a requirement to develop a programme of footway works. Condition data has been collected for the urban footways over a number of years, and is expected to be substantially completed this year. This will enable a programme of footway major maintenance to be identified for consultation and potential implementation in 2017/18.

Integrated Transport Schemes

- 24. The CATGs have proved particularly successful at identifying and prioritising local transport issues, and a number of schemes have been delivered in recent years, with many more being developed for future implementation. See **Appendix 3**.
- 25. It is proposed that this process should continue with the budgets for this type of work continuing for next year. The Area Boards are encouraged to use the CATG process to deal with local concerns.
- 26. The Council analyses the injury accident records in order to identify sites with particular accident problems. These sites are reviewed and where appropriate improvements are proposed. These will continue to be developed, with the CATG kept informed of progress.

Resilient Road Network

- 27. The major maintenance work is improving the condition of the highway network and making it more resilient to extremes of weather. The flooding during 2014 affected a number of key routes in the county, and there is a need to identify a core network where specific measures should be considered in order to ensure the continuing availability of the route.
- 28. The Council already has an identified network of main roads which is the priority to keep open in the event of an extreme snow event. This comprises the busiest main roads, and is about 10% of the network. Once these have been cleared other roads are then treated in accordance with local priorities and conditions. There is a much more substantial network of roads which is subject to precautionary salting when ice is forecast.
- 29. It is proposed that the core network (See **Appendix 4**) should be designated the 'Wiltshire Resilient Road Network', and should be reviewed to determine whether specific measures are necessary to ensure its continued availability in adverse weather conditions of all types.
- 30. Any comments on the proposed resilient network, or areas of concern, would be appreciated, especially with regard to any sections of the route which may be considered particularly vulnerable. The Area Board may wish the CATG to consider the proposed network.
- 31. Extending the length of roads to be included in the core network would not be feasible because of resource limitation with regard to snow ploughing or specific works to improve resilience. If the proposed resilient network is too large it could divert funding away from other roads on the network.

Safeguarding Implications

32. Does not apply.

Public Health Implications

- 33. Increased investment in road maintenance has benefits for public health. The improved road surfaces, better skid resistance and associated safety improvements help reduce the numbers killed and injured on the road network. These improvements complement the other measures to improve road safety, such as traffic calming and speed limits, being introduced through the Local Transport Plan funding and the Community Area Traffic Groups.
- 34. The improved road surfaces, particularly on the minor urban roads, will be of benefit to cyclists and pedestrians. At present the condition of some of the urban roads may discourage cycling as cyclists are adversely affected by poor road conditions and uneven or damaged surfaces. The proposed investment would support the strategy to encourage cycling as set out in the Local Transport Plan.
- 35. Roads in poor condition in urban areas can result in disturbance and noise for residents, especially on busier routes carrying heavy goods vehicles at night. Better road surfaces should result in reduced background noise in residential areas, with potential mental and physical health benefits.
- 36. The Council monitors road collision data in order to focus safety improvements at those sites with the worst accident records. With the additional funding this process will continue, and where appropriate other alterations to signing, drainage, street lighting or road markings could be incorporated into resurfacing work and schemes to improve safety.

Environmental and Climate Change Considerations

- 37. The road network is particularly vulnerable to the effects of climate change. In recent years we have seen the effects of a series of severe winters which have resulted in damage to the roads and an increase in the number of potholes. In 2014 flooding damaged a number of roads in Wiltshire, and increased deterioration.
- 38. In the longer term a more robust highway network, with roads in better condition, would require less reactive maintenance and reduced travelling to respond to potholes and localised defects. A planned maintenance regime would enable the traffic disruption to be kept to a minimum. With unplanned maintenance the delays to traffic and associated fuel consumption could be considerable.
- 39. The identification of a Resilient Road Network for the county will help identify the key areas where measures may be required to ensure the continuing availability of main routes in extreme weather conditions.

Equalities Impact of the Proposal

40. The improvements in road safety anticipated with increased investment in road maintenance would be expected to benefit all road users, but

especially the more vulnerable, including pedestrians, cyclists and other non vehicle users.

41. The highway network is important to local businesses, and to public transport operators. The delays due to un-programmed maintenance and road repairs have been identified as concerns by local businesses. The high profile programme of works to address road conditions will help send the message that transport is important in Wiltshire and could help to promote inward investment and job creation.

Risk Assessment

- 42. There are serious risks in connection with road maintenance. These include the safety and reputational aspects of those killed and seriously injured on the highway network. In order to reduce these risks the Council has approved highway inspection and skid resistance procedures in place, but in order to keep the network in safe condition it is important that the highway network has adequate investment, and the safety issues are prioritised.
- 43. The road condition data collected thorough the technical surveys is used to focus investment on those sites where there is most need and greatest risk. As well as the safety benefits this approach also ensures that best use is made of the limited available funding in order to keep the asset in optimum condition.

Risks that may arise if the proposed decision and related work is not taken

- 44. The risks to the Council from lack of road maintenance are in terms of claims against the Council as the result of accidents, or in extreme cases prosecution as a result of particular incidents. As well as the safety and cost aspects, there are also significant reputational implications of such events.
- 45. Not carrying out highway maintenance would lead to declining public satisfaction in the future as road conditions remain the same and no progress is made on improving them.

Risks that may arise if the proposed decision is taken and actions that will be taken to manage these risks

- 46. There is a risk that the proposals will not deliver the improvements in road condition anticipated. This risk will be managed by using the technical data to focus the necessary investment on those sections of road where work is required to meet safety requirements, and on those places where it would improve road conditions the most. Effective asset management will reduce this risk and make sure the investment is effective.
- 47. There is a risk that the investment will not increase public satisfaction with the service. In view of the initial results from those authorities which have made a substantial investment it would appear that satisfaction levels will

improve with the investment. However, a programme of publicity, branding and public involvement through the Area Boards will help raise awareness of the project, and will help to reduce this risk.

Financial Implications

48. The Council's approved budget has included increased investment to deliver the Council's Business Plan with regard to road maintenance. This has been £24 million for the past two years. It is proposed that £3 million of next year's expenditure will be moved in to future years in view of the improving road conditions and current budget pressures.

Legal Implications

49. The Council has a duty under the Highways Act to maintain the county's roads. The highway inspection procedures, policies and improvement plans ensure that this duty is fulfilled. The increased investment and improved road conditions is helping the Council meet its responsibilities with regard to road maintenance.

Options Considered

50. The Council reviews its proposed road maintenance programme annually in order to make best use of the latest information and take into account deterioration of the road conditions because of weather or other factors.

Conclusions

- 51. The conditions of the road network are important to the public, and this is reflected through the People's Voice and NHT surveys. There has been expenditure above anticipated LTP funding levels in Wiltshire which is improving the condition of Wiltshire's highway network.
- 52. The Highways Investment Fund 2014 2020 over the six years will provide a significant improvement to the condition of the network, including improving the condition of the unclassified roads, and improving safety on the classified roads. The involvement of the Area Boards to help identify local priorities for treatment is important.


