1	Welcome
	The Chairman welcomed those present to the meeting and Board members introduced themselves. The Chairman thanked Malcolm Smith for use of the village hall for the meeting.
2	Apologies for Absence
	Apologies for absence were received from:

3	<u>Minutes</u>
	Resolved:
	To approve and sign as a correct record the minutes of the meeting held on 16 May 2016.
4	Declarations of Interest
	Cllr Sue Evans declared an interest in a grant application from Devizes and District Association for the Disabled, she would not participate in debate and vote on this item.
5	Chairman's Announcements
	The Chairman gave the following announcements.
	<u>Wiltshire Online Programme</u> Wiltshire Council currently had a Basic Broadband Commitment Scheme designed to provide support to homes and businesses unable to receive broadband speeds in excess of 2 megabits per second (Mbps) and who were not benefitting from the superfast broadband rollout. There were further details available on the tables for those who required more information.
	<u>Update on Urgent Care Centre</u> A milestone plan had been received for an Urgent Care Centre in Devizes and it was envisaged that outline planning permission would be sought in July / August 2016. Work continued on the sizing of the building, how the building would be used, how primary care would operate at scale across the 5 practices of Devizes and the surrounding area and how services would integrate. It was expected that all of the current services in the existing community hospital would relocate to the new unit. Completion of the project was expected to be in September

	Devizes School Open Day An open day was to be held at Devizes School on 13 th July 3:30-6:30pm, the evening would be arranged around 8 faculties but would also feature guided tours of the Sixth Form Centre.
	Anti-social behaviour Members were aware of anti-social behaviour in Devizes at Station Road car park and were working to tackle this with other partners.
6	Partner Updates
	Inspector Nick Mawson spoke to a short video about a new policing model which would be implemented across the county from October. The new model was designed to be more efficient and to respond better to the public by having one officer as point of contact for each reported crime meaning less handovers of work between different officers. In response to questions from the public, the Inspector explained that further communications would be released over the coming months and it was acknowledged that communication and visibility of officers was very important.
	Written updates were available in the agenda pack from the Clinical Commissioning Group and HealthWatch Wiltshire.
	Devizes School promoted the School's open day, Lavington School promoted the school fete, which was to be held the following week.
7	Open floor session
	Members of the public were invited to ask questions of their local councillors.
	Rowde Parish Council advised that the My Wiltshire App for logging maintenance jobs was not working well for parish councils as they could not access the system to see the work that had been completed, it was also commented that it was difficult to report the exact location of an issue on the App. Cllr Whitehead, Cabinet Member for Highways and Transport, advised that the App would soon be better linked to the operating system which would allow greater feedback of information and he was planning that in 2017 the App would be able to produce a report for each parish council of works undertaken in their area. Further questions were raised from the parish council on the need to improve the pavement on Dunkirk Hill and the issue of parking on pavements in villages. The Cabinet member advised that the pavement on Dunkirk Hill would be improved at the same time as the road works which were planned for the autumn; it was confirmed that parking on pavements could be reported to the Police, but only if it obstructed the path.
	Residents from Erlestoke and Market Lavington asked what could be done to improve visibility at the 'Black Dog' crossroad and suggested that land be

	To constitute the Devizes Community Area Wellbeing Group in accordance
	Resolved:
	The Area Board considered the update and the proposed Terms of Reference for the Wellbeing Group.
	Mike Challinor, Devizes Champion for Senior People, updated that the Devizes Community Area Wellbeing Group was now established and would operate as a sub-group of the Area Board. Parishes or other interested people were encouraged to join the group if interested, the next priority of the group was to appoint a Champion for Carers locally and continue working on Devizes' registration for a Dementia Action Alliance. Following comments from the public Mr Challinor advised the group would make contact with charities for older people such as Age UK, and would be working on a broader range of issues for older people, beyond Dementia.
9	Health and Wellbeing Group
	Cllr Laura Mayes, Cabinet Member for Children's Services, thanked the youth club for all of their hard work to run a successful youth club for the last 30 years.
	Mike May, West Lavington Youth Club, was invited to introduce the club which was a registered charity. Mr May advised that the charity had an annual requirement for funding of approximately £15,00 per annum, which allowed the club to be open 3-4 nights per week. Adults running sessions at the club people were paid professionals, which meant they were reliable and fully trained in terms of first aid, safeguarding etc.
	Helen Bradley, Locality Youth Facilitator, introduced herself as the officer that would now be supporting the Local Youth Network. Helen would be performing a different role to her predecessor, but would continue to work with local groups to organise grant funding in support of activities for young people. The officer encouraged groups in the area to introduce themselves to her and was pleased to have met a representative for the West Lavington Youth Club at the Area Board meeting.
8	Youth update
	A question was raised over the height of speed bumps in the town since they were damaging the community bus. Cllr Whitehead advised that Kerry Rose would be contacted and advised that during a recent test of the speedbumps no damage had been caused.
	acquired from the farmer in order to move back the nearby fences. The Cabinet member responded that he would ask that the brambles at the crossing be cut back (this would give an immediate improvement to visibility) and the issue of permanent works would need to be raised with the Community Area Transport Group.

10	World War One Centenary commemoration
	To commemorate World War One centenary, Roger Frost (Curator at West Lavington Museum) gave a presentation on the presence of Commonwealth soliers in the area and the deployment of local men to the war effort during WW1.
	The Chairman thanked Mr Frost for a very interesting presentation and encouraged residents to visit the museum.
11	Area Board Capital Funding
	The Board considered applications for community area grant funding, Cllr Sue Evans left the meeting in her capacity as a councillor for consideration of the application from the Devizes and District Association for the Disabled (DDAD).
	Representatives from DDAD, St Joseph's Nursery, Devizes and District Opportunity Centre and the Kennet and Avon Canal Trust spoke in support of their applications.
	The Chairman explained that the application from Kennet and Avon Canal Trust for boiler repairs at Crofton Pumping Station was not in the Devizes area and funding had also been sought from Pewsey and Marlborough Area Boards, however was of great local interest and attracted visitors to the area. With this in mind, the Chairman proposed that the amount of funding granted be put to the public vote; the consensus was that £2,500 be granted for the boiler repairs.
	Resolved:
	 To grant Devizes and District Association for the Disabled £3,261 to bring bathroom facilities up to date; To grant St Joseph's Nursery £1,500 for an 'app' to monitor Children's Development; To grant Devizes and District Opportunity Centre £3,500 towards an outdoor classroom; To grant Kennet and Avon Canal Trust £2,500 for boiler repairs at Crofton Pumping Station.
	Cllr Simon Jacobs introduced a proposed councillor-led initiative for funding to create a more user-friendly wooded area at Pine Walk. The project would involve clearing rubbish, planting trees and involving young people in the development, the project would be match-funded by Grist Environmental. Following questions from the floor it was confirmed that local residents were very supportive of the works which was designed to link up pathways around Devizes and tie in with works at Drews Pond. It was further noted that Wiltshire

	Council owned the land in question and Cllr Jacobs had liaised with Wiltshire Wildlife on the project as well.
	The Chairman also updated that DOCA had advised the Area Board that they had £1,200 unspent from an Area Board grant of £5,000 and the Board agreed this could be re-invested in IT resource and resources for carnival activities
	Resolved:

	Cllr Philip Whitehead advised that the CATG had received, and supported, a request for funding to buy planters for a traffic calming scheme on Rotherstone and requested that the Board consider this application for funding.

Subject: Wiltshire Online Programme – Extension of the Basic Broadband Commitment Scheme

What is the Basic Broadband Commitment scheme?

This scheme has been designed to provide support to the homes and businesses that are unable to receive broadband speeds in excess of 2 megabits per second (Mbps) and who will not be benefitting from the superfast broadband rollout. The scheme was previously referred to as the Universal Service Commitment (USC).

Who is eligible for the scheme?

Residents who are unable to receive a service of more than 2Mbps and who are not benefitting from the Wiltshire Online superfast broadband rollout programme are eligible to apply to the scheme.

Why is there a subsidy available?

The subsidy is to provide support for premises which do not have access to broadband speeds of more than 2Mbps at an affordable price; 2Mbps is the minimum speed required to undertake routine activities over the internet. The basic requirement is that premises should not have to pay more than £400 over a 12 month period to access a basic broadband service; this cost represents the monthly charges, installation, hardware and activation costs. The subsidy scheme helps make basic broadband affordable by contributing towards the cost of the equipment and installation.

How does the scheme work?

Eligible residents are provided with a subsidy code which allows residents to gain access to a subsidised broadband connection, with all of the capital costs and at least part of the installation cost paid for. Residents are able to choose from a number of retail service providers and from a variety of packages to suit their budget and needs.

How has the scheme altered?

The scheme was originally launched in December 2015 in line with our contractual commitment to provide a basic broadband service via a satellite solution. However, Wiltshire Council has been working closely with BDUK since the launch of the scheme and we are pleased to advise that it has now been extended to include alternative technologies. For a list of current suppliers operating in Wiltshire please see Annexe 1.

Opening up the scheme to alternative technologies should see Wiltshire's residents being able to access a wider range of suppliers.

Does the scheme work the same for wireless technologies as with satellite providers?

Yes, the subsidy code can be used in exactly the same way with a wireless provider; the subsidy is used to fund the installation and equipment costs the same as with a satellite solution.

The one difference with the wireless technology is that it can be designed to serve multiple premises and could lend itself to a community based solution.

How do residents apply for the scheme?

Subject:	Mental Health Awareness Raising

The Public Health team at Wiltshire Council have developed some tools to help raise awareness of mental health both in the workplace and in communities.

We are able to offer (to Area Boards and other community groups) a session which is ideally about 90 minutes long (but can be tailored to provide a session of about 50 minutes if timings do not allow the full package to be delivered).

The session takes inspiration in its approach and ethos from the extremely successful Alzheimers' Society 'Dementia Friends' programme and is designed to deliver community awareness raising, increase understanding and reduce stigma and discrimination.

The session itself is interactive and suitable for both professionals and members of the public. It involves some group activities and video clips as well as information about mental health and how to keep yourself well. It focusses strongly on how to improve and maintain wellbeing and mental health and uses tools like the Five Ways to Wellbeing <u>http://www.neweconomics.org/projects/entry/five-ways-to-well-being</u>

Sessions held to date (including Health and Wellbeing Board, Health Select Committee and Westbury Area Board) have been extremely well received and have generated some healthy debate about promoting mental and emotional wellbeing.

The Public Health team is now in the process of rolling this session out more widely to include:

- Training key members of staff to deliver the sessions (e.g. Health Trainers, volunteers)
- Delivering the session within Wiltshire Council for staff members
- Publicising the sessions for wider dissemination
- Engaging with local voluntary and community sector organisations such as Mind to explore the option of offering the opportunity for their staff/volunteers to receive training and deliver the session
- Producing a toolkit to run alongside the training (or to stand alone) which will be available from September 2016.

2. Local Issues and crime:


During August and September 2016 PC Twyford and SPC/I Guy Sanders arranged targeted patrols concentrating on the issues of anti social driving and inconsiderate driving within the Devizes area. These targeted patrols have been highly successful and have resulted in Sec 59 Notices being served, the issue of Fixed Penalty Notices and vehicles being taken off the road.

Section 59 of the Police Reform Act 2002 provide uniformed police officers powers to deal with persons using mechanically propelled vehicles in an anti social manner, either on or off road. The officer must have reasonable grounds for believing that a mechanically propelled vehicle is being, or has been, used on any occasion in a manner which:

contravenes section 3 or section 34 of the Road Traffic Act 1988 (careless and inconsiderate driving and prohibition of off road driving) AND is causing, or is likely to cause, alarm, distress or annoyance to members of the public. The police can seize the vehicle however a warning has to be issued first. It would appear these warnings alone have had a positive impact on the reduction of the anti social behaviour.

3. Wiltshire Police Control strategy

Below is the Wiltshire Police Control Strategy, this is used to highlight our policing prioritises. As you can see these are areas of high risk which we need to concentrate on to protect the public.



Cybercrime

What is cyber crime?

Cyber crime means digital crime (any crime that involves a computer and a network). The computer may have been used to;

- Commit the crime.
- Be the target of the crime.
- Facilitate the crime.

Offences can range from harassment, to fraud to sexual offences and it is important that we learn how to keep ourselves and others safe as a large amount of the these crimes can be prevented.

<u>www.getsafeonline.org</u> is a website that offers advice on how to use the web safely. The site provides information that can assist with things such as transferring money to being aware of Copy Cat websites.

Keeping children safe forms part of our force strategy, teaching them how to stay safe on line is a preventative measure to reduce the risk of potential exposure to the dangers of the internet. The Child Exploitation and Online Protection Centre have created a website that aims to inform children in different age groups how to keep safe. It is also a useful tool to assist parents to communicate with their children. The site is <u>www.thinkuknow.co.uk</u> and it has been endorsed by the national Crime Agency and Childline.

<u>Domestic Abuse</u>

NPT play an important part in the investigation of Domestic Abuse. The team work closely with our Domestic Abuse Investigation Team (DAIT) based in Melksham and assist them with the safeguarding of victims. The NPT do this by working closely with external agencies such as

Housing and Family Services to ensure that any relevant information is shared enabling all of the agencies involved to support each individual according to their needs.

Domestic abuse can occur anywhere and may not be as overt as physical assaults that result in injury. There is new legislation that covers controlling or coercive behaviour so if you have concerns that domestic abuse is occurring them please report them.

The Domestic Violence Disclosure Scheme (DVDS), also known as Clare's Law, is used to help anyone who is worried they, or someone they know, may be at risk of domestic abuse. If an individual believes their partner was abusive in a previous relationship, or is concerned that someone they know is with an abusive partner, the disclosure scheme explains how they can apply for information about the partner's history.

High Risk Victims

The NPT are identifying and working with high risk victims on a daily bases. Victims can be deemed high risk for many reasons and examples of these are people with learning difficulties, domestic abuse victims, people with mental health conditions and the elderly. The NPT have formed close working relationships with other agencies to identify members of the community who may be at risk and are working together to reduce this risk.

High Risk Offenders

The NPT have been working closely with our new dedicated Intelligence officers in order to identify our persistent and dangerous offenders. By working closely together they have been able to identify and prioritise problems areas that need close attention and positive action. This one team approach has be successful as everyone involved have the same objectives. 4. Other issues

PS Vince Logue has left NPT to take up a new role at police headquarters and his replacement is TPS Lou Morley who joined us on the15 August 2016. Unfortunately PC Jon Bedbrook has left the police force to start a new career however we have been joined by a new member of the team PC Nicky Cross.

As of the 17 October 2016 Wiltshire Police will be implementing a new style of policing that will be rolled out over various towns within Wiltshire, including Devizes. The basic principle of the new way of working is that there will be a "One Team Approach". These are new and exciting times that will see Devizes police station becoming a hub of activity. The NPT team will be merging with the Response Teams and there will now be 24/7 cover from Devizes Borough. The new teams will now be known as Community Policing Teams (CPT). B&NES, Swindon and Wiltshire Sustainability and Transformation Plan

All health and social care organisations are working together across Bath and North East Somerset (B&NES), Swindon and Wiltshire on a five year sustainability and transformation plan (STP) to improve our local population's health and wellbeing, to improve service quality and to deliver financial stability. We are developing a joint approach that will help deliver the aims of the Five Year Forward View and is in line with other important national guidance such as GP Forward View, Mental Health Taskforce Report and National Maternity Review.

Why do we need an STP?

There are growing pressures on the health and care system, nationally and locally. The proportion of older people is rising and there are more people living with complex conditions. This is contributing to an increased demand for services.

Overall across B&NES, Swindon and Wiltshire the standard of health and care services is very good compared to other areas in England.

But some challenges remain. Our hospital Accident &Emergency (A&E) departments are under pressure, in some areas patients are waiting too long for GP appointments and there are gaps in quality with some parts of our region benefitting from better health and care services than others. Additionally there are increasing financial pressures. Across all our local health organisations there was a collective end of year deficit of £6million for 2015/16 and this will rise to £337million at the end of 2021 across our combined area if we do nothing.

So we are working on a collective plan to drive greater efficiency and improvements in quality across the health and care system. For services to be sustainable, we also need to get better at preventing disease, not just treating it, and encourage everyone to take responsibility to manage their own care.

Our STP partners

Our plan brings together our three hospitals (Royal United Hospital, Great Western Hospital and Salisbury Foundation Trust), the three Clinical Commissioning Groups (CCGs); B&NES, Swindon and Wiltshire Councils, South West Ambulance Service (SWASFT) and Avon and Wiltshire Mental Health Partnership Trust (AWP). The providers of our community services – Wiltshire Health and Care, Seqol and Sirona as well as the West of England Academic Health and Science Network (WEAHSN) and the Wessex Local Medical Committee (representing GPs from across the BSW area) complete our organisational grouping.

Working together to transform services

The health and care needs of our local population across B&NES, Swindon and Wiltshire are diverse and we are developing a joint approach that takes this local variation into account. Our joint work will not replace individual organisational plans or our B&NES, Swindon and Wiltshire Health & Wellbeing Strategies. And it will not stop all the great work already going on locally to improve local services.

The emerging STP focuses on shared challenges and opportunities across the wider geographical footprint. This is 'place-based' planning that is not limited by organisational boundaries and covers CCGs, NHS providers, specialised services and primary care. It also includes better integration with local authorities including social care, prevention and self-care. Some of our partner organisations such as AWP, Sirona and SWASFT operate beyond our combined area and so will overlap with other STP footprints.

Our emerging priorities

Based on our knowledge of local need and challenges and in line with national guidance, we have developed three transformational work-streams. Each is led by a CCG Accountable Officer. These are:

- Preventative and proactive care
- Planned care
- Urgent and emergency care

Over the past four months, organisation and service leads have been meeting in work stream groups and together at a number of cross-organisational workshops to explore solutions to the common challenges across B&NES, Swindon and Wiltshire. They have also begun to identify opportunities for innovation that will benefit the local population, agree some collective health outcomes and explore the potential for a standard set of quality and performance measures across the footprint. There are five emerging priorities:

- To provide improved person-centred care by strengthening and integrating the specialist services that support primary care
- To shift the focus of care from treatment to prevention and proactive care
- To redefine the ways we work together as organisations to deliver improved individual/patient care
- To ensure we offer staff an attractive career and build a flexible, sustainable workforce
- To strengthen collaboration across organisations to directly benefit acute and urgent care services.

What next and how can I get involved?

Compared to other STP areas, we do not have an established relationship across all the health and care organisations with the B&NES, Swindon and Wiltshire footprint so we are at an early stage of STP development.

We shared our outline proposals for the next five years with NHS England in June and will submit more detailed plans at the end of October. This will enable us to qualify for additional funding through the Sustainability and Transformation Fund from 2017/18 onwards, to help deliver our plans.

Drawing on the experience and clinical expertise of our workforce and those that use health and care services, as well as their carers, will help us to redesign services and to develop new models of care that are sustainable.

Across our combined area, we already have a wealth of patient insight and useful information from recent consultation and engagement activity. However the STP offers our stakeholders a new opportunity to inform our plans for local health and care services and we are committed to ensuring everyone's views are taken into consideration at all stages of the process. We are working closely with Healthwatch (the consumer champion in health and care) in B&NES, Swindon and Wiltshire to make sure the voice of local people is represented as our plans begin to take shape.

Updates on our STP will be shared at CCG board meetings, AGMs and Council meetings, please check individual organisation websites for details of these. A wider programme of public engagement will commence in the autumn and more information on this will be available here shortly. Big Pledge 2016 - the 'Road to Rio'



Summary Report

To celebrate the 2016 Olympics and Paralympics, Wiltshire Council's Big Pledge - 'Road to Rio' invited local residents to get involved in an activity challenge and improve their health and wellbeing.

Between 4 June and 29 July over **18,000** local people took part. In total participants ran, walked, swam or cycled **779,742km** over eight weeks. The challenge gave them the motivation



to get moving and the chance to see what a difference exercise can have.

People signed up to take a virtual journey around the world to the 2016 host city of Rio de Janeiro. Individuals, schools and teams completed a 20 stage journey that included stops at previous host cities.

A medal winning performance

How did our schools got involved?

A total of 47 schools signed up to this year's Road to Rio challenge. The schools undertook a range of activities to complete their 'journey' to Rio including incorporating 'a mile a day' into their school day.

While the programme meant that the schools taking part focussed on increasing physical activity, some also used the programme as part of their wider geography and maths lesson planning.



What did teachers tell us?

"We all took part in the Daily Mile- where all children and staff walked briskly/ ran a mile around the school grounds. We held a sports week and the children were able to take part in various activities."

"We had regular assemblies to guess where we were in the world and pupils were able to have a guess and talk about the country where we currently were after each week, it also gave them incentive to keep going and reach the goal. The children are a lot more active with many now walking to school."

"It was a good chance to get the whole school active and fitted perfectly with the Olympic values. Pupils took part of their normal school day plus pedometers doing a variety of activities including Fencing, Swimming, Running, Sport Day, PE lessons, Tennis, Netball."

"The pupils have been learning about the Olympics. They have studied the history of the Olympics, the underpinning values & principles and about the different range of competitive sports. They pledged to walk at least 1 km 3 times a week prior to lessons and to undertake additional walks during playtime and lunchtimes. They have enjoyed the time together walking and talking to each other and on some mornings listening and dancing to music as they walk! This time has helped children develop their social and emotional wellbeing as they are learning to socialise in a different way than they would at lunchtime or playtime."

Briefing Note Devizes Wharf Development Brief

1. Purpose

This briefing note provides an update to the Devizes Area Board with regard to a proposal for a Development Brief for the Devizes Wharf area.

The Development Brief would provide a guide to development in the area, ensuring a coherent plan to avoid a piecemeal and fragmented approach. It would be aligned to the Local Policy Framework, the Wiltshire Core Strategy and the Devizes Neighbourhood Plan.

2. Introduction

The future use and purpose of Devizes Wharf has been under discussion for several years but, as yet, few proposals have been implemented. The possible realignment of key sites in the area provides an opportunity to re-invigorate the project through partnership working with the NHS and the Police and Crime Commissioner. Such a partnership could benefit from funding through the One Public Estate programme.

A significant amount of planning and consultation work was undertaken in 2011 mainly focused around the Theatre and Museum. Building on the earlier work, this brief intends to provide a framework for the wider Devizes Wharf area, taking into account emerging development opportunities and the potential role it can play in the context of Devizes.

The Brief would:

- set out the main development principles for the site to protect and enhance the characteristics of the area;
- clarify policies and their application to the site;
- provide a clear vision for the future of the site as it develops and grows;
- offer possible solutions to access/transportation issues;
- be considered in conjunction with the Devizes Neighbourhood Plan;
- provide detailed guidance as to how development will conform to the local planning framework
- be used to inform bids for investment and funding and used to support wider regeneration projects.

3. Progression of work and consultation feedback

Wiltshire Council Officers met with representatives of the following stakeholders in July 2016: Canal and River Trust; Devizes Canoe Club, Kennet and Avon Canal Trust, The Wharf Theatre, Police and Crime Commissioner, NHS

A stakeholder consultation event was held on 11 August 2016 at the Wharf Theatre, Devizes, in order to gain initial feedback from local landowners and interested parties.

4. <u>Risks</u>

If Development Brief route is not pursued:

- Continued deterioration of Assize Courts building
- Missing NHS timeframe resulting in poor development in the area
- Lack of support for the process/no consensus on plan
- Missing opportunity of One Public Estate Funding

If Development Brief route is pursued:

- Raising expectations
- Lack of support for the process/no consensus on plan
- Lack of resources to achieve objectives of plan

5. Outputs and Proposed Timetable

The intention would be to take the Development Brief to the stage where it could be formally adopted by the Council and form significant material consideration for future planning applications.

Project description

Alzheimers Support has two shop front offices in Trowbridge and Devizes which have good sized meeting training rooms. We have over 90 staff who have comprehensive induction and ongoing training requirements. As dementia experts we offer training courses to professionals outside our organisation which generates income for the charity. Another method for generating income is the hiring of our rooms and their facilities to external customers. We want to increase our technological capabilities to move on from powerpoint and projectors to TVs and tablets. This will enhance our offer internally and externally and widen the range of training we can deliver.

Who will benefit - Alzheimers Support staff, other professionals such as care homes care agencies anyone who accesses our specialist dementia training. Organisations hiring the room will also benefit. How will they benefit – The training rooms will be well-appointed with modern up to date equipment which is more intuitive to use. The environment will be safer with no need for laptops projectors and trailing cables. We will be able to access a broader range of media in training delivery which in turn will make training sessions more interesting and diverse.

All training is monitored through feedback evaluation forms. Some staff training is mandatory and is required to comply with the Care Act. Staff must prove competency before being allowed to go on to work for us. Feedback forms following room bookings will also contribute to the monitoring process.

Project description

We would like to redesign our toilet area to provide both Gents and Ladies that are accessible for those with disabilities and to provide baby changing facilities. Our current toilets are very old and do not allow for either. Consequently we have had wheelchair-using residents unable to use the Hall and our Toddler group in particular struggles with the lack of changing facilities. Updating the toilets will also make them more comfortable for all users. The hall is used by a number of individuals and community groups all of which will benefit from this work.

All residents of Worton and Marston about 750 plus those outside of the two villages who attend community events or private functions will benefit from updating the toilet facilities. The Hall is an important amenity for the two villages and helps tackle social exclusion by providing a venue for people to meet and participate in social groups such as Toddlers, Brownies, Rainbows, Womens Institute, Ladies Group and Gardening Club or improve health and fitness by attending pilates or dancercise classes. In addition it is used for celebrating different landmarks in the year of the two villages such as the Christmas Fayre and the annual Church supper and it is used for Parish Council Meetings. Over and above the modernisation it is those with accessibility needs and those with young children who will benefit most from the changes we plan to make to the toilet layout and the additional provision to meet their needs and make the Hall accessible to and usable by all. It is not clear how many people fall into these categories in the two villages as they have been largely excluded from being able to use the Hall through lack of appropriate facilities in the past.

Not only does it allow parents of juniors and other spectators to understand and see the score as matches progress but it also keeps the players up to date as well.
