#### 36 Amesbury and Salisbury Recovery Update

Cllr Pauline Church, Cabinet Member for Economic Development and South Wiltshire Recovery, gave an update on the recovery in Amesbury and Salisbury.

78 businesses had been contacted by Wiltshire Council in Amesbury and £12,500 had been granted, to date, to financially support Amesbury businesses severely impacted by the incidents. £15,000 had been allocated to help Amesbury deliver the new History Centre. There had also been an agreement to top up the budget to regenerate the central car park toilet facilities.

Free parking from 3pm every day continued in Salisbury and Amesbury and free parking on Sundays had been introduced.

To date approximately £5.3 million had been spent on the recovery. This was made up of £1,550,004 from Wiltshire Council reserves, £3,285,487 awarded to Wiltshire Council from central government and £500,000 awarded to Visit Wiltshire from central government. These figures were then broken down further to detail how the funds were spent, this covered response and recovery, business support and profile and promotion.

South Wiltshire was moving forward, with Boots in Amesbury being reopened, and Zizzi in Salisbury reopening. Salisbury Christmas light switch on had taken place on 15 November 2018. The Salisbury Christmas Market and Ice Rink would be open from 29 November 2018 until 6 January 2019. The Amesbury Christmas Market was due to take place on 5 December 2018. Armed Forces Weekend 2019 had been launched and was being promoted. The event would be taking place in Salisbury from 28 – 30 June 2019. The OVO Energy Cycle Tour series would be returning in May 2019.

Long term economic recovery plans included; transport improvements; developing Amesbury History Centre; the future Boscombe Down programme; a campaign to encourage tourism and increase number visitors with Visit England; the re-development of Salisbury college campus and the Royal Artillery Museum Archive at Larkhill.

A governance structure had been developed to deal with the recovery, involving the South Wiltshire Task Force (Strategic), which included Government, Wiltshire Council members and officers, Salisbury City Council, Amesbury Town Council, CLoG, the LEP, Visit Wiltshire, Salisbury Cathedral and strategic business partners. The Task Force would interact with the South Wiltshire Operation Board and various recovery cells, which were divided into pillars to

provide delivery and work streams. These would include economy, health & wellbeing, communications, tourism and culture.

In response to questions from the audience and board, Cllr Church stated that there were temporary notices up in car parks detailing the free parking after 3pm arrangements. Cllr Church would investigate the possibility of getting a large sign to be displayed in Amesbury with the details (similar to the ones on the way into Salisbury) and would also investigate the removal of the free 30 minute parking in Central Car park in Amesbury. In response to a question from a representative of the Amesbury History Centre, Cllr Church stated that her office would liaise with Amesbury Town Council and the History Centre to move plans forward for the History Centre. Cllr Church also detailed who sat on the South Wiltshire Task Force and stated that whilst it was unlikely the History Centre would be able to sit on the Task Force, it may be possible to involve them elsewhere, for example in one of the pillars, such as Tourism or Culture.

The Chairman thanked Cllr Church for the update.

#### 37 <u>Update on Boscombe Down and Economic Development in the Amesbury</u> Community Area

The meeting received an update from Richard Walters, Head of Service, Major Projects, on Boscombe Down and economic development in the community area.

Mr Walters stated he was working on several major projects in the Amesbury and Salisbury Area, including Proton Science Park, the Maltings and Central car park, the A303 and Boscombe Down, so he was very familiar with the issues and challenges in the Amesbury Area.

Boscombe Down was a strategically important 300 ha site which was managed by QinetiQ under a long term partnering agreement with DIO (a MOD infrastructure organisation). Unique facilities at the site included the longest military airstrip in the UK, the Empire Test Pilot School and the QinetiQ Apprenticeship Training School. There were currently around 1,500 jobs on site whose main focus was on maintenance, repair and the operation/testing of military aircraft. There was scope for sustainable growth in order to secure the base's long term future and to capture opportunities in the aerospace sector.

The South West of England hosts one of the largest and most significant aerospace clusters in the world, worth more than £7 billion. The South West had a strong network of world class companies and an excellent supply chain. Therefore the economic potential was huge. High value jobs create opportunities, for example 1 direct job in aerospace created 1 indirect job in the economy. The aerospace sector in the UK grew 39% between 2012 and 2017. 68% of businesses in aerospace employ apprentices and trainees.

National policy objectives had identified the aerospace and defence aerospace sector as a key potential node of growth – and Boscombe in particular as a location that was already established with core capabilities. The Council had been working with its partners on the ground at Boscombe Down – QinetiQ and the MoD in particular, to explore this potential and identify opportunities for growth.

Boeing had shortlisted Boscombe Down as a new UK centre, Wiltshire Council were working with them to move this forward. Within local policy the Swindon and Wiltshire Local Enterprise Partnership had identified Boscombe Down as an opportunity in the Strategic Economic Plan, with the potential to support the delivery of high value jobs. Wiltshire Council Core Policy 37 also supported new development and changes of use at operational facilities that help to enhance or sustain their operational capability. The focus on Boscombe Down was part of a focus upon South Wiltshire, which also involved the Porton Science Campus, the new Science Park at Porton Down, the A303 Expressway and the Salisbury and Amesbury recovery strategy.

Going forward the Council, QinetiQ and DIO all shared an ambition to modernise and grow aerospace activity at the airbase. There would be a focus on employment-led development determined through a master planning approach with the local community and the potential to support further growth in MoD operations. Wiltshire Council were committed to enhance or create a new access from the A303 to the airbase. A master plan was being developed for the whole site however work was not yet advanced enough to consult upon. However there was a commitment from all parties to share plans with the community at the earliest opportunity. Mr Walters thanked the Board for the opportunity to speak.

Cllr Fred Westmoreland stated that Porton Road, Main Road and Stockport Road provided totally inadequate access to Boscombe Down. The people who live there struggle to access Amesbury. A possible solution to this was that the work started at Solstice Park could link through to Boscombe Down. Otherwise it was felt that the new employees of Boscombe Down would add further to the already problematic congestion in Amesbury, meaning that Boscombe Down would blight Amesbury rather than help it. In response Mr Walters stated that they wanted to provide a sustainable, long term solution and that there were a number of ideas in play, which would be consulted on.

In response to a question from the Chair, Mr Walters stated that housing would be considered as part of the plan, however he could not yet give details on the masterplan.

In response to comments from Cllr Robert Yuill regarding problems accessing Boscombe Down via the main gate, it was stated that transport consultants were looking at all the issues. There were no details yet, however, they would consult on plans.

In response to questions from the Amesbury History Centre as to why funding was being provided from local sources (for example SWLEP), rather than from national sources, as Boscombe Down and Porton Down were national assets, it was stated that the Council got a 200 year lease from Porton Down to develop the Porton Science Park. The SWLEP were seeking to support the aerospace industry so that jobs and economic growth could be developed.

The Chairman thanked Mr Walters for his presentation.

#### 38 Updates from Partners and Town/Parish Councils

The Chairman referred to the updates set out in the agenda and invited further updates from Town/Parish Councils and other Partners.

#### Wiltshire Police

Sector Deputy John Hutchings gave an update. Many police officers were taking part in "Movember" in order to support Men's Health. The Police Service were making a commitment to be as visible as possible. As part of this, if people were holding events, such as coffee mornings, fetes or Christmas events and would like a Police Officer or PCSO to attend they should contact the local PCSO. There had been a slight increase in youth related violence. In response, high visibility patrols were being stepped up. The Police were working with Wiltshire Council and Highways in order to prepare for the Winter Solstice and to deal with the traditional problems associated with it. The Chairman raised complaints he'd received regarding the 101 telephone service. In response it was stated that crime communication centre in Devizes had a significant turnover of staff, for positive reasons, as employees move on to other roles within organisation. This created ebbs and flows with the ability to answer calls. More staff were needed. However it was stressed that if you call, please do not give up, as crimes needed to be reported as the police cannot react if crimes were not reported. The problems would be fed back to the communications centre. Also in response to a question from the Chair regarding Speedwatch, the Sector Deputy stated that new managers had been employed, the capacity to train people had been expanded and the reaction time was now much quicker. Cllr Graham Wright wanted to pass on his thanks to the Amesbury PCSO, Lucy Wileman. In response to a question from Cllr Wright it was stated that the new Speedwatch manager for Durrington was Sarah Holden.

#### Fire and Rescue Service

Figheldean Parish Council also wanted to pass on their thanks to Police as they had been very helpful responding to problems being encountered with strangers in the area.

#### Lovells – SFA and Army Rebasing

John Lewy from Lovells gave a brief update. At Bulford the last of the timber kits would be completed soon and the masonry wraps for these

would hopefully be completed by Christmas. During the first 2 weeks of December homes would start being handed over. At the Larkhill site far more extensive ground works had been carried out but they were progressing well now. Cllr Wright thanked Lovells, as they had managed the road very well in Durrington. Thanks were also expressed for Lovells help with the fireworks display in Durrington.

#### 39 <u>Local Youth Network Update and Youth Activities Grant Applications</u>

Cllr Darren Henry gave an update on the Local Youth Network The last meeting of the LYN had been held at Stonehenge School where they received a talk on volunteering.

At the separate LYN management meeting it was agreed that there would be an event around April 2019, to which adults involved in youth training would be invited. The best ways for the LYN management and the LYN to communicate were also discussed. There were concerns regarding Facebook, which had been the preferred method of the LYN. Advice was being sought on this matter. Whats App had been determined to be a good platform for sending pictures and a Whats App group had been set up for the LYN management group.

The applications for Youth Grant Funding detailed in the agenda were considered. The LYN had recommended all the applications. It was;

- To award Shrewton Youth Club £3,396.00 to help support their youth club for 2019.

Cllr Graeme Wright gave an update on Communities Together.

#### Dentists

It was stated that there would be no new NHS dental facility at the new Larkhill Medical Centre. The NHS had stated that they would match demand with resources and ensure that demand was met within a 15 mile radius of communities.

#### Doctors

Amesbury, Larkhill, Shrewton and Durrington had the highest population

growth in Wiltshire and Army Rebasing would be on top of existing growth. The GP practices in Durrington were too small, leading to the closure of the Shrewton practice in 2019 and the Durrington practice in 2020. There would however be a new NHS Dr's at Larkhill opening in 2019.

#### World War One Commemorative Tree Planting

Across Wiltshire almost 11,000 trees had been planted by community groups to commemorate the centenary of WWI, including several in the Amesbury Area.

#### Armed Forces Day 2019

Salisbury had been selected to hold the prestigious national event in June 2019. Events would be held across the last weekend in June and over 250,000 people would be expected to attend. Further details would be released in the new year and it was hoped that as many community groups as possible would take part.

# Frequently Asked Questions: Policing Precept Consultation 2019

#### What is the precept?

The policing precept is a contribution from local residents towards local policing. This is collected with your council tax payment and goes directly to the Police and Crime Commissioner (PCC) to allocate to the police force.

#### What are you consulting us on?

I want to know whether you would be willing to pay an extra sum per month to enable us to improve policing services in Wiltshire and recruit more police officers.

At the moment this is what you pay:

#### How is this money spent?

This money is spent on policing in Wiltshire, 98% of the PCC's budget is allocated to the Chief Constable and the remaining 2% is spent by the PCC's office on commissioning services which includes supporting victims of crime, crime prevention and restorative justice.

#### But don't you receive funding from the Government?

Around two thirds of Wiltshire Police funding comes from the Government, the rest is collected locally with your council tax.

#### Why are you asking us for more money?

I've listened when the public have said they want to see more police, and I want to enhance community policing, prevent crime from happening in the first place and enable Wiltshire to tackle cyber-crime effectively.

It's always a difficult decision to increase the precept, but it is necessary if we want more police officers. I continue to lobby the Government to provide fairer funding for Wiltshire Police, just because we live in a rural county it doesn't meant that we aren't seeing the same threats and demand as more urban forces.

#### What will change if I agree?

If residents and businesses back my proposal additional funding will be allocated to:

- Recruiting 41 extra police officers and two dedicated cyber-crime staff, with a particular emphasis on response and community policing.
- Two cyber teams (CIET and DIIU) tackling child sexual exploitation and online fraud
- Targeting those at risk of committing crime with diversionary tactics

#### **Transforming maternity services together**

A proposal to transform maternity services across Bath and North East Somerset (BANES), Swindon and Wiltshire has been shared with the general public for their consideration today, Monday 12 November.

The proposal has been developed after listening to the views of women, families and staff over the last two years by all the NHS organisations that plan and buy health services as well as those that provide or manage maternity services across Bath and North East Somerset, Swindon and Wiltshire. Together these organisations make up the Local Maternity System.

Lucy Baker, Acting Director for Maternity Services at Wiltshire Clinical Commissioning Group and Lead Director for the project said:

"Our proposal is the result of feedback gained from listening to over 2,000 women and families, staff, midwives, obstetricians and others with an interest in maternity services to look at ways we can improve the services we provide to mothers and families across the region. To do that, we need to make some changes to how we currently do things".

#### She added:

"Our proposal would allow us to provide more choice for more women across our area about where and how they are supported before, during and after the birth of their baby, and allows us to make more efficient use of our resources and workforce so we can further improve our antenatal and post-natal and birthing services. We also want to ensure we are delivering the services that can meet the changing needs of our local women and families both now and in the future.

"Despite the financial pressures facing the NHS locally and nationally, we are not planning to reduce how much we spend on maternity services, nor are we proposing to reduce the amount of staff we have or to close any buildings."

The proposal addresses the issues posed by changes to the population. The average age of a woman giving birth in the UK is now 35. More and more women are experiencing high risk pregnancies (for example, because of high blood pressure, obesity or diabetes) which means they need to be supported in a hospital setting with an expert medical team available. The combination of these factors means there is vastly increased pressure on services at the Obstetric Units at the Royal United Hospital in Bath, Great Western Hospital in Swindon and Salisbury District Hospital.

In addition, many women with a low risk pregnancy are choosing to have their babies in an Obstetric Unit because they are worried about having to move by ambulance to another site during or after their labour if they need the help of a doctor. Women need a safe, convenient alternative so staff at the three obstetric units at Bath, Salisbury and Swindon hospitals can focus on mothers who really need their care.

Sarah Merritt, Head of Nursing and Midwifery at Royal United Hospital, Bath, said:

"Some of the changes we are proposing are because, particularly at the RUH, certain services are underused and we are often staffing empty buildings and beds. 85% of women give birth in one of the three Obstetric Units with fewer than 6% giving birth across our four Freestanding Midwifery Units in Chippenham, Trowbridge, Paulton and Frome.

"We believe we have the right number and mix of staff but they're not based in the right locations to ensure efficient use of our resources and provide women with the services they need.

"In our Freestanding Midwifery Units - particularly at night - staff are covering areas even when there are no or very few births. On average only one baby is delivered every two or three days in each of these units but they need to be staffed to support births 24 hours a day seven days a week."

The plans have been developed to ensure services are efficient and sustainable to support future population growth, changes in housing policy, and the repatriation of military personnel to South Wiltshire from April 2019.

The proposal offers the following:

 To continue to support births in two, rather than four, of our Freestanding Midwifery Units across Bath and North East Somerset, Wiltshire and Swindon. Women will still be able to have their baby in Chippenham and Frome Freestanding Midwifery Units, and antenatal and postnatal clinics will continue to be provided in all four – at Chippenham, Frome, Paulton and Trowbridge as well as all other current locations e.g. GP practices.

A detailed travel impact analysis was undertaken to inform our proposal to continue supporting births in two of the Freestanding Midwifery Units.

- To create two new Alongside midwifery Units, one at Salisbury District
  Hospital and one at the Royal United Hospital, which will provide more women
  with the opportunity to have a midwife-led birth. These two units will be in
  addition to the White Horse Birth Centre that already exists at the Great
  Western Hospital in Swindon.
- To improve the range of antenatal and postnatal services, for example by
  providing more breastfeeding support to women in their own homes. We also
  want to support more women to give birth at home if this is their preferred
  choice.

- To replace the nine community postnatal beds (four at Chippenham and five at Paulton Freestanding Midwifery Units) with support closer to or in women's homes. Women who need to be admitted for medical treatment after giving birth would be treated in their local Obstetric Unit at one of our acute hospitals in Bath, Salisbury and Swindon.
- **95%** of the time post-natal beds in our Freestanding Midwifery Units are empty as women rarely need to stay in a community hospital after giving birth.
- 89 antenatal or post-natal beds are available at our Obstetric Units for women who need them

Once the public consultation has closed, the responses will be carefully and independently analysed and the results used to help the Governing Bodies of Bath and North East Somerset, Swindon and Wiltshire Clinical Commissioning Groups make a final decision by Spring 2019.

Lucy Baker said: "Our proposal is just that – a proposal. It addresses what women and staff have told us they think will work, but we want to hear people's views and encourage them to have their say.

"The consultation will run from 12 November 2018 until 24 February 2019, to enable plenty of time for people to give their views.

"We will make the consultation results available to the public and explain how their feedback has helped shape our plans. We are aiming to make our final decision in Spring 2019."

## **Background**

- We began talking to women and families in 2017 about their experiences of pregnancy, labour and birth across the counties of B&NES, Swindon and Wiltshire
- We have now worked with over 2000 women and families, plus our staff and partner organisations
- Their feedback, together with national guidance such as 'Better Births', has led to development of a proposal for future maternity services across the BSW region
- Partner organisations include Great Western Hospital Trust, Salisbury District Hospital, Royal United Hospital Bath, and B&NES, Swindon and Wiltshire CCGs



## Changing needs of our population

- The <u>average</u> age of a woman giving birth is now 35
- More and more high risk pregnancies (eg high blood pressure, diabetes, obesity) which need medical support in a hospital setting
- Clinical deliveries, such as ventouse and forceps, are not possible at Free-standing Midwifery Units, nor is epidural pain relief
- Increasing pressure on services in our obstetric units at Royal United Hospital and Salisbury District Hospital




## Right staff, right place, right time

- We don't always have right staff in the right place at the right time to offer the services women want to receive and we want to provide. This is a particular challenge for Royal United Hospital
- Staff have told us what works well and what needs to change
- We have the right number and mix of staff, but they're not based in the right locations, so we can't provide service we want to and is not efficient use of our staff
- RUH staff currently supporting births across four community midwifery units, the hospital obstetric unit and home births, 24 hours a day, 7 days a week

### Issues

- Staff too busy looking after empty beds and buildings or travelling from community hospitals with very low births to extremely busy obstetric units, often at short notice, which they dislike
- Frustrating for staff effect on morale, retention and skills
- We want to increase opportunity for home births but staff are not able to promote and support due to existing working patterns



Subject:	Polling District and Polling Place Review

The Electoral Registration and Administration Act 2013 requires Wiltshire Council to undertake regular reviews of both polling districts and polling places within its area. The Polling District and Polling Place Review is distinct from the Electoral Review of Wiltshire Council which will determine a pattern of electoral divisions.

A polling district is a geographical sub-division of an electoral area, (an electoral area being a UK Parliamentary constituency, a European Parliamentary electoral region, a parish, parish ward or an electoral division).

A polling place is the building or area in which polling stations will be selected by the Returning Officer. A polling place within a polling district must be designated so that polling stations are within easy reach of all electors from across the polling district.

The purpose of such a review is ensure that all electors have reasonably practicable facilities for voting and that polling places are reasonably accessible to electors who are disabled.

A programme of work has been scheduled to gather, analyse and consult upon relevant information and recommendations for revised polling districts. Further information is available here.

As of 7 January 2019 we have received just over 900 formal responses to the proposal document.


We attended a number of Area Board and Town Council meetings in November and December with a presentation on the proposed changes, and will continue to attend meetings in January and February.

#### Community participation in National Armed Forces Day 2019 events

#### Aim:

The project's aim is to enable communities from around Wiltshire to engage with and participate in the activities around the National Armed Forces Day event in Salisbury in June 2019 and request funding from Amesbury Area Board

#### **Executive Summary:**

The Community Engagement Manager, along with the Library Heritage and Arts Team, will work to deliver three projects that will require community involvement and provide a lasting legacy following the events.

- Social media photograph campaign as part of the event launch
- Community art tapestry project to be displayed at the event in June
- Human poppy world record attempt at the event in June

Funding will be requested from area boards to support each of the three projects as outlined below in this report.

#### Benefits:

This project directly addresses both Wiltshire Council's and the local priorities including:

- Combatting loneliness and isolation
- Improve our mental health
- Provide more activities for older people
- Provide positive activities for young people
- Improving affordable access to arts and cultural activities
- Increasing volunteering and providing skills
- Creating a lasting legacy for National Armed Forces Day 2019

#### Proposal:

 Social media photograph campaign as part of the launch of the National Armed Forces Day 2019

Community members will be encouraged to take pictures that show what the armed forces mean to them within Wiltshire, and to post them on social media sites such as Twitter, Instagram and Facebook using the hashtags #Salisbury NAFD and #Amesbury

Each community engagement manager will capture 5-10 images in their community area including a NAFD official flag.

As well as promoting the event, the images will be used to create a collage for display at the events in June. The collage design will be something that represents the armed forces and the communities support for them.

### • Community art tapestry project to be displayed at National Armed Forces Day 2019

Wiltshire Council will commission an artistic lead to work with community groups in each of the 18 community areas, identified by Community Engagement Managers, to create a tapestry, which will be combined together to form one larger piece to be displayed at the event in June. This will create a lasting legacy for the event which can be displayed around the county at Libraries, Campuses and Hub and future events.

#### Human poppy world record attempt

Community members will be encouraged to come to Salisbury on the Sunday of the weekend of events to participate in a "human poppy". This will be created by providing participants with a coloured poncho and arranging them into the shape of a poppy (see image below).

The aim of this will be to break the World Record for the largest ever human poppy which is currently 2,567 people. We aim to get between 3,500 and 4,000 people to take part. This could involve providing transport from around the county by putting on coaches from each community area to ensure the event is inclusive and anyone can take part.

In order to officially break the world record there is a significant amount of impartial monitoring required by Guinness. There will be costs involved in this and other parts of the attempt which are outlined below.

#### Project Description:

Our Hall was constructed in the early 1990s. It presently supports over 50 Beavers Cubs and Scouts plus leaders. The present floor within the main hall and lobby dates from when the building was constructed. It is a floating floor with a linoleum surface. It is well warn and cracked in places. We have received quotes and have selected one that offers good value for money. Additionally our fire extinguishers need replacing and we have been given an opportunity for replacement and servicing at regular intervals.

The George Kingshott Hall was opened in 1993 and minimal maintenance has taken place since. It is home to the boys and girls of our Beaver Cub and Scout Sections who all benefit from the life experiences offered by Scouting. We can afford £4,600 and seek your help with the remainder. We have raised £4,600.00 so far but this has taken the Group a couple of years and to get to the full amount may take a few more.
