58	Photo Competition Winners				
	The Area Board heard from Kez Hawkins on the photo competition for 11-16 year olds. 38 entries had been received, with 6 winners. Those winners in attendance were presented with a certificate recognising their success.				
	The Chippenham BID were also thanked for funding the enlargement and framing of the winning photos.

59	Sammy Sullivan Opening Comments				
	The Area Board received a presentation from Sammy Sullivan, a young person from Chippenham who had been selected for full time training in sprint canoeing and was an aspiring Olympian. She discussed the challenges she had faced and her support of her hometown, and hoped to inspire local young people to achieve their dreams.				
	The Area Board thanked Sammy for her presentation and wished her every success in her future endeavours.				
60	Dog Fouling Sign Competition Launch				
	Julie Anderson-Hill, John Quinn, Sebastian Williams and Katherine Edge, Wiltshire Council delivered a presentation regarding dog fouling in Wiltshire, providing details of the legislation, level of available fines, and that owners were responsible for picking up dog waste even if walking their dogs in the countryside, as it remained a health hazard to livestock and other animals.				
	They discussed development of the 'Green Dog Code', an initiative to educate children in schools on responsible dog ownership, communicate to the public, monitor problem areas and seek volunteers to assist the Council in managing the problem of dog fouling.				
	In particular it was stated new signs were being prepared by the Council, and a competition was being held for schools to develop more colourful and imaginative signage to focus attention on the problem. In response to queries it was agreed that there could be promotion of environmentally friendly bags.				
61	Kandu Arts Young People's Film				
	The Area Board received a presentation from Donna Lee of Kandu Arts, an organisation which over the past 20 years had been working with vulnerable young people in the Chippenham Area. She discussed a project working with some young people who had created a short film called Cuckoo, which related to the County Lines gang problems and the cases of drug dealers taking over flats to operate out of. The film would be shown in November 2019 as part of the local film festival and would be available from Kandu thereafter, and ?? urged all those present to attend and watch, as it was a raw and powerful film from vulnerable young people about some of the problems they were facing.				
62	Youth Survey Results				
	Oliver Phipps, Community Engagement Manager, presented the headline results of the annual youth survey. There had been 930 responses, roughly 20% of young people within the community area, and included specific responses from those with Special Educational Needs or disabilities, as well as those who				

	were young carers or LGBT.					
	Details were provided of levels of engagement with youth clubs and other activities, with a list of other items that were desired such as parkour facilities, skate parks and arts opportunities, and it was noted that in some cases there were developments such as permission for a new skate park in Chippenham.					
Full details were available from the Community Engagement Manag Board members and partners were asked to keep the priorities of yo in mind as they sought to help their communities in the year ahead.						
63	Mental Health Workshop					
	The Area Board received a presentation from Paul Harvey, interim Head of Leisure at Chippenham Town Council regarding a projected funded by the Area Board to provide mental health workshops for sports coaches, recognising that such coaches had strong engagement with young people and needed the skills to identify concerns regarding anxiety and depression and other mental health issues. Over 70 coaches had attended the sessions, and an example was given where a young person had been signposted to deeper professional engagement after concerns were raised by their coach.					
	The Area Board also heard from Kerry (get name from Ollie) whose son Josh had committed suicide, who spoke passionately about the importance of mental health among young people.					
	The Chairman thanked Paul and Kerry for their words, and emphasised the commitment of the Area Board to help tackle these vital issues.					
64	Rag & Bone Workshop					
	Following a session before the meeting demonstrating improvisational skills from young people, a film was played from the Rag & Bone Making Waves Youth Project showing public performance dance art taking place in the area.					
65	Future Events - Club Night and Youth Summit					
	Attention was drawn to the Youth Club Night that would be hosted by Chippenham Town Council on 1 November. A Youth Summit would also be held in 2020, it was hoped at the History Centre, and more details would be provided in due course.					
66	Community Partner Updates					
	Jerry Herbert, Deputy Police and Crime Commissioner, provided an update to the Area Board. It was noted that Wiltshire was one of only 7 areas which had seen a decrease in crime over the past year overall. 41 new officers had been recruited, with a stable number of community support officers. He emphasised that community policing was at the heart of how the police in Wiltshire served					

	local people, and noted recent national comments on police numbers, and that it was intended to recruit over 100 more officers next year.							
	An update was also received from Ash Gray, Community Coordinator, discussing County Lines and bike thefts. Free bike marking kits would be made available on 30 October between 4-7pm.							
	In response to queries Mr Herbert stated mental health for officers was of high importance to both the Chief Constable and Police and Crime Commissioner, and the occupation health team of the Wiltshire Police was highly commended nationally. It was also confirmed that if someone came across an abandoned bike which had been stolen they could return them to a police station.							
	The written report from the Fire and Rescue Service was noted, and that around £250 had been raised by a community car wash.



#### Devolution

On 1st June 2019 a considerable amount of assets were transferred to the Town Council from Wiltshire Council under the process of devolution. History shows that prior to 1974 Chippenham enjoyed ownership of these assets but after that date the creation of a District Council network took these and many services away from the town. Wiltshire Council then inherited these in 2009 when the unitary system of local government was created - and now the process has gone full circle. The devolution of various services also went live in June but this transfer will not be fully completed until the contract between Wiltshire and Ide



Verde, the external contractor, ends in June 2020.

#### **Monkton Park**

General grass maintenance is continuing in Monkton Park and a tree survey is currently being undertaken. There are continuing issues with rough sleepers, vandalism and anti-social behaviour but we are working with the relevant agencies to manage this.

#### Road Sweeper naming competition

The current road sweeper is out in Chippenham Monday - Friday and in the High Street twice per week at 6am. We are awaiting delivery of an 18 Tonne Road Sweeper which will be delivered in the autumn and we would like to give it a name. Wiltshire Council has launched a new reward campaign to prevent fly-tipping in the county.

# The We're Targeting Fly-tippers (WTF) campaign aims to combat the scourge of fly-tipping by offering residents a reward of up to £200 in high street vouchers if they report information that leads to the successful prosecution of an offender or the payment of a Fixed Penalty Notice (FPN).

If anyone has any information about fly-tipping in Wiltshire, they are requested to report it using the My Wiltshire app with as much information as possible. If this information leads to a successful prosecution or payment of a Fixed Penalty Notice, the person who reported it will earn a voucher of up to £200.

We want residents to provide information as possible, such as where the fly-tip is, the registration and make or model of the vehicle they saw, plus any description or photographs of the alleged fly-tippers. However, it is essential that people do not attempt to confront anyone who is fly-tipping or put themselves in danger in any way. We also ask people not to try to rummage through or disturb the waste, as this could affect the scene and put people in danger.

Fly-tipping costs Wiltshire Council more than £180,000 each year, it is unsightly and it is a danger to people, wildlife and the environment.

In Wiltshire, most fly-tip reports are of a commercial nature, where waste is cleared for a fee and then dumped to avoid lawful disposal costs. Penalties for offenders include an unlimited fine and/or five years' imprisonment; a £50,000 fine and/or 12 months' imprisonment; or a FPN of £400 if they are caught fly-tipping small-scale waste.

The council has received notification from BT regarding consultation on its current programme of proposed public payphone removals. The relevant Area Boards should be aware of the affected payphones in their local community, by referring to the detailed enclosed sheet.

There are currently 71 public payphones with low usage levels and BT propose to remove them following a full consultation. BT has also placed consultation notices in the relevant payphone kiosks.

As the local authority, we are required to carry out our own consultation process to canvas the views of the local community. Briefing Note Number 19-033 has been circulated to Wiltshire Councillors and Town and Parish Councils.

Consultation has been initiated to receive reasons for any objections to the removal of specific phones, as a blanket objection is unlikely to carry weight.

BT offers the opportunity for parish councils and registered charities to \*adopt a kiosk for just £1, thereby protecting the heritage of the community.

### Wiltshire Council shall be undertaking a Community Governance Review in certain areas beginning on 1 November 2019.

Community Governance Review (CGR) is a process to provide opportunity to review and make changes to governance arrangements to town and parish councils. This is to ensure that they continue to be reflective of the identity and interest of local communities, and that they are as efficient and effective in their governance as can be.

From 12 July 2019 Wiltshire Council contacted town and parish councils requesting expressions of interest for any changes to governance from parishes. Expressions received were circulated to any potentially affected parish council.

At its meeting on 31 October 2019 the Electoral Review Committee approved terms of reference for a Community Governance Review to be commenced on 1 November 2019, to include the following areas:

- Trowbridge, Hilperton, North Bradley, Southwick and West Ashton
- Salisbury and Netherhampton
- Chippenham, Chippenham Without, Kington St Michael, Lacock and Langley Burrell Without
- Melksham, Melksham Without and Seend
- Derry Hill and Studley (proposed new parish)
- Wilcot (and Huish), Manningford, Woodborough and Pewsey

Warm and Safe Wiltshire is a single point of contact cold homes and energy saving advice service set up specifically to assist the health service in Wiltshire. The service is run by the Centre for Sustainable Energy (CSE), an independent charity, on behalf of Swindon Borough Council and Wiltshire Council.

The service provides a range of support both over the phone and through home visits. The telephone advice line is available to all residents and provides support which includes information about insulation and heating, guidance on heating systems, advice on understanding energy bills, help with ensuring a client is on the best energy deal, signing residents up to the Priority Services Register and fuel debt support.

Home visits are provided on a case-by-case basis and are especially useful where issues are challenging or difficult to discuss and support over the phone. As a guide, householders should have a vulnerability, such as an older occupant, low-income or health condition(s), to receive a home visit.

Wiltshire Community Foundation administer a Surviving Winter grant of £300 per person to help vulnerable residents pay for winter costs.

Warm and Safe and Age UK are the referral partners who can help clients complete the application form process and compile the necessary evidence for Wiltshire Community Foundation to make their decision.

The grant is administered on a first-come-first-served basis and it is in two rounds this winter. It should be noted that funds are limited.

- Round 1 opened 21 October and is open until 13 December 2019 (Please note Warm and Safe have allocated all grants in this round but are adding clients to a waiting list for round 2)

## Chippenham BID Statement 02/12/2019

Chippenham BID is a business representative organisation that began on 1st April 2015 after a successful ballot in which every business who would be liable to pay the Chippenham BID levy was entitled to vote. BIDs have a 5 year life and in order to be renewed they need to be voted in again by the businesses liable for the BID levy. Chippenham BID undertook a renewal ballot in October and November 2019 and unfortunately the result, although close with a 47%/53% split, was against the BID continuing into a second term. This means that Chippenham BID will close by the end of March 2020.

Over the last 5 years, Chippenham BID has delivered a range of projects to support the business community who fund it. Business to business projects include a cost reduction project that has identified savings of over £100,000 for Chippenham businesses, a mystery shopper programme, Pubwatch administration, a subsidy for businesses wanting a Christmas tree, networking events, an online exclusion scheme for use in business crime reduction and promotion of levy paying businesses on the BID's social media and website, Chippenham Connected. Recently Chippenham BID has initiated a town centre worker discount scheme and supported the installation of ShopAppy, which gives small and micro businesses the chance to have an online presence without having to set up their own online shop. Chippenham BID has also delivered the Chippenham Business Awards since 2017, which has quickly become Chippenham's biggest B2B event and it funded the free town WiFi and footfall counters, as well as the refurbishment of a public toilet that would otherwise have closed.

Chippenham BID also invested heavily into a public events programme, which it delivered in partnership with Chippenham Town Council. The events programme saw the resurrection of Chippenham Carnival after an absence of 16 years, the introduction of Chippenham Soap Box Derby and the growth of the Christmas light switch-on event. It also saw events such as the outdoor cinemas, chilli fiesta, steampunk festival, summer garden and Easter events. In addition, Chippenham BID sponsored other local events such as the Folk Festival and the Rotary fireworks night.



## Force-wide

- Wiltshire Police has had an increase in the volume of recorded crime by 1% in the 12 months to September 19 and continues to have one of the lowest crime rates in the country.
- Our service delivery remains consistently good.
- In September, we received 8,312 999 calls which we answered within 6 seconds on average and 12,474 CRIB calls which we answered within 2 minutes 08 seconds on average.
- In September, we also attended 1,344 emergency incidents within 17 minutes and 00 seconds on average.
- Wiltshire Police has seen a 17% reduction in vehicle crime and 21 per cent in residential burglaries in the 12 months to September 2019.
- The Crime Survey of England & Wales recently ranked Wiltshire as one of the top forces (78.3%) nationally for public confidence. It covers the 12 months to March 2019. The publication can be found here: <u>WWW.CRIMESURVEY.CO.UK</u>



## HIGH LEVEL PCC UPDATES

- **Recruitment** Police officer recruitment continues with more than 500 applications received so far since the campaign launched on 23 September. Wiltshire Police is accepting applications until Sunday 13 October.
- **Community work** In September PCC Angus Macpherson awarded a total of £22,500 from the Police Property Act to projects across the county which make a difference in their communities. Beneficiaries include a drop-in service for homeless people, a 12-week personal development course for unemployed young people and a pilot project using photography to engage with young people at risk of offending or exploitation. Full details are available on our website.
- Herbert Protocol The PCC was proud to join Wiltshire Police, Swindon Borough Council, healthcare partners, Swindon Carers Centre and the Alzheimer's Society at the launch of the Herbert Protocol last month. It comprises of a document in which carers, family and friends of vulnerable adults can fill out key details about the individual as a pre-emptive measure in case they later go missing. This will enable the police to start their initial enquiries sooner with the aim of finding the missing person safe and well.

## HIGH LEVEL FORCE UPDATES

- **County Lines** The issue of gangs transporting Class A drugs from major cities such as London and Manchester into rural counties, is one which is attracting significant media attention. Here in Wiltshire we are raising awareness of the problem, and specifically the impact these crimes have on the wider community, as they are often linked to modern slavery and organised crime, with children and vulnerable adults being exploited. Please look out for local media coverage, or go to our website for more information.
- **Domestic abuse** This month we are highlighting the work Wiltshire Police is doing to tackle domestic abuse, including educating the public about the support that is available for victims. This campaign will include a young mother, who has been the victim of domestic violence, speaking out about her story in the hope that she can encourage other victims to come forward and get support.
- **Rural crime** During the beginning of October we are taking part in a national week of action targeting rural crime. Our work will include providing crime prevention advice and encouraging residents to report all incidents to the police, as well as having our Community Policing Teams and the Rural Crime Team out and about engaging with our rural communities.








## Crime count by crime group

The Healthwatch Wiltshire survey will look at how well this new service is working and identify any areas that could be improved.


