85 Welcome

The Chairman welcomed those present to the meeting and invited the councillors and officers present to introduce themselves.

87 Minutes

89 Grant Feedback - South Western Ambulance Charity

90 Chairman's Announcements

The Chairman made the following announcements:

New Fly-Tipping Campaign – We're Targeting Fly Tippers

The new We're Targeting Fly-tippers (WTF) campaign was announced. The campaign aimed to combat the scourge of fly-tipping by offering residents a reward of up to £200 in high street vouchers if they report information that leads to the successful prosecution of an offender or the payment of a Fixed Penalty Notice (FPN). Email peter.white@wiltshire.gov.uk with as many details as possible to report fly-tipping.

• British Telecom Proposed Payphones Removal Consultation

The council had received notification from BT regarding a consultation on a programme of proposed public payphone removals. BT proposed to remove payphones with low usage levels following a full consultation. Wiltshire Council would also carry out a consultation. Responses received by 14 January 2020 would be included in our return to BT. Please see the agenda report for full details and email Mary Moore, Economic Development and Planning, on mary.moore@wiltshire.gov.uk to comment. The Chairman noted that parish councils and registered charities could adopt a kiosk for £1.00. Uses for these kiosks could include mini libraries, or a space for a defibrillator.

Community Governance Review

Wiltshire Green Pledge

Earlier this year Wiltshire Council pledged to be carbon neutral by 2030, and its councillors had agreed to seek to make the county of Wiltshire carbon neutral by 2030. To help with this, The Green Pledge had been launched which was asking people to commit to making small changes that could have a big positive impact on the environment. • National Grid VIP Project

The Chairman announced an exciting new project in the Devizes Area. The National Grid was currently in the early stages of developing a landscape enhancement project in the North Wessex Downs. The project

would involve the removal of approximately 4km of high voltage overhead electricity line, and associated pylons, near to the Millennium White Horse, north of Devizes, and subsequently replacing it with underground cable.

The project was still in the early stages of development and National Grid was undertaking a range of ecological, archaeological and ground investigation surveys as well as meeting with local stakeholders to discuss their plans and their potential to transform this special landscape.

Given the rich archaeological heritage of the area, National Grid was working closely with local archaeologists, the Wiltshire County archaeologist and Historic England to devise the best route to bury the cables.

There would be public drop-in events in the new year where National Grid would share more information on its plans with the wider public and local people would have the opportunity to feed back their thoughts.

The Visual Impact Provision (VIP) makes use of a financial provision from the energy industry regulator, Ofgem, to deliver landscape enhancement initiatives in Areas of Outstanding Natural Beauty (AONBs) and National Parks to mitigate the visual impact of overhead transmission lines.

Further announcements about this project would be given at future area board meetings.

91 Partner Updates

Cllr Philip Whitehead arrived at 6.41pm.

Written updates were available in the agenda pack from Wiltshire Police, Dorset & Wiltshire Fire Service, Healthwatch Wiltshire and the CCG.

In addition to the written updates, the following verbal updates were given by the partners present:

Wiltshire Police

Acting Inspector Pete Foster directed the meeting to the written report in agenda pack. In addition he announced that several arrests had been made recently for offences including the theft of lead from St James' Church roof and for possession with intent to supply.

A knife amnesty (Operation Sceptre) had taken place which was very successful. Although Devizes did not have an issue with knife crime, many knives had been handed in.

Devizes Police had also been focusing on Rural Crime, trying to tackle offences like hare coursing and theft.

Office of the Police and Crime Commissioner (OPCC)

PCC Angus Macpherson drew people's attention to the updated Police and Crime plan which was available on their website (https://www.wiltshire-pcc.gov.uk/). The annual report on policing in the county for 2018/2019 was also available on the website.

Wiltshire Police had been recruiting heavily. There were over 500 people being assessed. There were 40 people training to be officers at the current time and 20 more joining after Christmas. It was explained that it took time to recruit and train officers as they received around 22 weeks training and then a year's further on the job training.

The PCC highlighted the Herbert Protocol detailed on page 41 of the agenda pack, which consisted of a document in which carers, family and friends of vulnerable adults can fill out key details about the individual as a pre-emptive measure in case they later go missing. This would enable the police to start their initial enquiries sooner with the aim of finding the missing person safe and well. The PCC requested that people promote the protocol.

In response to questions it was stated that unfortunately knife crime was part of 21st century living, however the police were not complacent. Police fire arms teams were moving back under Wiltshire Police control and once this had happened there would be more education and prevention work undertaken. The force was also looking for PCSO's to work educating youths. They wanted the important message that most people who are hurt by knives are also knife carriers to reach young people.

Cllr Laura Mayes also stated that there was a Community Safety Partnership where multi-agency work was undertaken to do contextual safeguarding to protect vulnerable people. The reverend of St James' Church stated that Amnesty bins were headline grabbing but work went on all year round to prevent knife crime.

Schools updates

Phil Bevan, Head teacher, Devizes School welcomed those present to Devizes School and advised that there was a lot of building work being undertaken at the moment. He gave a brief update on behalf of Georgina Keily-Theobald, Head teacher, Downland School. Downland had been expanded and could now take around 90 students. It was a Special Education Needs (SEN) School and was now fully co-educational, taking boys and girls with SEN.

Lavington School and Devizes School were holding a combined open evening for 6th formers at Devizes School. Both head teachers had also been to Dauntsey's School to see how they could all work together

Devizes School had hosted a Remembrance Service, with around 1,400 people attending. It was a fantastic service and had been a good opportunity for young and old to mix.

Devizes School was also running a café after school for young people, with table tennis, activities and mentors. This ran on a Monday and Thursday evening.

Mark Lacselles, Head teacher, Dauntsey's School stated that they were running a primary school partnership which involved a lunch for older and vulnerable people.

Town and Parish Councils

Simon Fisher, Devizes Town Council Clerk gave a brief update to the meeting. The asset transfer was progressing with all services transferred, apart from the Market Place. Suggestions for this had been out for consultation. The current proposal was to have a 50/50 split between parking and community space, with some flexibility to adjust this depending on circumstances. In principal this had been accepted by Wiltshire Council. Cllr Philip Whitehead stated that once the Market Place was transferred to Devizes Town Council it would be owned by Devizes Town Council and Wiltshire Council would lease back the area for parking. The proposed flexibility in the area used for parking was difficult as you had to have defined liability so that people were protected. Wiltshire Council solicitors were currently working to find a solution to this issue.

The Chairman thanked everyone for their updates.

92 Anti-Social Behaviour

The board received a presentation from Rowena Lansdown, Wiltshire Council Anti-Social Behaviour Officer.

The officer explained that the Anti-Social Behaviour (ASB) team sat within the Public Health Directorate and was part of the Vulnerable Communities team. The makeup of the team was explained. People could contact the team on asb@wiltshire.gov.uk.

ASB was defined as "conduct that has caused, or is likely to cause, harassment, alarm or distress to any person".

The team undertook this work partly due to cases like the Fiona Pilkington case in 2007. For over 10 years she had suffered from ASB and her disabled daughter was mocked. She had reported this to different agencies, but the agencies were not communicating, there had been a failure to link incidents and to identify social needs. Unfortunately, she took both their lives because of the impact of the ASB. Now all the relevant agencies had regular conferences to prevent this happening.

Actions taken when ASB was reported included; meeting with victims and issuing log sheets, completing a risk assessment matrix, referring the victim to Victim Support; referring the case to the Anti-Social Behaviour Risk Assessment Conference (ASBRAC); monitoring the case and taking appropriate action and only removing the case from ASBRAC when agencies were satisfied that it was resolved.

The ASBRAC concept was recommended by the Home Office as good practice. Wiltshire's ASBRAC was governed by the Community Safety Partnership and was made up of agencies such as the Police, Council, Fire, Housing Associations and others. They involved multi agency meetings that had the wellbeing of victims at heart. They provided a forum for sharing information and assigning actions. ASBRAC was outcome driven with a focus to safeguard the victims and reduce the anti-social behaviour from the perpetrator. For example, an acceptable behaviour contract may be agreed with the perpetrator. If the perpetrator had issues themselves, for example substance abuse, mental health issues or housing problems then they would also get relevant agencies to attend.

No single agency had sight of the full situation but may have crucial information about the individuals involved which assisted with agreeing appropriate actions.

If all the actions taken failed to resolve the situation they could take enforcement action. Enforcement options included: Criminal Behaviour Orders; ASB Injunctions; Closure Notices/Orders; Community Protection Warnings; Community Protection Notices and Absolute Grounds for Possession.

In 2018, through ASBRAC they supported 140 victims and issued 6 Community Protection Warnings, 1 Injunction and 6 Closures.

In response to questions it was stated that most of the ASB in Devizes was related to drug and alcohol abuse. The drug abuse was not in the form of County Lines. The ASB team also dealt with problems relating to homelessness. The number of ASB cases reported seemed to be rising. However, this was thought to be as a result of increased reporting. People could see the reporting cases to the ASB team worked. It was not thought that there had been a large increase in ASB cases. The team could use more resources, there used to be 5 ASB officers and were now only 2. The rough sleeper team offered all rough sleepers a place. Not all homeless people wanted to engage with the team, often the place they were offered was not what they wanted or where they wanted. However, all were offered a place and the rough sleeper team tried hard to engage with them. The officer encouraged people to report ASB to either the police or the ASB team. The team would look into issues raised regarding the Sheep Street problem, which had been thought to have been solved, but may have just moved to the woods.

The Chairman thanked the officer for her presentation and hard work.

93 CCG - Update on Devizes Health Centre

The Chairman announced that this item had been withdrawn from the agenda and would be coming to the next area board in January.

Cllr Mayes stated that there was informal feedback that the project should be happening in the next couple of years, hopefully with ground being broken for building works next year.

Several members of the public expressed their disappointment that this item had been withdrawn from the agenda and in the delays in getting this project off the ground.

It was explained that the NHS were responsible for this project, rather than the council. However, councillors were working hard behind the scenes to try to move the project along.

94 Wiltshire Council - Focus on the Future

The Chairman announced that the Focus on the Future meetings, where local residents could join the councils senior leaders to discuss the services that the council provides and its plans for future years, had been postponed due to the General Election. The Devizes event was now due to take place on Thursday 16 January 2020, 5.30pm at the Devizes Hub and Library. All were welcome to attend.

95 **Open Floor**

The Chairman invited questions from the floor.

A resident of Great Cheverell stated that she was extremely worried by the large volume of traffic through the village and particularly the large number of big lorries. This seemed to have increased since the railway bridge had been lowered. There was no pavement on some sections of road and the speaker had herself been knocked over by a car, although thankfully had not been hurt. It was stated that action should be taken to make things safer before someone did get hurt.

Cllr Richard Gamble stated that he was aware there was a problem there and he had seen the photographs she had sent in. He also stated that he was glad she had not been hurt when she was knocked over. It would be useful if they could get the parish council to report the issue formally to the CATG, so they could look at it. However, it would be a very difficult problem to solve.

Cllr Philip Whitehead explained that it was Network Rail who had lowered the bridge in order to reinforce it, so that trains could continue to run. In response Wiltshire Council had lowered the road underneath as much as was possible. They were trying to encourage HGV's to use other routes.

One idea was to ask central government to get HGV's to use special sat nav's which only showed them routes suitable for HGV's. This would solve a lot of the problems. However, this would have to be up to central government to implement.

Mr Michael Maxwell, expressed his concerns regarding the Black Dog crossroads on the A360 near Devizes. He explained that he had written to Cllr Bridget Wayman, Cabinet Member for Highways to highlight his concerns that someone may die at the junction if no action was taken. An article had also been in the Gazette and Herald regarding the issue. Black Dog crossroads was

currently ranked 94th out of 118 priority spots in Wiltshire. He stated that accidents seemed to be rated on severity of injury, however, he felt that all accidents should be taken into consideration.

In response Cllr Philip Whitehead stated that every single accident reported to the police was reported to Wiltshire Council Highways. He did sympathise and agreed with some of the arguments raised. However, the council had to prioritise and undertake works in order.

Cllr Richard Gamble stated that CATG would look at the issue.

The Chairman thanked everyone for their comments.

96 Community Area Transport Group (CATG)

Cllr Richard Gamble, Chair of CATG, updated the meeting. He directed people to the minutes in the agenda pack and stated that the last CATG meeting had been extremely well attended. There was a lot on the agenda. In order to progress items through the system the CATG operated a scheme whereby 5 issues were given the highest priority. There were currently 9 issues in the top 5 priority section. The budget for CATG was extremely small to deal with all the issues raised and the possibility of delivering all through CATG was unrealistic. Cllr Gamble was going to look at ways of addressing this. He encouraged all those with issues to contact him and attend CATG.

97 **Air Quality**

Cllr Richard Gamble updated the meeting. Air Quality and Transport Strategy meetings were now being held after CATG meetings as there was some overlap in Highways issues.

There was the opportunity to look at issues such as public transport and cycle lanes. Hopefully reducing carbon emissions and improving air quality.

98 <u>Local Youth Network</u>

A representative from Devizes Outdoor Celebratory Arts (DOCA) updated the meeting on the success of last year's carnival and spoke in support of their current grant application.

The Board considered the application and it was;

Resolved:

• To grant Devizes Outdoor Celebratory Arts (DOCA), £4,983.00, towards their Carnival Incubator Intensive Workshop project.

99 **Health and Wellbeing Group**

Cliff Evans, Chairman of the HWBG gave an update to the meeting. Devizes had held 2 health and wellbeing days over the past two years and plans were being made for next year's health and wellbeing day. These events had previously been held on the small green, the group were looking at the possibility of moving the event into town, possibly in the Market Place in order to take advantage of the increased footfall. Plans would be finalised in the new year and the group were also looking at the possibility of increasing the event to more than once a year.

A very late grant application had been received, which involved requesting £250.00 towards an Xmas Shin Dig for disadvantaged, lonely and vulnerable people. This was to be held at St James' Church on 6 December. The application had been received too late for it to be considered by the board. However, as the application was time sensitive it was agreed that this could be looked at under delegated powers in between meetings.

The Chairman thanked Cliff for the update.

100 Community Engagement Manager Update

Andrew Jack, Devizes Community Engagement Manager, gave an update to the meeting. If anyone wanted to contact him, his details were: Tel: 01225 713109, Mobile: 07769 917270. Email: andrew.jack@wiltshire.gov.uk.

A successful careers day had been held at Devizes School on 2 October, with around 20 local employers and 180 students from years 12 and 13 attending. Another event was being planned for year 10 students on 12 December. This event was to be more of an introduction to work, giving students the chance to talk to people and employers regarding the training, qualifications and experience required for certain roles. Along with the opportunity to think about interviews and first impressions.

A summary of grant funding provided by Wiltshire's 18 Area Boards over 2019/2019 was detailed. £1,141,326 was given out in total. In the Devizes Community Area 42 grants had been awarded with a total value of £78,307. If people were interested in applying for a grant they could contact Andrew for advice.

The Devizes Assize Court Trust DACT purchased the Grade II Listed Building in 2018 so that it could be rescued and restored as the new home for the Wiltshire Museum. DACT is about to appointing architects and is seeking support to enable them to begin developing plans for the building. Alongside this DACT will work in

partnership with the Wiltshire Museum on a community history project to record how the court was used and scan photographs and documents that people may have. This will be brought together on a website and support the development of displays at the building.

The Youth Adventure Trust works with disadvantaged young people aged 11-14 from Wiltshire and Swindon. The programme is a combination of three residential camps Mountain Forest and Coastal and eight activity days. It lasts three academic years and uses the Power of the Outdoors to transform their lives. We would like funding towards the cost of purchasing vital equipment for the existing young people and the new stream of young people from Devizes School participating in our camps and activity days.

Input from Community Engagement Manager:

Six young people from Devizes School are confirmed on the new intake onto the outward bounds course from Youth Adventure Trust. This is the first time the Trust has worked with young people from this area (and also Calne and Pewsey) so need to purchase new equipment to cater for this increase in numbers taking part. This award will allow these six local young people to engage in the three-year course and benefit from the personal development it brings.
