



#### **Re-allocation of Road Space**

I thought it would be helpful to write to you to update you on the current position regarding the Reallocation of road space project.

An initial announcement was made by central government on 9th May in relation to the reallocation of road space with local authorities being asked to identify and deliver schemes that gave greater priority to pedestrian and cyclists. In response you will recall that the Council formed multidisciplinary teams of officers for each community area tasked with identifying potential locations where action would be helpful. In addition, members of the public, stakeholders, partners and other organisations were invited to put forward their own suggestions. All suggestions were subject to assessment in line with government guidance to identify a priority list for design and implementation.

At that early stage there was an assumption that funding for the delivery of all the identified schemes would be provided by the Department for Transport through their Emergency Active Travel Fund

Further information from the Department for Transport (DfT) was received on the 29th May and the 10<sup>th</sup> July indicating that the funding would be released in two tranches, the first for pop up cycling schemes on routes that offer an alternative to using public transport and the second for meaningful schemes that reallocate road space to cyclists and pedestrians with a clear level of segregation or closure to traffic. Indicative funding levels for Wiltshire were £227,000 for tranche 1 and £908,000 for tranche 2.

A bid for the tranche 1 funding was successful and the identified schemes are in the process of being delivered. A bid for the tranche 2 funding is currently being put together and will be submitted in early August.

In addition to the Emergency Active Travel Fund the government has also made funding available through its Reopening the High Streets Safely Fund, for which the Council has received £449,858. We have been able to use some of this for highway purposes but there are clear and strict requirements on the use of this funding which must relate directly to the need to support local business recovery.

What has become clear is that there is no readily available funding stream for the delivery of the smaller scale 'pop up' social distancing measures of which we have had many requests. I therefore propose to allow the Community Area Transport Group's (CATG's) to use the Discretionary Highways budgets allocated to them to fund social distancing schemes if they so wish. It will be for the groups to consider and prioritise social distancing schemes alongside other received requests. In order to facilitate this, I have asked the engineering staff that support the CATG's to share the list of approved suggestions and restart the wider CATG activities.

Whilst it is disappointing that a separate funding stream is not currently available for social distancing schemes the Council will continue to seek alternative funding for this, but in the meantime the CATG's should consider whether any of the identified schemes are priorities to implement with their own funding.

To provide detached street-based youth work in Calne. This will provide young people with opportunities to engage with professional youth workers for support advice and mentoring. It will				

cover the period in which indoor youth activities may be hard to achieve and will help to build relationships with young people to help assess the needs and gaps in their social and educational development that may be supported through local community action especially in relation to Covid 19 recovery.

#### Input from Community Engagement Manager:

This is an application to the Positive Youth Activities fund.

The project will support the needs and priorities of young people by helping to address their requirements for advice mentoring and signposting to other sources of support.

As the Covid-19 lock down period lifted and young people started to be able to gather outside but were still not back at school the Town Council and Area Board have been able to provide some temporary street based youth work to give young people the opportunity to talk about the things that are worrying them and make sure that they understand the need and rationale for new social distancing rules with trustworthy adults who are able to provide appropriate support and advice and signposting.

The temporary period has been in place for approx. 2 months and has been well received by young people and the wider community. It has proven the value of street-based work in engaging with vulnerable young people in the community and encouraging them to become more involved and included in community-based activities. While it is hoped that the provision might eventually develop to provide a youth cafe style provision in the town centre it is also felt that the continuation of detached youth work is relevant and necessary as part of a Covid 19 recovery plan.

Funding will enable detached youth work to continue 1 session per week until the end of the current financial year.

The current provider links closely with many other youth providers and can advise and help implement focussed activities as they become required e.g. Counselling services Drug and alcohol awareness groups.

Town Council officers have worked closely with the Community Engagement Managers and the Wiltshire Police Youth Engagement manager to develop this joined up youth focussed provision and all share knowledge and information that will enable the continuation of this work to the most beneficial ends for young people.

The project will be run under a service level agreement entered into between the provider and the Town Council in consultation with the Area Board this agreement will comply fully with all safeguarding requirements and will be available for inspection prior to the arrangement being signed off.

This application can be linked to Calne Area Board JSNA priorities for young people relating to: Mental and Emotional Health and Educational attainment. It also links to wider community priorities linked to social isolation and loneliness, support for carers, mental health, and healthy life styles.

An award to this application would represent 50% of the total project cost.
