COVID-19

The infection rate in Wiltshire remains low, but we cannot be complacent and it's important that everyone continues with their great efforts so far to follow social distancing measures and maintain good hand hygiene.

The advice for everyone remains the same:

- Keep washing hands regularly
- Wear a face covering over the nose and mouth in enclosed spaces
- Stay at least a metre away from people not in their household

If anyone is experiencing COVID-19 symptoms, no matter how slight they may be – a high temperature, a new, continuous cough or a loss or change to your sense of smell or taste – isolating and getting tested should be done immediately.

As a reminder, the isolation period is now 10 days. Those living in the same households should self-isolate for 14 days if they, or any members of the household, receive a positive test. Staying at home means not going out for any reason, including to work, or to the shops.

We thank everyone for their continued support and for playing their part.



Connect 5 aims to improve population mental wellbeing by changing the way we have mental wellbeing conversations.

Connect 5 is offering an incremental three-session training programme about mental health and wellbeing. The programme is free of charge and available to community groups and individuals who have a role in supporting mental wellbeing.

The programme has been developed by academic, clinical and public mental health experts in partnership with Health Education England and Public Health England.








Force Area CPT – Highest Crime Groups (Previous 12 months)

PERFORMANCE – FORCE-WIDE

- Wiltshire Police has had a decrease in the volume of recorded crime by 5.8% in the 12 months to July 2020 and continues to have one of the lowest crime rates in the country.
- Our service delivery remains consistently good.
- In July, we received 8,974 999 calls which we answered within 8 seconds on average, 13,513 101 calls which we answered within 28 seconds on average, and 14,975 CRIB calls which we answered within 2 minutes and 19 seconds on average.
- In July, we also attended 1,899 emergency incidents within 10 minutes and 8 seconds on average.
- Wiltshire Police has seen an 8.2% reduction in vehicle crime and a reduction of 17.8% in residential burglaries in the 12 months to July 2020.
- The Crime Survey of England & Wales recently ranked Wiltshire as one of the top forces (78.3%) nationally for public confidence. It covers the 12 months to March 2019. The publication can be found here: WWW.CRIMESURVEY.CO.UK

LOCAL PRIORITIES – ROYAL WOOTTON BASSETT

UPDATE
We are experiencing some issues with a small minority of the community that upset our neighbourhood with their behaviour. This is particularly prevalent in the area of Malmesbury. We have identified some key areas which will see an increase in high visibility Policing (Pulse Patrols). Officers and staff will also be seeking to identify long term opportunities to get to the root of the issues that cause these type of offences. This includes working with partners and sign posting individuals identified to productive activities.
Our Pulse Patrols are a really effective way of tackling crime hotspots. They work by flooding a specific area with uniformed officers to engage with the public and deter further problems. Research has shown that just 15 minutes of officers being out of their vehicles and present in an area can have a significant impact in reducing crime.
We are monitoring some small businesses that have come to notice.

HIGH LEVEL PCC UPDATES

- PCC Annual Report: Last month, the Police and Crime Commissioner published his annual report for 2019/20. The report sets out how the OPCC priorities are being met and highlights what additional work is being carried out to ensure that wider policing priorities reflect the concerns from the Wiltshire and Swindon communities he serves. You can read the full report <u>here</u>.
- Frontline recruitment is on track: Wiltshire's first 40 student police officers on the new police degree apprenticeship are nearly half way through their initial 23 week classroom training before deployment to Community Policing Teams in December. The next cohort of 20 students start their training on 19 October and by March 2021 we are on target to have 1,050 police officers in Force. We also welcomed 20 new student Police Community Support Officers (PCSOs) who started their 12 week training in August and we've had a huge response to our PCSO recruitment campaign in July with 179 applicants, a record level of interest in this important community facing role.
- COVID19 update: We continue to be impressed by the high levels of compliance with the current restrictions within our communities. Although officers have not issued any Fixed Penalty Notices for breaches to these restrictions since May, we remain fully committed to being transparent when it comes to enforcement. The OPCC is also in the process of distributing the new COVID19 Response Fund a £50,000 funding stream supporting community and voluntary groups that are struggling to keep their organisation going or are facing unexpected costs due to the Coronavirus pandemic.

HIGH LEVEL FORCE UPDATES

- Officer and staff assaults review: The views of more than 40,000 officers and staff have informed the Officer and Staff Safety Review published by the National Police Chiefs' Council (NPCC) last week. The review, which is the largest ever survey of the police workforce, was commissioned to examine why police forces are seeing a rise in assaults and increased violence against officers. Here in Wiltshire, we are not immune to assaults against our frontline officers, staff and volunteers and this is something we have seen increase year on year. Even as our officers and staff have been out in our communities trying to provide reassurance during the COVID pandemic, they are still being kicked, spat at and abused. We've already introduced a large number of improvements to best protect our staff including the introduction of spit and bite guards and increased the number of officers who carry taser but this is also a societal problem that needs to change. We welcome this review and will continue to invest in anything which protects our officers and staff.
- **COVID19 update:** We are pleased to report that we are still seeing a very high level of compliance within our communities with regards to the Coronavirus Regulations. Our officers

continue to focus on engaging with our communities first and foremost and, for the most part, this continues to be effective. The Government has now brought in tougher penalties for those who do not wear face coverings in areas where it is now mandated to do so and for those who organise, facilitate or attend any large gathering or unlicensed music event. These types of unlawful events place the public at a high level of risk and are likely to spread the virus. If we come across these types of events we will actively look to use our powers. Coronavirus remains a deadly threat and it should be everyone's priority to stop the spread of the virus and save lives.

• **Demand campaign**: The lifting of lockdown restrictions in July heightened some of the demands Wiltshire Police face, particularly those related to public order, violence against the person and anti-social behaviour. In comparison to last summer, we are seeing an increase of 26% in public order offences and an 18% increase in reports of anti-social behaviour. Last month, we launched a campaign with the aim of highlighting some of these additional summer demands, and whilst there has been some reduction in these offences as a result, compared to last year we are still seeing more of these crime types. We continue to proactively work with the public and our partners to not only reduce this demand, but to prevent crimes from happening in the first place. We are committed to making a real difference to the lives of people in Dorset and Wiltshire. Our aim is to reduce the level of risk and harm to our communities from fire, targeting those most at risk. We do this primarily through our Safe and Well visits.

A Safe and Well visit is **FREE** and normally lasts about one hour covering topics such as:

- Using electricity safely
- Cooking safely
- Making an escape plan
- What to do if there is a fire
- Keeping children safe
- Good practice night time routine and other points relevant to you
- Identifying and discussing any further support the occupier may need

Are you or anyone you know:-

- Need a smoke detector?
- Have a long-term health condition?
- Suffer from poor hearing or sight loss?
- Would you struggle to escape in the event of a fire?

On Call Recruitment

Have you always wondered if you could join the fire service, but haven't had the opportunity to find out more? Have you found yourself seeking your next challenge, keen to give back to the local community or wanting to learn new skills including leadership and teamwork? Then becoming an on-call firefighter is for you.

As a paid position, on-call firefighters commit anywhere between 40 to 120 hours per week, during which time they must be able to respond to the station immediately.

Many have 'normal' jobs during the day, then upon their return home make themselves available overnight or during the weekends. Some of our crew respond from their workplaces during the day, and we are very grateful to their employers for releasing them to perform their vital duties.

Anyone over 18 years old can apply (although you can also apply once you are 17½) you must be able to respond and attend the fire station within 5-8 minutes, you have a good standard of physical fitness (i.e. you are generally active), and you must have the right to work in the UK.

Businesses urged not to overlook Fire Safety by National Fire Chiefs Council

Businesses across the UK which have had to make changes due to COVID-19 are being urged to make sure fire safety remains a top priority.

The call comes from the National Fire Chiefs Council (NFCC) as many have had to implement new ways of working due to the current pandemic. The NFCC is reminding businesses about the everyday fire risks in the workplace – and there is both a legal and moral responsibility to ensure premises are safe from fire.

Many businesses had to respond quickly to the pandemic once they were allowed to reopen and while revisiting risk assessments, fire safety may not have been at the forefront of planning.

As part of NFCC's Business Safety Week – which runs from 7th- 13th September – Dorset and Wiltshire Fire and Rescue Service are encouraging business owners and Responsible Persons (RPs) to ensure they review Fire Risk Assessments. They should also seek guidance and advice to help them keep their premises and occupants safe from fire.

Businesses must consider the potential risks that the COVID secure measures – which are required to open some premises – may in some cases, compromise fire safety measures:

- New screens must not obstruct smoke detection or sprinkler heads
- Business must have enough trained staff to support evacuation procedures
- Ensure measures to support social distancing do not impact evacuation procedures, exit doors or the ability of emergency service to help you
- Protect your business from arson
- Help your fire service by reducing false alarms which currently accounts for about 40% of all emergency calls

Group Manager Tim Gray, said: "The last few months have undoubtedly been difficult and challenging for many people and businesses. As such, we want to make sure that whilst businesses address the changes needed in response to Covid-19, they remain fire safe in doing so. Fire can have a devastating impact on businesses, with many never recovering after an incident."

He added: "We are encouraging businesses to firstly review their Fire Risk Assessments, and to contact us for advice should they need any support. Our goal is to keep all businesses working safely."

New digital approach for Safe Drive Stay Alive



How are we delivering one of our most important education schemes in the 'new normal'? Road safety manager Christine Sharma reports: With the new academic year came the challenge of delivering our flagship educational roadshow Safe Drive Stay Alive. As we are still unable to deliver our shows in schools, we considered how we could ensure this next cohort didn't miss out

on this life-changing education.

When we first entered lockdown, we realised Covid 19 would affect delivery for some time. We therefore considered using Microsoft Teams to run live shows, asking our speakers to deliver their accounts in real time. Whilst this would have mimicked the usual presentation, internet connectivity and technical expertise were factors that would be out of our control – so we decided against it. We were also concerned that a digital show would not be as impactful as a live performance, where you can feel the emotion of the speakers in the room. After we wrote our nationally acclaimed road safety education modules, we realised that 'business as usual' was still some time away, so we returned to our initial idea.

We chose to use pre-recorded talking heads instead of live speakers to avoid the issue with connectivity. We also considered ways that we could make the presentation more impactful digitally to compensate for not having live speakers. We have therefore created some bespoke media and used some existing public media to create a powerful digital show. Over the past few weeks, we have conducted several trials with our road safety partners, our sponsors and you, our supportive colleagues. The feedback has been phenomenal - we are still refining the show, and we are ready to begin delivery with schools.

Around a dozen schools have already booked their time slots and they've only been back a few days! In addition, the Ministry of Defence loved our show so much, they want us to deliver our military equivalent, Survive the Drive, in the same way.

Looking ahead, we envisage shorter, interactive lessons to be delivered in schools before or after the show as part of a suite of education and part of the PSHE programme. For behaviour change to happen, more regular intervention is necessary, so we're currently undertaking some research - we hope to have an update for you soon.

Face fit testing ... what is it?



Since the start of Covid 19, a team of HSE accredited face fit testers have been carrying out qualitative face fit testing in both Dorset and Wiltshire as part of the tri-services agreement. The team included Service personnel from Prevention and Protection - Gareth Baker, Natasha Campbell-Bell, Martyn Jones, Gaynor Mant, Steve Mant, and previously

Simon Carter, Kim Armstrong and Josh Williams. To date, the team has completed over 800 tests on staff from various agencies including paramedics; ambulance staff; doctors, nurses and practitioners from doctors' surgeries; care staff looking after the old, young and vulnerable; and even our own DWFRS personnel. Risk assessments had to be carried out at all 13 different premise locations - including care homes, a hospice and ambulance stations - before any testing was able to take place.

Facemasks are worn in various categories of medical intervention requiring a protection level of FFP3. These include Aerosol Generated Procedures such as CPAP (continuous positive airway pressure), minor surgical procedures to any part of the body above the clavicle, and general treatments to patients suspected of having Covid 19 infection. The FFP3 facemask provides the highest level of protection from a disposable facemask and is a two-way barrier to protect both wearer and patient. If the mask does not seal sufficiently on the face, both the wearer and patient will be at risk.

During the months of testing, the team have met, tested and made safer some incredibly selfless and caring people who have been so appreciative of our work, which we have found so humbling and rewarding. Background

Following the Electoral Review of Wiltshire Council, Electoral Divisions for the May 2021 elections no longer align to the boundaries for the Council's 18 Area Boards, which are based on Electoral Divisions.

It is therefore necessary for Full Council to agree new Area Board boundaries for implementation in May 2021.

At its meeting on 21 July 2020 Full Council delegated authority to the Electoral Review Committee to conduct a review of Area Board boundaries and prepare recommendations for its consideration.

The Committee met with the Members of each Area Board in July to discuss the incoming Electoral Divisions and their impact, including on potential Area Board boundaries.

At its meeting on 13 August 2020 the Committee agreed a set of proposals for Area Board boundaries to be consulted upon.

Consultation

A consultation will run from **10 September 2020 – 31 October 2020** on the <u>Draft</u> <u>Recommendations</u> of the Electoral Review Committee for Area Board boundaries to take effect for May 2021.

This briefing note will be circulated to all parishes and Members, and where an Area Board meets it will have the opportunity to be briefed on the proposals.

Update from Royal Wootton Bassett Academy

Anita Ellis - Headteacher

The challenges of returning to school in such circumstances this year have certainly presented themselves at RWBA thus far. However, the determination to overcome these challenges and provide resolution to each barrier from students, staff and parents has been phenomenal! I have been so proud to start my headship with such committed individuals.

We have introduced a wide range of safety measures to ensure that students, staff and parents feel safe and secure and that they can focus on the important business of learning. Attendance to date this year is 93.7%, less than we would normally see at this time of year but significantly more than many other schools. Much of the absence is down to parents trying to be cautious over illness and deciphering what potentially could be COVID-19 related illness, or not. We have very few students shielding or not attending school out of concern. Our Year Teams are doing an excellent job (as they did throughout lockdown) in communicating with the home environment to ensure that attendance continues to improve.

We have self-isolated 2 Year Groups, Year 9 and Year 10. They are not linked cases and we know that neither were caught or transmitted through school. We know this because one case was as a result of foreign travel and the other transmitted within the family. Through both isolations, no other student has reported COVID-19 symptoms or fallen ill, and due to our measures in place, no staff member has had to isolate. We carry out a proximity test on all staff who taught or supported the students and as they passed the test and developed no symptoms, no staff members were affected.

We wrote a Risk Assessment and Return To School Document in June 2020 and they have been reevaluated every 2 weeks as a result of monitoring, student, staff and parent feedback. They are published on our Website and sent directly to all parents.

Some of the most significant changes to school are:

- 1. Staggered arrival and departure times for all Year Groups so that we are able to bubble each Year Group and reduce the risk of transmission. This means that in the event of a positive case, we have only needed to ask that particular Year Group to isolate.
- 2. Staggered breaks and lunch times. Each Year Group have their own break and lunch time in their specific Break Zone. This has been the biggest logistical challenge as we only had one eatery (Terry's Restaurant) at the start of summer and we have since developed a further one on the other side of the school building. This has allowed us to only have three breaks and lunches over two different locations but this has come at considerable cost and providing shelter that can last through the winter is going to cost over 55k. Behaviour and calmness at break and lunch times has been noticeable as a Year Group of nearly 290 students has been able to enjoy the freedoms of their own space.
- 3. Each Year Group has their own toilets.
- 4. To enable the above, we have had to break apart the structure of the day. We have not reduced our curriculum offer as breadth is important to us. Our transition around the school means that Year 7 and 8 are largely static in 2 parts of the school with Years 9-13 having movement around the school. Years 7 to 9 go to their Break Zone at the end of each lesson to sanitise and be picked up by their next teacher. This has resulted in smooth transitions where we can ensure that Year Group bubbles do not mix. Years 10 − 13 (ass examination classes) have been able to carry on their work towards their exams with no disruption.

- 5. We have introduced a one-way system around the school, which in line with the split breaks and lunches, keeps contact points between Year Groups at an absolute minimum and allows Years 7 and 8 movement away from their static classes.
- 6. We have increased the number of cleaning staff at school with a rota throughout the day of key areas such as ICT rooms and PE changing rooms between changeover. Every class desk is disinfected by students at the end of each lesson.

We were concerned about transport, our drop offs and pick ups but with more visible Leadership Team staffing and guidance, this has run brilliantly and our parents have been really supportive. It has also increased the quick catch ups that happen outside of the school building with students and parents.

In terms of supporting our students to catch up, we have a Reconnection Curriculum in place, which we launched before the summer holidays. We have rag rated (with the students) what they covered during lockdown, what they should know and their confidences around this. This summarises key knowledge and skills. All students will have more frequent formative assessment to ascertain where they are on their learning path and they will complete baseline assessments to inform our planning, interventions and further tuition, if needed.

Our remote learning offer (whilst not perfect) ensured that the vast majority of our students did not fall behind and this has been borne out in our return to school. That said, they key concern of most students is the sense that they are 'behind'. We are working hard to provide them with the SEB and MH (Social, Emotional, Behavioral and Mental Health) support that they need and deserve. Assemblies continue to go ahead, iLearn and Tutor support continues to go ahead and our online offer has meant that on average, 320 Parents have dialled into our Year Group Parent Information Evenings. Staff have learned new skills and our 2 self-isolations have provided us with opportunities to practice remote learning, and to ascertain the student skill base too.

Our recent virtual Open Evening was dialled in by over 540 families. We are constantly thinking out of the box in how we can make our communication clear and honest.

The Government has pledged around £115k to fund catch up at RWBA and in addition to the above, we have developed an Inclusion Zone with specialist support for those students who need it. We have increased the hours for our MDSAs to monitor behaviours and help keep our Zones calm. We also have 3 x 1to1 Teachers recruited out of this funding to support small group work with students across the Year Groups.

Our key concern is regarding the weather, inclement and cold weather will not help these structures but we remain resolution focused and positive.

Engaged in discussions about substance misuse including smoking and worked jointly with other agencies around substance misuse.

YP in the park by the skate park friends left him in the park, he appeared sad at this and anxious he told us he went to a school in calne and then Devizes school and that he just moved house, staff spent some time with him, checking in how he was feeling, supporting him to feel less anxious until he was ready to go home.

Our new normal...



Like everyone our organisation was affected by the pandemic with key volunteers (Sue & Jenn) stepping up to help run Royal Wootton Bassett Helpers (the local COVID-19 support group). Our young people were also doing all they could to support their community from home, by building food boxes, sourcing donations and



creating messages of hope for those isolating. So, we paused meetings over the spring/summer, whilst we found our feet again.

Our link to RWB Helpers remains and they are reaching out to families who maybe struggling to purchase uniform. We now include both RWB Helpers and the Richard Jones Foundation leaflets in our uniform packs.

Welcome to Bassett – Free Second-Hand Uniform (All RWB schools)

We launched our uniform scheme in the middle of the lock down to ensure that any families and young people in need of school uniform, were supported. Our scheme is open to anyone wishing to use it, so those wanting to support the environment are as welcome as those with limited finances.

To date the amazing work of our volunteers has resulted in:

- 1117 items being donated
- 259 items being given out
- 55 loads of washing (in just 1 month)
- 49 items mended
- And most importantly 66 families helped!



This would not have been possible without the amazing work of Zach, Gary and Frances whose dedication enabled the scheme to start and continue through the crisis. Thank you!

As life settled a little, we were able to return to holding meetings this September. We are now meeting online with new policies in place to safeguard our young people. We're also exploring how we can connect in more ways with local young people using digital platforms.

Junior Champions (Committee) – Young People

Two more young people have joined our Junior Committee this Autumn. We are pleased to welcome Junior Treasurer Katie, and Jasmine who attended for the first time this month. Our Junior Champions are, and will continue to, prepare minutes; attend our meetings; attend Town Council meetings; learn about our organisation and put together their own initiatives.

Youth Groups

Like all organisations our youth groups have had to work hard to continue.

Swindon and Bassett Sea Cadets are now working together to ensure they have all the right team members to provide groups for both areas. All involved are working hard to make sure that their new spaces will be delivered soon. It just goes to show, in the pandemic, dedicated key volunteers from both groups found new ways to ensure our young people continue to have access to the support and opportunities the Sea Cadets can offer. Thank you!

Out of The Can has maintained support for its existing members via online meetings, to continue doing all they can for our LGBTQ+ young people.

Unfortunately, CMAS could not survive the crisis, but thankfully a great response from the Rise Trust has meant that two of the CMAS youth workers were hired and a COVID Safe Youth Outreach was not only in place but actively engaging with Bassett's young people by the start of September.

Our thanks to both the Rise Trust, Cllr Allison Bucknell and Jane Vaughan for their quick and effective responses at that time, which paved the way for agreement to be sought from Royal Wootton Bassett Town Council to continue to fund and provide.

The meetings have been streamed on our facebook page leading to a much greater public engagement than is normally the case. One of the responses posted on facebook the first time we used it said:

"I thought this was great. \downarrow Should make it live like this all the time even when it's back in the council offices. Gives people a good insight on how things work and encourage younger people to join to be a councillor. I'd love to have a go \downarrow \downarrow "

We were fortunate that the work on our long-planned Skate park extension was able to proceed on schedule. It opened in July and is much appreciated by the users. The funding came from section 106 agreements and CTC reserves.

We were pleased to appoint Duncan May as our new Town Clerk with effect from 1st September. Duncan had served as Deputy Town Clerk for just over five years and it was a well-deserved promotion. The process of recruiting a new Deputy is now underway.

Like most communities, in Cricklade there has been a great deal of voluntary action during Covid, especially during the months when our more vulnerable residents were shielding. CTC coordinated a team of volunteers to carry out shopping, deliver prescriptions and provide telephone support. Those activities have now effectively ceased but the team stands ready in case the need arises as we move through the autumn months.

The annual community litter-pick that was postponed from March took place on 19th September. The arrangements were very different this year with just small groups of volunteers. However, the rubbish was there just the same and 38 bags were collected in just a couple of hours.
