A quarter of all known coronavirus deaths have happened in care homes. Elderly people have been isolated and prevented from seeing their family until recently. According to Dementia UK this enforced separation has caused a deterioration in residents mental and physical health particularly for those living with dementia - who make up more than 70 percent of the population of care homes. Our Time Project was established in 2013. Prior to the crisis we provided theatre and movement workshops to elderly people including individuals who had endured strokes and those with dementia. Improving the physical and mental health of our beneficiaries is still our main priority. As such we have talked to our care home partner Staverton House about the key issues affecting residents. One of these issues is that many are struggling to understand their experience of sudden lockdown and this is impacting their mental health. In response we have created this new project at a specific issue that has impacted our beneficiaries such as depression anxiety fear and death. Using theatre some simple movement sharing stories around an object important to them beneficiaries will be supported to explore and understand what they have experienced and this will help to improve their mental health. Humour is an important part of this project. Comedy has been shown to improve engagement in dementia patients and studies show that laughter improves health and eases stress. Our beneficiaries have been severely impacted by the crisis. Without support now their mental health will continue to deteriorate. Residents have care and support needs that have not been met due to their separation from their family and current visiting guidelines are inconsistent meaning many continue to be isolated. A second wave would bring back this separation. Our project will help to improve mental health and wellbeing. Studies and our own experience show that by engaging elderly people especially those with dementia with art and theatre their levels of anxiety and feelings of loneliness decrease. The use of humour will increase this impact. One study has found that laughter caused a 20 percent reduction in anxiety symptoms in dementia patients. Laughter helps by redirecting negative emotions or even just by being a pleasant distraction for a while. Four online Workshop sessions will connect elders with our practitioners in as one to one personal and supportive sessions. The workshops will be tailor made and developed

written and adjusted carefully as the work goes on collaborating and listening to the coordinators in the home. The project supports Local needs and priorities as it encourages and promotes health .This project will reach these beneficiaries in a time of Crisis which as we know has affected everyone but this group the most severe.

The Project will be overseen by The Our Time Project Company Management Advisory Board MAB which consists of a Medical Doctor Academic Doctor with extensive community Project Development experience a Marketing Business Executive and a Community Engagement advisor as well as a Financial Manager. Feedback forms will be collated from the participants managers and carers. This in turn will give an idea of the projects impact on participants. The feedback forms will also have an influence from The Warwick Edinburgh Evaluation scale giving a sense of the benefits with regards to participants well-being. The Company website www.ourtimeproject.com will be updated regularly with regards to the progress of the project. Quotes will be collated at the end of the project to give an overall impression of the benefit of the project to the participants and surrounding communities. As an artistic organisation who has worked with thousands of elderly people for the last 7 years we endeavour to tailor all of our productions to the unique needs of the beneficiaries of those projects. This happens under the guidance of our management advisory board. One of the members of our board is a NHS GP. Their advice is vital in making sure we address the key physical and mental health issues affecting elderly residents in care homes. Dee Mansfield from Forum Stroke Club said of our work This visit caused so much merriment. I was amazed at the involvement of my members even my chair bound members had a go. Karen Johnson from Order of St Johns Care Trust said of our workshops Many of the residents threw themselves into the role play.

The issuing of devices will benefit the local community in numerous ways. Our project will

help bridge the digital inequality linked to disadvantage which has become blindingly obvious during the unprecedented Covid Pandemic. It will allow impoverished children and families -Access to welfare and health advice impacting on wellbeing and happiness -To communicate with trusted adults and health professionals that they cannot see in person thus supporting their mental health-Equal opportunities to access learning and achieve academically thus raising aspiration and life chances -A safe platform to communicate with peers and family thus avoiding isolation. By providing IT devices to children in need many families will benefit. For disadvantaged families the pressures to provide IT equipment will be immense. Many are struggling to meet minimum basic need eg increase in the numbers accessing food banks. Evidence is suggesting rising debt amongst low income groups. By removing the pressure of IT concerns families will be able to focus on other priority areas which may go some way to avoiding future debts and financial pressures. The devices will also allow older families members access to online life long learning opportunities. A subliminal benefit will be the reassurance struggling families will gain knowing that community groups organisations and schools are aware of their needs and willing to help. This will build community cohesion establish relationships and promote trust. It will also help build the confidence to seek help when needed in the future.

We will do this anecdotally via feedback forms and via online communication. We will be able to view how much online learning has taken place and will support families to achieve this. Although we currently hold 57k in reserves our expenditure budget for 2021 is 173k. We have pruned this budget as much as we are able but payments to the Diocese of Salisbury which covers Vicars salary pension and housing costs salaries to our admin staff and cleaners insurance and utility costs for the buildings amounts to 134k. As a charity we are required to hold a sum equivalent to 3 months of expenditure so the minimum we must hold is 43k. Part of the keeping the budget as low as possible includes taking advantage of the Job Retention Scheme for our three part time cleaners 4 hours per week each and an Office Assistant 6 hours per week. Our income budget is just 165k most of this income 148k comes from church members and gift aid reclaimed on this giving. The remainder we have predicted what we are likely to receive in the letting of our premises which is going to be

much reduced for at least half of the year. As the community groups who hire the building are not able to under the current COVID restrictions and as a number of the groups have older members notably U3a groups they are not likely to start using our premises before September. This 2021 budget already shows a deficit of 8k which will reduce our reserves yet again. Prior to COVID-19 i.e. 2019 we had a large number of community groups and events in Holy Trinity and the income from that was 10k in 2020 it was reduced to just 2.5k.

As a building with a large open interior space in a central and prominent location in Trowbridge Holy Trinity has the potential to host a variety of community events and groups. However many of the facilities were dated and are in need of an upgrade to meet the standards expected by todays users. Since becoming part of St Thomas parish in 2010 a project has been underway to develop the buildings to benefit both existing users and attract new users to the buildings. The refurbished toilets combined with the comprehensive updating of the building described below will provide existing user groups of the building with toilet facilities with wheelchair access improved baby changing facilities and the replacement of old open topped cubicles with fully enclosed ventilated toilet cubicles with floor to ceiling walls and doors suited to unisex use. Existing users include the Church an open access Parents and Toddler group which meets weekly and have over 100 children

from all parts of the community attending over two sessions the Trowbridge Orchestra and Trowbridge Philharmonic Choral Society who use the building as a venue for orchestral and choral concerts local primary and secondary schools who use it for carol Services the Sea cadets new in 2017 a number of choirs who use it for performances and the National Citizenship Service who use the building for training sessions and their young people's groups. These user groups only use the church to a fraction of its capacity therefore we expect that the improved facilities will allow a number of other community groups to use the facilities as well. Ultimately an increased use will allow Holy Trinity to secure its future at the heart of the town of Trowbridge.

The use of the church will be monitored by the number of bookings.

All counsellors and staff have an up to date DBS and all references are taken. During their induction counsellors and staff are provided with a copy of the policy and key elements are worked through. Yearly training on specific areas such as suicide risk self-harm and the potential risk to others is provided. Our vulnerable person policy is up to date and will be reviewed in September 2021

There is a lot of help available for addicts but families often feel overlooked. No one can understand the impact addiction has on families trying to cope with a loved one in the grip of an addiction. It devastates lives and families if someone you care about is abusing drugs or alcohol your life is affected at every level. People often experience distress hopelessness a strong sense of shame and feel their lives are spiralling out of control just trying to cope. Families Out Loud offers the opportunity to talk which can be a lifeline for anyone going through trauma and distress. We help people manage their situation and make positive changes in their lives. Talking to others who have had similar experiences and understand can be powerful and healing. One client wrote I have been attending FOL support group meetings for over 5 years during which time my own life and that of those around me has improved dramatically to a point where we are all now able to function normally despite my sons addiction. We offer a safe environment where you can talk listen give or get advice and discover that you are not alone. Our families come from all walks of life ethnicity religion ability and financial position. We now have 12 members in Trowbridge with 3 more waiting to attend face to face when Covid allows. They meet on the 1st and 3rd Wednesday each month. We employ a qualified specialised substance abuse counsellor especially trained to support these families. She undertakes initial conversations with new referrals and offers a one to one session to assess their situation. They are then offered one to one counselling with an option to join the support group if when they are ready. These group sessions are

led by the same counsellor. We are aware of the high level of drug and alcohol related issues affecting families in Trowbridge not only from the anti social and crime incidents reported in the Joint Strategic Needs Assessment but also in the Local Area Priorities to tackle antisocial behaviour and crime together with developing opportunities to improve health and wellbeing. Also our own clients report other families in need are out there so we recently recruited a further Counsellor to support a managed increase of the Trowbridge service from 16 families per year to up to 24 subject to funding. This means that up to 144 people are likely to be positively impacted as each family is likely to have work relationships direct siblings extended family friendships and other professional relationships to keep going in order for their lives to function. In the last 12 months our referrals have developed without specific website publicity or liaison with other agencies except Turning Point who refer family members to us occasionally. We wish to build on this by developing meaningful working relationships with other local agencies including the Trowbridge Hub GP Surgeries Housing Associations and the Local Coordinator for Public Health. We have always offered a virtual counselling service on line via Zoom or other media alongside our Face to Face service but Covid conditions have trebled this need and extended to virtual group sessions. We are asking for help towards the professional counsellor costs to deliver sessions in either way clients want. Also we need to purchase two Laptops owned and maintained by the charity used by the Counsellors to ensure ongoing continuity of safe reliable virus protected sessions to support clients effectively. We ask members to contribute towards the on to one counselling and support group running costs where they are able however contributions are small and we would never turn someone away through their lack of means. We are planning a mix of fundraising activities to match these needs one of which is extending our grant applications where appropriate. We really do need your help and ask you to support us in this project.

14. How will you monitor this?

We will monitor the number of referrals and take up of one to one counselling via internet and f to f. Then those that move into a support group. Users of the service will be asked to complete an assessment form every 6 weeks to detail their personal outcomes and progress. Referral numbers and progress will be discussed at each monthly Trustee meeting. We also conduct on-line client surveys typically twice per year. This is to ensure that our management decisions are informed and influenced by our families.

15. Safeguarding. Please tell us about how you will protect and safeguard those involved in your project

Our safeguarding policies and constitution were approved by The Charities Commission as part of our registration process. We review policies yearly as standard but also more often when we are aware of changes. Our professionals who are fully trained in all aspects of safeguarding regularly refresh their skills. For example our lead counsellor will shortly attend the following online training course NHS Future Learn Safeguarding Adults Level 3 Training. In addition two FOL trustees have recently completed the NSPCC safeguarding course Charity Trustees your duties to safeguard and protect. Everyone in our organisation who has undergone training is responsible for disseminating all necessary information and ensuring safeguarding compliance by the rest of the team. We do not have volunteers at present but would put in place recruitment and monitoring systems were this to change. Training will be undertaken at regular intervals to refresh skills. Counsellors identifying safeguarding issues follow FOL procedures for adult safeguarding and child protection - and discuss with counselling supervisor we also have access to a social worker and a highly qualified psychotherapist who is a champion for our charity. We also discuss with MASH

and WASB Wiltshire Council for further guidance if required. All trustees have a basic DBS certificate details of which are held in a central record by the secretary. A copy of the secretary's certificate is held by the chair. Renewal is undertaken every 3 years. We are in the process of upgrading our professionals from basic to enhanced DBS certification which will be completed in the next few weeks. All employees references are kept securely in the same place. Our Chair of Trustees is ultimately responsible for safeguarding. She is made aware of any safeguarding issues and actions being taken. In addition our Board of Trustees will be appointing a Designated Safeguarding Lead at their next meeting due this week.

Moving forward we aim to regularly review participant contributions for one to one counselling and group meetings. We are currently looking into a variety of fund-raising events and ongoing activities by Trustees and group members in addition to extending our portfolio of grant funders.
