	Cllr Kelvin Nash declared a pecuniary interest in agenda item 15, the Health and Wellbeing grant application from the Bassline Circus as he was a trustee of the organisation and was also the Chair of DOCA, he therefore declared that he would not take part in the debate or vote on that item. For transparencies sake Cllr Nash also declared an in agenda item 6, St Joseph's Pupil Parliament as he was related to a teacher at the school. There was no vote planned on that item.
	Cllr lain Wallis declared an interest in agenda item 13, Air Quality and Sustainable Transport, in particular the proposals for new, moveable cycle parking in Devizes marketplace as he was a member of the Devizes Town Council working group. He declared that he would not take part in the debate or vote on that item. Cllr lain Wallis also declared an interest in agenda item 16, Area Board Funding, in particular the application from Devizes Open Doors, as he was a trustee of the charity. He declared that he would not take part in the debate or vote on that item.

Youth Council update

The Chairman encouraged schools to look at the written update on pages 23-25 of the pack so that schools could take part in the Youth Council.

Agenda order

The Chairman announced that item 9, Devizes Urban Gulls, would be brought forward and considered after agenda item 6.

43 <u>St Joseph's School Pupil Parliament</u>

Gemma Payne, Assistant Headteacher, St Joseph's Primary School gave an update to the meeting on the school's pupil parliament and their efforts to improve road and traffic safety in Station Road. Devizes. A video was played featuring the children from the school and the problems caused by people parking illegally, especially at school drop off and pick up times. The children were fundraising and creating posters to try to address the issues.

Devizes Area Board discussed the situation, and the Board were going to raise the issues to the Highways team, Parking team, and to other officers regarding a school travel plan, which could lead to additional funding sources. It was highlighted that parents could park in the Station Road car park for 20 minutes, free of charge at school pick off and drop up times. Russell Holland (Deputy PCC) stated that he could also share the video with his team.

The Board applauded the efforts of the youngsters.

44 Partner Updates

In addition to the written partner updates in the agenda the following verbal updates were given:

Dorset and Wiltshire Fire and Rescue Service

David Geddes of the DWFRS referred attendees to the written report in the agenda. Recruitment was was highlighted, Devizes Fire Station was an on call station and more on call firefighters were needed. Further information could be found at www.dwfire.org.uk/working-for-us/on-call-firefighters/. Devizes station had received 72 call outs in the period 1 September 2021 to 23 November 2021 and just over half of those were

false alarms. 4 of the call outs had been for chimney fires, so the representative stressed the importance of making sure chimneys were swept and serviced. In response to questions regarding the recent waste fire at a landfill site in Devizes, the representative explained that due to the amount of damage the actual cause of the fire would probably never be known but it was possible that it had been caused by the careless disposal of batteries, so people were reminded of the importance of disposing of batteries properly. Cllr Tamara Reay thanked the service for the help they had provided with flooding in Potterne.

Wiltshire Police

Inspector Allen Lumley gave an update to the meeting and ran through the update published with the agenda. Sergeant Gareth Cole, a new member of the Devizes Community Police Team was now in place. The overall volume of crime had reduced by 7% in the last year and there had been a 31% reduction in burglaries.

Officer verification checks had been introduced as a result of the murder of Sarah Everard by a serving MET Police officer. These checks would mean that if a person was stopped by police, they could request that the officer verify that they were conducting lawful business. To do this the officer would put their radio on loudspeaker and contact the control room for verification. The aim of this was to reassure the public and help to build confidence.

It was stated that anti-social behaviour was an ongoing issue in the Quakers Walk/Keepers Road area. The majority of youths responsible were known and a multi-agency approach was being taken to tackle the issue, although this would not be a quick fix.

There had been a decrease in rural crime compared to the same period last year, however there had been some issues with hare coursing.

There had been a spike in bike thefts, some key suspects had been arrested and people were reminded to be careful with their bikes, ensuring they were locked up in secure areas.

The Deputy PCC, Russell Holland stated that Operation Sceptre focusing on knife crime and a weapons amnesty had been a success, with over 450 knifes being handed over. Speeding which was an ongoing issue was also mentioned and the Deputy PCC explained that more cameras had been ordered to help with speeding enforcement.

Schools Update

Ralph Plummer, Headteacher of Lavington School gave an update to the meeting. The school was busy approaching Christmas and everyone was looking forward to a production of Matilda taking place that week. A year

11 mock interview day had been held with a range of diverse employers attending and the year 11's were now undertaking their mock exams. Things were moving in a positive direction regarding COVID. At the end of term 1 infection rates among pupils at the school had been very high, but now numbers were the lowest they had been since September. However, staff absences had resulted in extra pressures. The School were concerned about the long-term budget implications of fuel costs after prices had at least doubled.

Mark Lascelles, Headteacher, Dauntsey's School, stated that the situation at Dauntsey's was similar to Lavington. COVID had resulted in pressures on staff and pupils. There were also concerns regarding mental health pressures on the students, as a result of COVID and the pressures faced by year 11 and 13 regarding their exams.

• Devizes Indies

Although unable to attend the meeting Devizes Indies sent a brief update which included the QR codes that they received funding for were up around Devizes and looking great; the maps they had produced were in multiple retailers and they had noticed a significant number of visitors to Devizes and Devizes Indies were working with Sustainable Devizes on 'Turning the High Street Green' which would be launching early in 2022.

Sustainable Devizes

Graham Martin of Sustainable Devizes gave an update to the meeting. Topics covered included identifying the communities Sustainability Priorities, as part of this a consultation survey containing questions on the attitude to climate change had been underway. The group were pleased with the response rate, with 568 responses received and the demographics of the respondents roughly matched those of Wiltshire. 77% of respondents had climate anxiety and some of the priorities identified covered waste, transport and active travel and biodiversity. Upcoming for the group was the Active Travel Devizes Local Cycling and Walking Infrastructure Plan (LCWIP) and a biodiversity event. The group had applied for a lottery grant with Devizes Indies for the production if a reusable Devizes cup and they were also working on a Sustainable High Street project.

The group highlighted their aim to increase dialogue with the parishes and Members suggested that they email the parish clerks. Representatives of Bishop Cannings and Market Lavington Parish Councils stated that they would be interested in working with the group.

Cllr Tamara Reay thanked the group for their hard work and highlighted the resolution passed by the Board in September 2021 where the Board committed to work with organisations, residents and businesses across the Devizes Community Area to create a sustainable Devizes.

• Devizes Opendoors

Noel Woolrych gave an update to the meeting. The Devizes Opendoors centre was open four days a week, Monday, Wednesday, Thursday and Friday. They also provided hot melas three days a week. The service was a success with one service user had stating that they liked going to the centre as it felt like home. The organisation was happy to rent out the space when it was not being used. The official opening event had been postponed due to COVID.

45 Vibrant Wiltshire Grant Scheme

The Chairman announced that a grant scheme for Wiltshire independent businesses had been due to be launched, but unfortunately had been delayed, therefore there was no presentation for this item. Details of the grant scheme would be advertised once available.

46 Devizes Urban Gulls

Note: This item was considered after item 6 on the agenda.

Danny Kruger, Devizes MP, thanked the Board for the invitation and explained that the blockage in dealing with the Devizes Urban Gulls situation was at a national policy level. The policy had been changed to prevent the culling of birds or disturbing of nests and attempts to get a licence to control hatching of eggs in Devizes had not been successful. He intended to get other MPs with the same issue in their constituencies to join a lobbying campaign to DEFRA and Natural England to change the policies. Mr Kruger stated that he had written to all the relevant MP's and responses were starting to come back, he would follow up and report back to the Board.

The Chairman thanked Mr Kruger and hoped that some progress could be made on the issue.

47 <u>Fostering in Devizes</u>

Andrew Jack (Community Engagement Manager) gave an update on the recent fostering campaign in Devizes. The campaign was held during November 2021 and highlighted that there were 23 children in the Devizes area who needed foster families. Being fostered locally helped to keep children in their own school, with their friends and in a place they know.

Several engagement sessions had been held, and well attended, as well as information being shared online and at various locations around Devizes. As a result of this target effort the team had received numerous contacts which were now being followed up.

It was highlighted that if anyone was interested in being a foster carer they could visit https://fosteringwiltshire.uk/ for more information.

48 Open Floor

A question was received from Sue Buxton who worked with Devizes Opendoors, regarding the Devizes Library and when the hub would start operating again. There were concerns that vulnerable people who needed contact with the Council face to face, rather than by email or telephone were missing out.

The Community Engagement Manager stated that he would feedback this back to colleagues and respond directly to Ms Buxton.

49 Community Area Transport Group (CATG)

The Chairman, on behalf of Cllr Dominic Muns (Chair of the CATG) gave an update on the CATG.

The following high priority schemes were progressing well with the Highways Engineer:

- Speed limit review, A342 Lydeway:
- No through road, Rotherstone, Devizes: This project confirmed as complete
- New footway linking Tanis, Conscience Lane, Rowde: A bid for Substantive Funding was submitted summer '21 awaiting outcome.
- Signage for amenities, A342, Bromham: This project confirmed as complete
- Speed limit review, A342, Bromham:
- New 20mph limits, various roads, Devizes: Metrocounts undertaken November '21
- New dropped kerbs throughout Market Lavington: This project confirmed as complete
- New warning signage for pedestrians in road, Bromham village

Progress had also been made on the following schemes:

- Pedestrian visibility at Seend High St. Agreed to develop new signage and high friction surface; moved to High Priority list
- Request for new footway, Townsend, Poulshot: Construction length is approx. 75m; awaiting High Priority slot
- Parking issues at Duck St, West Lavington: To investigate solutions to parking problems and obstruction near care home; awaiting High Priority slot.
- Sockets/posts for SIDs at Worton. Agreed to install up to 5 sockets for posts at various locations within village that would carry a SID; awaiting High priority slot

An additional project had been added:

 Speed limit review, Horton Rd, Bishops Cannings: to reduce speeds after building of new developments there; moved to High Priority slot. It was,

Note: There were no CATG financial commitments to confirm.

Air Quality and Sustainable Transport

Cllr Tamara Reay as Chair of the Air Quality and Sustainable Transport group highlighted the detailed reports within the agenda pack and gave the following updates.

Air Quality

Air quality levels in Devizes were below the 40µg/m3 threshold. Much of this was due to a drop in the number of vehicle journeys during the pandemic. However, levels appeared to be rising and it was anticipated that 2021 levels would be higher than 2020. Sources of this pollution were looked at by vehicle type and a major contributor to pollution in Wiltshire was private diesel cars. Wiltshire Council was developing an Air Quality Action Plan, which would be ready in 2022.

Devizes Gateway Station

The Strategic Outline Case (SOC) for Devizes Gateway had now been submitted to government. Danny Kruger MP had written to Secretary of State regarding the scheme. £34,000 had been committed by Devizes Town Council which was very welcome and showed the strong local commitment to the project. Devizes Local Cycling and Walking Infrastructure Plan (LCWIP)

There had been strong collaboration with Cycle Friendly Devizes and Sustainable Devizes to develop a brief in order to create a new Local Cycling & Walking Infrastructure Plan (LCWIP). Wiltshire Council's contractor, Atkins, were to be commissioned at a cost of £20-30,000. LCWIPs also enable bidding for further money from government. The AQST group recommended allocating up to £30,000 from the AQST budget to deliver the LCWIP.

Proposals for new, moveable cycle parking in Devizes marketplace.

Devizes Town Council had developed plan for new cycle parking in the marketplace, comprised of two moveable racks, each for up to 4 cycles, which would be trialled at different locations across marketplace. It was highlighted that these locations should be covered by CCTV. The total cost for the racks was £1,08161 which the AQST recommended funding in full.

Buses

Service use was up on 2020 but overall demand was just 75% of pre-pandemic levels. There was an industry-wide shortage of drivers making it hard for improvements to be made. However, the No. 49 and the town bus were unaffected. £1.2m had been made available for demand responsive service in the Pewsey Vale, including a direct service between Devizes and Marlborough.

EV Charging Point Strategy

Wiltshire Council had now published a new strategy (available under minute 72 at the following link). The plan was to restore current chargers across county (including 2 in Station Rd car park). The group may also be able to support installation of additional charging points elsewhere. A package of funding for town & parish councils was available to bid for in order to support residents without off street parking. There were also opportunities for employers with EV charging points in staff car parks to open them to the community as well.

It was,

Resolved:

- To note the discussions from the AQ&ST meeting of 18 November.
- To confirm the allocation of up to £30,000 towards the production of a Devizes Local Cycling & Walking Infrastructure Plan.
- To confirm the allocation of £1,081.61 to Devizes TC towards new cycle parking for the marketplace.

51 Youth Updates

Bromham Youth Club was now moving forwards and things were looking more positive after the club had been affected by COVID.

Steve Dewer (WYFC) stated that WYFC was committed to supporting Devizes

Town Council and Wiltshire Council wherever they can in order to hear young people's voices. There was a concern that Local Youth Networks (LYNs) should be consistent across the county, more strategic in nature and it was hoped that the Devizes LYN could go from strength to strength. Mr Dewer was currently working with 3 schools in order to support young people. Mental health was an issue for young people and measures should be put in place to support them. The Chairman stated that these were good points and asked the Community Engagement Manager to pick these up.

Andrew Jack, Community Engagement Manager, gave an update on a Youth Survey which had been undertaken. The survey had been county wide, with over 4820 respondents, 85 of which stated that Devizes was their nearest town. The survey looked at who the youbng people were, the activities they currently took part in and those they would like to do. Sport was currently very popular and young people wanted more access to art facilities, cooking facilities and self-defence.

Questions around mental health were asked with young people stating that they were affected by anxiety and depression, exam pressure and difficulties with self-esteem. For those who responded, drug and alcohol use did not appear to be issues.

There were a large number of open questions asked and the data received was still being analysed.

The Board then considered the application for Youth Grant Funding and a representative of Market Lavington Parish Council spoke in support of the application. It was,

Resolved:


 To grant Market Lavington Parish Council, £1,200 towards a Skateboard and BMX Poor Show and Workshop Event.

Health and Wellbeing Group

Cliff Evans, Chairman of the Health and Wellbeing Group (HWBG) gave an update. The group had organised a charity awareness week, where each of the groups involved with the HWBG came to Morrisons to promote awareness of what they did and to try to raise funds. In all 13 organisations took part. The event was a success, but feedback included that due to the cold weather, it would work better to run the event in warmer months. The group would like to repeat the event, possibly in April.

Waste collection days to change from 28 February for most Wiltshire residents

The household waste collection days for nearly all Wiltshire properties will change from Monday 28 February, as Wiltshire Council seeks to make the rounds more efficient.

This change will only affect the general household waste collections – there is no change to recycling or garden waste collections, which will still take place on their usual day for all residents.

To help residents with the change, every household will receive a personalised information letter that explains how their collection day will change and what they need to do. They'll also have a hanger label placed on their general household waste bin on their last collection under the old schedule that will give them more information. Letters will start landing on doormats from 31 January and during the following two weeks, while people will start to see the hangers on their household waste bins from 14 February.

Cllr Dr Mark McClelland, Cabinet Member for Waste, said: "Changing the waste collection day for nearly every household in Wiltshire will enable us to make our rounds more efficient, help reduce our carbon emissions and save more than £1.5m over the next five years.

"While we're making these savings, our waste contractors, Hills, will maintain the current number of collections staff, as there are a number of vacant positions that will now not be filled.

"This change only affects what we call residual waste, which is essentially the general household rubbish bins, and not the recycling or garden waste collections – these collection days will stay the same across the county.

"From 31 January and for the following two weeks, all households will receive a letter that explains the changes and details their new collection day, so people don't need to do anything until they receive their letter.

"We look forward to these new rounds helping to reduce our carbon emissions and deliver value for our residents."

The Queen's Platinum Jubilee celebrations

1. Purpose

1.1 To update Area Boards on arrangements to support communities to celebrate the Queen's Platinum Jubilee.

2. Background

- 2.1 In 2022, Her Majesty the Queen will become the first British Monarch to celebrate a Platinum Jubilee (70 years of service) having acceded to the throne in February 1952.
- 2.2 An extended Bank Holiday, from Thursday 02 June Sunday 05 June 2022 will provide an opportunity for communities and people throughout the United Kingdom to come together to celebrate the historic milestone by means of community street parties.
- 2.3 These four days of celebration will include public events and community activities, as well as national moments of reflection on the Queen's 70 years of service.
- 2.4 Similar events took place in 2012 for The Queen's Diamond Jubilee, with many communities holding street parties, barbeques and tea parties in honour of the milestone. Wiltshire Council have specified previous guidance and relevant officers will follow the same process as used in 2012.







3. Procedure and management of applications

- 3.1 Wiltshire Council has a robust and straightforward system in place to ensure that communities wishing to celebrate the Queen's Platinum Jubilee are signposted to the council's web page where they will find the appropriate tools, support and guidance to apply to hold a street party. See here – Platinum Jubilee celebrations – useful information and guidance
- 3.2 The application process will be a combined departmental effort, as with previous events of this nature.
- 3.3 The council's Traffic Orders, and Highways teams will need time to ensure that all road closure notices and provisions are in place to allow for a safe and enjoyable event for all guests, while maintaining and facilitating access for emergency services at all times. A minimum of eight weeks' notice is required to process applications if a road closure order is required.
- 3.4 The council is committed to managing this process utilising a cross departmental approach. Such departments will include the Community Engagement Managers, Traffic Orders, Communications, Highways, Streetscene, Wiltshire Police and Waste.

4. Conclusion

- 4.1 Relevant council departments are aware of the importance that street parties are to the residents of Wiltshire to celebrate the Platinum Jubilee.
- 4.2 Planning in preparation to support these activities is well underway to ensure communities will have what they need to celebrate this unique occasion.

Chairs Announcement – Changes to the Highway Code

Jane Deeley (Road Safety Manager – Education) has highlighted that there are to be changes to the Highway Code from 29 January 20222. However, there is not yet anything official yet from Department for Transport in terms of publicity assets around the changes to the Highway Code, although they have promised there will be a THINK publicity campaign 'soon'.

In the meantime there is further information on the outcomes of the Government's 2021 consultation on the proposed change here: Government response to the review of The Highway Code - GOV.UK (www.gov.uk)

Attached is a summary table of the changes from the gov.uk website, which can be shared.

Major changes include:

- The introduction of a hierarchy of responsibility of road users. Drivers of
 vehicles that can cause the greatest harm in the event of a collision bear the
 greatest responsibility to take care and reduce danger for others. There is
 emphasis throughout on everyone sharing roads and other routes safely with other
 road users
- Priority for pedestrians at junctions. Drivers, motorcyclists and cyclists should give way to pedestrians crossing or waiting to cross a road into which or from which they are turning. You should give way to pedestrians who are <u>waiting</u> to cross at a zebra crossing and pedestrians or cyclists waiting at a parallel crossing (previously only when actually crossing)
- Priority for cyclists, riders and horse-drawn vehicles at junctions. Drivers and
 motorcyclists should not cut across the path of cyclists, riders and horse-drawn
 vehicles going ahead when you are turning at a junction, in the same way that you
 should not cut across any other road user.
- Clarification on road positioning for cyclists, who are advised to ride in the
 centre of the lane in some situations to make themselves as visible as possible,
 especially at the approach to junctions or road narrowings where it would be
 unsafe for drivers to overtake. (This is taught in Bikeability training)
- More information on safely overtaking motorcyclists, cyclists, horse-riders and horse-drawn vehicles and filtering by cyclists.
- Adopting what is known as the 'Dutch Reach' technique when opening the
 doors of a parked vehicle. Use the hand on the opposite side to the door you are
 opening (e.g. use your left hand to open a door on your right hand side) This will
 make you turn your head to look over your shoulder and avoid injury to cyclists or
 motorcyclists passing on the road or to people on the pavement. Video here: <a href="https://doi.org/10.100/jhep-10.100

On Call Recruitment

Have you always wondered if you could join the fire service, but haven't had the opportunity to find out more? Have you found yourself seeking your next challenge, keen to give back to the local community or wanting to learn new skills including leadership and teamwork? Then becoming an on-call firefighter is for you.

As a paid position, on-call firefighters commit anywhere between 40 to 120 hours per week, during which time they must be able to respond to the station immediately.

Many have 'normal' jobs during the day, then upon their return home make themselves available overnight or during the weekends. Some of our crew respond from their workplaces during the day, and we are very grateful to their employers for releasing them to perform their vital duties.

Anyone over 18 years old can apply (although you can also apply once you are 17½) you must be able to respond and attend the fire station within 5-8 minutes, you have a good standard of physical fitness (i.e. you are generally active), and you must have the right to work in the UK.

Electric blanket safety

With colder weather now kicking in, we've been reminding people about the best ways to stay safe and warm. The recent cold snap will have led people to get heaters and electric blankets out of storage. However, there has already been at least one fire involving an electric blanket this winter, so please follow this advice if you're intending to warm your bed this way:

- Folding up electric blankets damages the internal wiring, so store them flat or rolled up instead.
- Check the wiring and plug on your blanket before using it, to make sure there is no fraying or damage.
- Unplug blankets before you get into bed, unless they have a thermostat control for safe all-night use.
- Never use hot water bottles in the same bed as an electric blanket, even if the blanket is switched off.
- Make sure you have smoke alarms fitted on every level of your home, and test them regularly.

Waste site fire near Devizes

It took more than two and a half days to extinguish a fire involving some 300 tonnes of residual waste at a recycling centre on the outskirts of Devizes, which started on 17 November.

Firefighters worked through the night to contain the fire, supported by on-site staff who used loading shovel machinery to create fire breaks in the pile of waste.

Because of the size of the waste heap affected, the cause of the fire remains unknown.







Motorcycle safety focus of fire station display

Firefighters at Stratton fire station are again supporting the Christmas road safety campaign with a dramatic visual display.

This year's road traffic collision reconstruction, at the fire station in Highworth Road, involves a car and a motorbike, kindly provided by Grist Environmental. There is also a banner that says: "Don't get smashed – don't drink and drive".



Dorset & Wiltshire Fire and Rescue Service runs Biker Down Wiltshire, which is a free course available to motorcyclists and motorcycle clubs in Wiltshire and Swindon. A similar programme is available in the Dorset area, organised by the DocBike project.

Whether you ride your motorbike with a group of friends or on your own, there may be a time when you are the first person at the scene of a fallen biker. Injured motorcyclists need to be dealt with in a specific manner as it can be easy to cause them further injury, particularly by removing a crash helmet unnecessarily, or in the wrong way.

- Wiltshire Police recorded crime has been stable with a slight increase by 2.2% in the 12 months to December 2021 and continues to have one of the lowest crime rates in the country.
- Wiltshire Police has seen a 12.7% reduction in vehicle crime and a reduction of 11.2% in residential burglaries in the 12 months to December 2021.
- Our service delivery remains consistently good.
- In November 2021, we received:
- 8,787 '999' calls, (answered within 8 seconds on average);

Stop and Search information for Devizes CPT

During the 12 months leading to December 2021, 119 stop and searches were conducted in the Devizes area of which 77.9% related to a search for controlled drugs.

During 73.1% of these searches, no object was found. In 26.9% of cases, an object was found. Of these cases 78.2% resulted in a no further action disposal; 21.8% resulted in police action being taken; 7.6% resulted in an arrest.


- Hate Crime across force in December has reported a

	Priority	Update
	Op Elf	Op Elf was a focused operation on the build up to Christmas to provide a visible presence in and around the towns shops in order to dissuade potential thieves and reassure the public. The festive period often means that people are out getting presents, and withdrawing cash for loved ones — unfortunately this is not lost on those wishing to prey on the casual shopper and takes the form of purse snatches, pick-pocketing as well as general thefts from shops and shoppers. Op Elf saw officers and staff from various teams focus on providing extra presence where it was needed the most. This was well received by the community, with lots of positive feedback received in person and on various social media platforms.
Page	Shoplifting Crime Spike	Devizes has experienced an increase in Shoplifting offences in January and February. Enquiries have revealed that a few individuals are responsible for the vast majority of these offences. It has yet to be established officially, but it is highly likely that items being stolen are being used to fund drug habits. We have been working with the shops in the town to ban these individuals, with the most prolific being issued with a Community Protection Warning. This warning has since been breached by the individual and so is being escalated to a Community Protection Notice that carries with it specific conditions and legislative sanctions when breached.
e 31	ASB & Youth Engagement	Reports of Anti-Social Behaviour in Devizes has reduced over the past quarter but still continues to be a significant issue for the residents of Devizes. We have been working with a number of partners to seek solutions, including youth engagement sessions and multi-agency discussion on individuals of note. Significant time and effort is being invested by the police and our close partners in order to bring this issue to an acceptable level. This is clearly a long term issue that requires sustained attention by the Neighbourhood Police Team, so this will continue as an area priority for some time.
	Storm(s)	The recent storms have required a significant response from Police and partners. Special mention goes out to our colleagues in the fire service, highways and the local authority for working closely with us to resolve some of the disruption caused. Across the county we logged over 620 incidents in relation to Storm Eunice alone, causing police services to be stretched significantly. We are aware that the public felt that a better service was needed in some areas (London Road closures for example) but hope that the scale of the issue faced by all of the public services can be acknowledged and appreciated by those that feel we could have done better. Teams pulled some extremely long shifts in dangerous conditions to bring the town back to some sense of normality as soon as possible.



Covid-19 vaccinations

As at 9 February 2022, more than 2.1 million Covid-19 vaccinations have been given out at sites across Bath and North East Somerset. Swindon and Wiltshire.

Since the beginning of 2022, more than 3,000 adults have come forward for their first vaccination. This is partly due to the innovative ways in which the vaccination offer has been taken to the heart of people's communities. Pop-up vaccine clinics have taken place in sports clubs, community centres, places of worship and even pubs thus removing previous barriers to uptake including inconvenience and proximity to a site.

Children aged between five and 11-years-old, who are deemed to be clinically extremely vulnerable, can now get a single dose of the Covid-19 vaccine from more than a dozen venues across the region. Efforts to make settings as comfortable as possible for this audience are being offered including 'Superhero' themed child environments at Salisbury City Hall, that also have therapy dogs for the children to cuddle and play with.

More than 30,000 secondary school children have received a first dose of the Covid-19 vaccine, and more than 10,000 have had a second. This means the Bath and North East Somerset, Swindon and Wiltshire area is leading the way in vaccinating 12 to 15-year-olds, with current uptake being the highest in the south west. Children in this age group are being offered the vaccine in school but can also get the jab at evenings and weekends from venues such as Salisbury City Hall.

Walk-in vaccination appointments are still available at a number of sites. Pre-booking at many venues is no longer a requirement. It is hoped that by removing the booking process, people who may have been putting off getting vaccinated, perhaps due to work, home or other commitments, will find it easier to get protected.

All vaccination centres, including those that offering walk-ins, are listed on NHS England's national Find My Nearest Walk-in Vaccination service.

Those using the online tool will be able to see a list of the vaccination centres closest to them by entering their postcode in the search box.

Current pressures on local health and care system

The health and care system in Bath and North East Somerset, Swindon and Wiltshire continues to face enormous pressure. A main contributing cause is Care Home capacity issues as a result of Covid-19 which directly impacts on discharge flow for Wiltshire patients out of hospitals.

A number of initiatives have been implemented to alleviate pressure and help with flow through Salisbury hospital by discharging patients who are well enough to go home. These include:

- The commissioning of 7 beds at South Newton Hospital for admissions until the end of March 2022.
- Supporting the wider CCG system to open and effectively use additional capacity in Bath, including a Care Hotel and opening additional capacity on a community ward at St Martin's Hospital in Bath.
- Working with the provider, Abicare, to maximise the use of additional Live In Carers.
- Collaboration with Wiltshire Council and Wiltshire Health and Care on several initiatives including the provision of two CCG colleagues to the Wiltshire Flow Hub and an area-wide call-to-arms to support additional domiciliary care provision as part of the Council's Support at Home service.

Appeals to the public to support services during this difficult time are ongoing. The main messages being for people to use our health services appropriately, support hospitals by collecting loved ones as soon as they are ready to go home, using our pharmacies for help and support wherever possible and using the online 111 service in the first instance.

Wiltshire Link Schemes

Wiltshire Link Schemes are community-based, volunteer run charities which aim to improve the quality of life for disadvantaged, elderly or infirm people by providing transport and 'good neighbour' services.

Link schemes help to keep local communities connected to vital services, by connecting volunteer drivers (using their own cars), with passengers who have limited access to transport. Depending on volunteer availability, this can involve taking someone to a medical appointment, taking them shopping or providing 'good neighbour' services like prescription collection.

There are currently 42 schemes in Wiltshire supported by 1,567 volunteers. Together in 2021 alone, they completed over 23,136 everyday tasks and offered over 81,000 hours of support. The economic value of the schemes in 2021 was over £1million pounds.

Our Shaping a Healthier Future – Health and Care Model Consultation

Our Shaping a Healthier Future public engagement programme to seek local people's views on our developing health and care model concluded in mid-December. The model sets out what health and care services will be like for people in the next ten years and will provide a framework to ensure we take a coordinated approach to how we design and plan services across our partner organisations.

People across BSW have shared their thoughts and opinions by taking part in a short survey online and by attending in-person engagement events. Around 750 people completed our survey and almost than 1,200 people attended workshops and interviews.

The completed findings and recommendations will be presented at a forthcoming BSW Partnership Board on 25 February 2022 that will be held in Public, with supporting papers being available on the CCG website on the 18 February. Oximetry

The oximetry service in Bath and North East Somerset, Swindon and Wiltshire CCG is going from strength to strength. The service enables clinically vulnerable patients with Covid-19 who are isolating at home to measure their own oxygen levels and send data into local hospitals for monitoring.

If clinicians spot any early warning signs in terms of low blood oxygen levels – which can lead to complications and poor outcomes – the patient can then be admitted to hospital where they can receive treatment.

The remote home oximetry service is supported through collaboration between a number of health and care partners including hospitals, Medvivo and the West of England Academic Health Science Network.

Annual Health Checks for people with Severe Mental Illness (SMI) and learning disability

The Bath and North East Somerset, Swindon and Wiltshire CCG are launching new initiatives to encourage people to come forward for their Annual Health Check (AHC). The AHC is offered to people with learning disabilities and also those living with Severe Mental Illness (SMI) as a recognised, evidenced method of improving their health. They are vital to ensure that these patients remain safe and clinically well, and also to inform the review and update of the patients' health action plan.

People living with severe mental illness (SMI)1 face one of the greatest health inequality gaps in England. The life expectancy for people with SMI is 15–20 years lower than the general population. This disparity in health outcomes is partly due to physical health needs being overlooked. Smoking is the largest avoidable cause of premature death, with more than 40% of adults with SMI smoking. Individuals with SMI also have double the risk of obesity and diabetes, three times the risk of hypertension and metabolic syndrome, and five times the risk of dyslipidaemia (imbalance of lipids in the bloodstream) than the general population.

Poor uptake for health checks is proven to lead to earlier diagnoses of life limiting conditions and leave individuals with poorer health outcomes should they succumb to COVID-19.

In response, First Option Healthcare have been commissioned to support local GP surgeries with AHCs and have already completed over 1300 health checks since they started in February 2021. The BSW team are leading a focused effort in reaching children and young people, working with Special Schools across Wiltshire to be able to extend the offer and offer AHCs in school settings. The initiatives form part of the operational plan for 45% of eligible individuals to have completed their AHC by March 2022 and further work to drive awareness of the importance of having and access to AHCs is being planned.

Devizes Health Centre

The construction of the Devises Health Centre has now passed the half way point and is on track to open later this summer. Devizes Health Centre will be one of the region's first integrated care centres with several organisations coming together to provide a range of health services from one building. Healthwatch Wiltshire are currently conducting a survey to collect thoughts on service provision covering aspects such as opening times and what services would be desired at the centre. Integrated Care Board

As we move towards the establishment of the Integrated Care System (ICS) on a statutory footing on 1 July 2022, we welcomed Sue Harriman to the CCG in February 2022 as Chief Executive Designate of the BSW Integrated Care Board (BSW ICB) and are making good progress with the recruitment to other roles on the Integrated Care Board.

Sue brings a wealth of NHS experience. She joins from the Solent NHS Trust where she was Chief Executive for eight years. Whilst at Solent she took up a six-month

secondment at Chief Operating Officer for the national Covid-19 vaccination deployment programme.

Following more than 16 years of clinical experience gained from working as a nurse in the Royal Navy, Sue joined the NHS in 2002 as a nurse consultant in infection prevention. Since that time, Sue has held various executive roles within the NHS, including as a Director of Nursing and Allied Health Professions, Chief Operating Officer and Managing Director before becoming Chief Executive at Solent NHS Trust. Under her leadership, Solent NHS Trust achieved an improved Care Quality Commission (CQC) rating, from 'requires improvement' to good overall with outstanding in the caring domain.

Sue was appointed to the Chief Executive Designate position last November and has now officially started her new job which will see her work with health and care partner organisations and VCSE groups across BSW to improve outcomes in population health and healthcare; tackle health inequalities in patient outcomes, experience and access; enhance productivity and value for money and support broader social and economic in the local area.

As regards other roles for the ICS, recruitment for four of the five the Non-Executive roles has also completed. Appointments are in the process of being finalised for the Non-Executive Director roles covering Audit, Public & Community Engagement, Quality and Remuneration & People. Further information on the appointments will be made available shortly. An appointment was not made for the role covering Finance and this will be re-advertised.

Recruitment for the Integrated Care Board Director positions for Medical, Planning & Performance, Strategy & Transformation and Chief Nurse is also underway with the closing date for applications being the 28 February. Recruitment for the Director of Place roles will commence at the start of March.

3. Air Quality Data	GT described that the AQ data from December was now available and looks to show an improvement on pre-Covid levels. GT will share graphs to show this data once ready. GT covered the incoming UK Environment Act and the changes this will introduce. The new Act aims to fill gaps left in legislation caused by Brexit where the UK does not currently have rules covering these elements. The Act will bring in legally binding environmental targets, including for air quality to be in place by October '22 and of at least 15 years duration. There will be a new requirement that Local Authorities must have regard to the National Air Quality Strategy when exercising any public function that could affect air quality. Local authorities are no longer required to "work toward" air quality standards and objectives. Requirements around Air Quality Action Plans will become more specific. "Air Quality Partners" will be created to cooperate towards air quality functions. These can include e.g. transport planners and other agencies to help create AQ Action Plans. JS asked how town councils could work with Wiltshire Council and would they be considered AQ Partners. GT said that where town and parish councils have an AQ responsibility, e.g. in planning, then Wiltshire Council will include them. Greater emphasis will be put on PM2.5 in terms of monitoring and action. There are limitations on the sources of PM2.5 that we can influence – sources include sea-spray and pollen but man-made sources include brake dust, agricultural fertilizers and burning biomass for energy. Targets for PM2.5 are currently based on AQ hotspots leading to designations of AQMAs. In future will have an exposure objective to lower a pollutant to a particular level. Also discussed were proposed reductions to WHO thresholds for NOx, PM10 and PM2.5 and how they will affect UK thresholds. GT agreed there's still debate if the UK will adopt these as they are very aspirational.	GT

Mere TC currently lease the town's car park from Wiltshire Council, so a decision to release a parking space for the Co Cars vehicle would be down to them. Co Cars has arranged for a townwide survey about the use of the car club to take place over Christmas and January. This was online and the Wiltshire Councillor wanted there also to be a paper-based version available too, which the CEM had to arrange and analyse. Wiltshire Council has asked the legal team to look over these arrangements for the area board to enter into an agreement like this with Co Cars. The vehicle and equipment will not belong to the area board or town council. As well as an opportunity for local people to access a vehicle, this scheme is intended to boost Mere's economy by attracting visitors from the nearby A303 to charge their vehicle and spend some time in the town. MA said that when he had been talking with Enterprise Cars, they had been looking at 3 cars for a town the size of Devizes. Within the town, the cars would be located where there was the greatest demand for them, based on a survey of residents. At 3 vehicles for Devizes, that could increase any financial support to £15k. There were questions about the business risk and who would take that? The opportunity for car club vehicles to be based or serve the new Gateway station came up. AJ pointed out the need for car parking spaces for the vehicles, particularly at EV charging points. He questioned whether Parking Services would give up the income from these spaces. AJ was asked to make contact with Co Cars and set up a meeting between them and this group CR pointed out Co Cars also operate e-bikes and cargo bikes.	AJ

As a rural parish, there are few facilities in the village, and the Parish Council is passionate about striving to ensure that those we have, are fit for purpose, and meet the needs of the community. Every effort has been made to maintain the existing equipment in as good a state of repair as possible, but we have now reached the point that complete refurbishment is the only real solution. The planned refurbishment aims to widen the age-range and accessibility of the play area, increase the level of usage, and make it safer to use.

The QWBP was started at the end of 2020 with the establishing of one wildflower bed and the planting of daffodil bulbs. 2021 saw further planting of 2 pollinator beds, 6 apple trees, 3 wildflower beds, sowing yellow rattle in an experimental portion of the meadow, and the planting of 1700 bulbs in the meadow below the Quakers Walk trees. A large proportion of the cost of the trees, seeds and bulbs has been met by committee members. The newly formed Committee plan to build on the success of last year's planting by establishing two more wildflower beds, one at the top and one at the bottom of the meadow, plus a further pollinator bed, and more fruit trees. The QWCBG has also been successful in applying for the Woodland Trust free trees and plan to plant 105 berry producing hedgrow late in March. Further funding is required to enable the progress of the 2022 Plan. This will include the planting of an oak to contribute towards the Queen's Green Canopy to celebrate the Queens Platinum Jubilee. We are also collaborating with the Sustainability Devizes and the Devizes Biodiversity Strategy. We believe the project supports The Wiltshire Green Blue Infrastructure (GBI) Strategy.

Project Summary:

As a Scout Group in a rural community through the support of unpaid volunteers we are the main provider of youth activities in the village. We currently have Beaver, Cub and Scout units covering the ages 6 to 14 and we are in the process of trying to establish an Explorer Scout unit to cover the ages 14 to 18. During the pandemic we have somewhat bucked the national trend by expanding the unit so that we currently have 76 young people (with waiting lists for each group) as well as 20 or so adult leaders and helpers. Open to girls and boys we offer a wide range of activities which involves to use of fixed premises in Urchfont and off site activities including camping, canoeing, archery and climbing. As an integral part of the village the group also supports many community activities including recently helping planting trees as part of the Urchfont environmental initiative as well as litter picks in the village and the group parades at the annual remembrance day church service. We are looking for a grant for revenue support, we run a lot of activities and camps which incur transport and activity costs. These costs are currently paid partly by the parents of the children taking part and partly by fund raising by the group. We also have ongoing costs of renewing equipment and maintaining a very old scout hut which recently required an asbestos survey to be undertaken and has resulted in some remedial work needing to be carried out.

Since January '22, following a short period of consultation with Devizes School, St James Church and the school have been trialing a new form of schools-based Chaplaincy and mentoring support. The school provides the space and support, and St James provides the Chaplain, Youth Work intern Bethany Kinderman. The Chaplain works in collaboration with year heads and the pastoral team, but is seen by students and staff alike as outside of the school system and therefore a neutral person to connect with and seek support from. Generally speaking chaplaincies - support the mental, emotional, relational and spiritual wellbeing of students and staff - are a place where students and staff feel cared for and safe - foster ways for students and staff to develop meaningful and spiritually rewarding lives - build a bridge between the school, church, and the wider community At Devizes School the Chaplaincy/Mentoring provides support to students and staff via 6 different provisions 1. 1-2-1 support of students identified and signposted by leadership team, year heads, or pastoral team 2. 1-2-1 support of students and staff self-referring to the Chaplain 3. coordinating and providing oversight of peer-created peerled student support groups 4. coordinating and delivery of workshops providing support in areas of wellbeing identified by students 5. coordinating and delivery of after-school provision for students in need of a space to be (Crammer Café) 6. coordinating volunteering opportunities to students, particularly those in 6th Form, in the wider community As well as the Chaplain themselves, the role also enables the additional provision of trained volunteer mentors from the local community working through the Chaplaincy. Some aspects of this provision are in collaboration with WYFC. The benefit of having a Chaplaincy/Mentoring post in the school is already be realised during the trial (please see uploaded Trial Review submitted by Clare Dale, Head of 6th Form). For students struggling with stuff in their lives, having time to chat with Bethany has been the difference between them being able to flourish and cope, or their situations escalating to the next level of trauma and need. That Bethany is available to all, is onsite, with access to support requiring no referral system or a requirement to meet a needs-threshold, means students can get support when they need it and where they need it, thus minimising the impact on their wellbeing and education. The funding we are applying for will enable the trial to evolve into a permanent component of the pastoral provision at Devizes School.

1. Background

- 2.3. Councillors need to consider any recommendations made by sub groups of the Area Boards.

3. Environmental & Community Implications

Grant funding will contribute to the continuance and/or improvement of cultural, social and community activity and wellbeing in the community area, the extent of which will be dependent upon the individual project.

4. Financial Implications

Councillors must ensure that the Area Board has sufficient funding available to cover the grants awarded.
