Dean Hoskins – Dorset and Wiltshire Fire and Rescue Katie Brown – Prevention and Wellbeing Team (Wiltshire Council) 79 Minutes On the proposal of the Vice-Chairman, seconded by Cllr O'Neill, it was resolved to make the: **Decision** To approve the minutes of the meeting held on 7 March 2023 as a true and correct record. 80 **Declarations of Interest** The Chairman and Vice-Chairman declared that they were members of Calne Town Council, defined as an Other Registerable Interest in Wiltshire Council's Code of Conduct. However, they had been granted dispensations to vote on the town council's applications by Wiltshire Council's Standards Dispensation Sub Committee, so would vote on their application. Cllr Rounds and Cllr Thorn also declared that they were members of Calne Town Council. The Democratic Services Officer noted that Wiltshire Council had resolved, on 16 May, to delegate responsibility for the approval of dispensations for Other Registerable Interests to the Monitoring Officer. The Monitoring Officer was in attendance at the Area Board, so Cllr Rounds and Cllr Thorn requested dispensations to vote on Calne Town Council's grant application. The requests to vote were approved by the Monitoring Officer. The Chairman, Cllr Thorn and Cllr O'Neill all declared interests in relation to the Friends of the Marden Valley grant application. Cllr O'Neill clarified that he was making a declaration for the purposes of transparency. Cllr O'Neill and the Chairman only attended their meetings, so it was not an Other Registerable Interest as defined in Wiltshire Council's Code of Conduct. The Monitoring Officer confirmed that the Chairman and Cllr O'Neill would be able to participate and vote on the Friends of Marden Valley application. Cllr Thorn declared an Other Registerable Interest, as he chaired the meetings of Friends of Marden Valley. The following partners also provided verbal updates:

Wiltshire Police

Sgt Mike Tripp gave an overview of recent operations and community policing work. Key points included:

- The new Chief Constable, Catherine Roper, was passionate about community policing and keen to improve engagement.
- Police Community Support Officer (PCSO) Mark Cook had been working closely with local schools and youth clubs.
- There had been fewer incidents of youths coming from Devizes to Calne exhibiting violent behaviour. Community Protection Warnings had been given to several individuals.
- PCSO Nicole Sheppard was operating again in the Calne Area.
- Operation Exit had seen the police work alongside licensed premises to reduced anti-social behaviour in Calne and make the public feel like it was a safe environment for an evening out.
- The town had recently had an issue with drink related anti-social behaviour, with a particular issue with underage drinkers being supplied with alcohol by older people. However, Sgt Tripp was pleased to say that recent efforts to tackle this issue had reduced the number of incidents.

During the discussion, the Area Board thanked the police for their community engagement work. Cllr Rounds praised the impact that the Police and Crime Commissioner and Chief Constable for the positive action they were taking, stating that their work was paying dividends with a noticeable increase in police presence. Cllr Thorn reported that he had attended a Neighbourhood Watch event in Devizes where they had shown an excellent video on online safety and suggested that this topic could be considered at a future Area Board.

Dorset and Wiltshire Fire and Rescue

Watch Manager Tom Burns provided an update. In response to a query from the Vice-Chairman about their online recruitment the Watch Manger said they had had a positive response, although did face challenges getting employers to release their employees at the appropriate time. The Watch Manager confirmed that there was no upper age limit for volunteers, although they would be expected to complete a fitness test.

Calne Community Safety Forum

Diane Gooch from Calne Community Safety Forum explained that they received a presentation from PC Jonathan Bourke at their last meeting and were trying to set up safe spaces for people with dementia. An event about understanding dementia would take place in Calne Library at 2pm on 1 June and they would be working closely with local businesses.

Calne Without Parish Council

Keith Robbins explained that they had recently held their annual Full Council meeting and that road safety had been an important area of focus, particularly in Derry Hill and Studley. The parish council were conducting a survey of footpaths in the area to establish their usage and maintenance requirements. They also aimed to write a pamphlet about the different types of footpaths in the parish.

Cherhill Parish Council

Tributes were paid to David Evans, who had recently passed away, for his community work in the parish. It was reported that his funeral was due to take place at 1pm, on 26 May, at St James' Church, Cherhill.

Heddington Parish Council

Mark Cawley explained that an IT issue had been resolved so the minutes of their recent meetings were now available on their website.

Hilmarton Parish Council

Shawn Warren-Willcox reported that their play park had now been completed and thanked partners for the financial support that they had provided for the project. The parish council now had funding to install speed indicator devices (SIDs) on the A3102 and were looking at options for funding their installation on posts.

Bremhill Parish Council

The Vice-Chairman of Bremhill Parish Council, Isabel McCord was unable to attend but provided an update to be included with the minutes.

- Highway related issues were the main concern of residents.
- The parish council welcomed that the measures submitted to the Local Highway and Footway Improvement Group to improve road safety are being included in the Priority Schemes List.
- The parish council found the All Things Roads meeting useful in raising further issues to improve road safety which they will pursue moving forward.
- The revised neighbourhood plan is currently with Wiltshire Council for review and advice on how to proceed to completion.
- The parish council continued to work with community groups and neighbouring parishes to improve biodiversity and the environment. There would be a Himalayan Balsam Bash on the River Marden and its tributaries on 16 June.
- Strong community spirit and engagement made sure each day of the coronation weekend was celebrated with social events.

Health

During the discussion about health-related issues, members spoke about the challenges in getting NHS dentistry appointments. Cllr Thorn stated that he understood that there were currently no vacancies for NHS dentistry services in the county. He also stated that he would welcome a more detailed report from the BaNES, Swindon and Wiltshire Together, Integrated Care Board.

The Vice-Chairman highlighted that he would welcome a report about the progress towards delivering a new medical centre in Calne, including a timeline of planned works. The Practice Manager at Northland's Surgery, Allison Ingham, explained that they did not have enough room for staff at their current estate, so several of their employees had to work from home.

The Area Board stated that they would be happy for the Chairman to write a letter to the Integrated Care Board about the delays in delivering the new centre. Cllr O'Neill said that he would welcome an update about the project at a future meeting.

83 Area Board End of Year Report

The Area Board Delivery Officer, Louisa Young, introduced a report detailing the progress that the Area Board had made towards its priority goals since 2021. The Area Board then watched a video about some of the valuable projects that they had supported.

84 Area Board Priorities - Looking Ahead

Having reviewed the progress that they had made towards their priorities over the past two years, the Area Board were invited to consider their priority actions for the forthcoming year and to appoint Lead Members to those priorities. Cllr O'Neill noted that he had not been a Lead Member for a specific priority area for 2022/23 as he had been Chairman of the Area Board. He spoke about his keen interest in improving transport in the Area Board and suggested adding transport as a fifth priority area, which he could lead on.

The other members welcomed Cllr O'Neill's suggestion and stated that they felt it would be beneficial to retain their priority areas from 2022/23 in order to build upon the work that they had already undertaken.

On the proposal of Cllr O'Neill, seconded by Cllr Thorn, it was resolved to make the:

To retain the four existing priority areas and appoint the same Lead Members as 2022/23.

86 <u>S106 Working Group - Meeting Update</u>

The Vice-Chairman gave an update from the last meeting of the S106 Working Group on 27 April 2023. Key points included:

- Milestone had conducted a series of trial holes to explore the possibility of widening Abberd Brook Way.
- Discussions were ongoing about rights of way near to the former Co-op site whilst the planning application was awaited.
- Potential bids for S106 money would be put in for any planning approvals on Sand Pit Road.
- Connectivity between sites was very important.

Although not S106 money, discussion turned to the recent £7 million grant from the Department for Transport's Safer Roads Fund to improve safety on the A3102. Cllr Thorn noted that Calne Town Council was investigating the possibility of using this funding to improve the White Heart roundabout. Cllr Thorn suggested setting up a workshop with local parishes to see what the priorities were in the local area for the use of this funding. Cllr O'Neill welcomed the suggestion and stated that, as Lead Member for transport, he would be happy to set up a working group and invite representatives from each parish. Shawn Warren-Willcox from Hilmarton PC welcomed the plan, explaining that it was important to ensure that the views of smaller parishes were heard.

87 <u>Area Board Funding</u>

Consideration was given to three applications made to the Community Area Grants Scheme. Applicants were invited to speak in favour of their applications.

Atwell Wilson Motor Museum Requesting £1,100 Towards a Defibrillator

On the proposal of Cllr Rounds, seconded by the Vice-Chairman, it was resolved to make the:

Decision

To award Friends of Marden Valley £3,250 towards river quality measurement.

Reason

The application met the 2023/24 Community Area Grant criteria.

Cllr Thorn and Cllr O'Neill returned at 19:55pm.

Consideration was given to three applications made to the Youth Grants Scheme. Applicants were invited to speak in favour of their applications.

The Area Board Delivery Officer noted that the Area Board would have £2,663 remaining in the Youth Budget for the rest of the financial year if all of the applications were approved in full. She noted that the application from Calne Town Council had been deferred from the previous meeting as not enough members had received dispensations for the meeting to be quorate. It was confirmed that the stake series event could not be funded from the 2022/23 Youth Budget, despite initially being due for consideration at the last meeting.

Calne Town Council requesting £1,220 towards the 2023 Skate Series Event

On the proposal of Cllr Rounds, seconded by the Vice-Chairman, it was resolved to make the:

Decision

To award Calne Town Council £1,220 towards the 2023 Skate Series Event.

Reason

The application met the 2023/24 Youth Grant criteria.

Youth Adventure Trust Requesting £4,000 Towards Supporting Vulnerable Young People on a Resilience Programme

The Area Board received information about the adventure and mentoring programme and sought confirmation about the ages of the children that would benefit. On the proposal of Cllr O'Neill, seconded by Cllr Thorn, it was resolved to make the decision:

Decision

To award The Youth Adventure Trust £4,000 towards supporting vulnerable young people on a resilience programme.

Reason

The application met the 2023/24 Youth Grant criteria.

The Rise Trust (Youth) Requesting £5,000 Towards Rise Youth Clubs

Members welcomed the proposals and thanked the Rise Trust for the fantastic work that they were doing. Some members did raise concerns about the level of detail included in the application and asked further queries about the costings and age range of the young people who would benefit. Danielle Blake from the Rise Trust explained that an individual youth club session coast around £230 and that the £23,000 project cost listed on the application was the amount ringfenced within the Trust specifically to support young people. She also noted that they had recently lost £5,000 in funding from Greensquare Accord.

Due to the limited funding available in the Youth budget for the remainder of the financial year, Cllr Thorn queried whether it would be possible to award half of the money at this meeting and for the application to come back later in the year.

The Area Board Delivery Officer confirmed that it would not be possible to approve part of the money at the meeting and for the remaining funds to be considered at another meeting later in the financial year.

The Monitoring Officer confirmed that it would be possible to approve an application in principle subject to further information.

On the proposal of Cllr O'Neill, seconded by Cllr Thorn, it was resolved to make the following:

To approve in principle the awarding of £5,000 to The Rise Trust (Youth) towards their Rise Trust Youth Clubs, subject to receiving further detailed

information about the project.






Calne Town Crime and Incident Statistics

The strategy sets out BSW Together's ambition as partners working across the health, social care, voluntary and other sectors to support the people of BSW to live happier and healthier for longer.





Heritage Survey of the Wilts & Berks Canal

John Henn April 26th 2023 revised May 8th 2023

This document is the first stage of an investigation to see how the Wilts & Berks Canal fits into the (heritage) landscape. It covers the Calne Community Area.




It does not look at the infrastructure of the canal (locks bridges etc.). This will be for another document.

Studley Mill

There may have been a fulling mill at Studley in the 13th century and one is recorded in 1602 driven either by the Marden or Whetham Stream but the site is unknown.

A grist mill known as Hassell's Mill on the Marden east of Norley House in late 17th century was replaced by New Mill on or near the same site in 1728 and was used for grinding corn until the middle of 20th century. It was demolished in 1962.






Moss's Mill

Situated south of Berhills Farm, Moss's Mill was the property of the lord of Studley Manor from the mid. 17th century, perhaps earlier and was used for fulling.

We know it was occupied by Thomas Hale, a drugget maker in 1735 because there is a lease agreement letting the partial use of the mill to another drugget maker. The document grants the use of "two tucking or fulling mills, part of Moss's Mill, Calne, for the tucking, fulling and braying of 20 pieces of drugget every week in the year."

The use of two drying racks was also included. The rent was 10p for each full batch of cloth plus two pieces of each variety produced.



It was operating as a grist mill in the 18th century and in 1761 was said to contain two flour mills.

It was rebuilt as a corn mill in the early 1820s, but a directory of 1822 records that part of the mill was occupied by William Gatehouse, a list maker. List is a term to describe the selvage of cloth, but there is no indication of what Gatehouse produced. It was often used to make slippers.

The stable block was part of the mill complex and would be used as part of the interpretation of the mill. Part of the building could be turned into stables.

It is suggested that the Stable block could also be used as an information centre and class room for wildlife and ecology. The stable block would complement the educational aspects of Moss's Mill.

The stable block rebuilding would be done in close collaboration with the Wildlife Trusts.

Moss' Mill continued to operate as a corn mill run for some years by Keevil and Sons, millers and corn and cake merchants, until it burned down in a fierce fire in 1962.

It is proposed that the mill could be rebuilt with a multi-functional working waterwheel:

- 1) Turn a grind stone to produce flour
- 2) Generate electricity

The ground floor of the "mill" building could be set out as a "hands on" class room. Children could be involved in making flour and baking.

Possible educational themes:

- The history of various and different types of mills around Calne; flour production and weaving.
- Sustainable Energy

The upper floor will set up for accommodation of large Groups

The mill rebuilding would be done in close collaboration with Calne Heritage Centre.

An exhibition area next to mill could also have narrowboat exhibits and possibly a floating classroom.

Possible themes: Living on a narrowboat, Education for families on working boats.

Town Mill (Now Calne Town Hall)

Located in the centre of Calne, Port Mill was probably held with Calne manor by Fulk de Cantelo as early as 1199. It was certainly part of Calne manor from the mid-13th century. In 1651 it incorporated a grist and a malt mill.

The old building was demolished around 1806 and a new one constructed adjacent to the original site. It became one element in a group of two storeyed buildings on the site, the principal one having five bays on its north front and a large carriage arch spanning the width of two bays.

This building was bought from the lord of the manor, Lord Lansdowne by the Borough in 1884 to provide a site for the new Town Hall which opened two years later.

Calne

In the 10th century and possibly earlier Calne was a locally prominent settlement. It stood on a large estate of the king and had an early church. The pattern of streets in Calne in the Middle Ages had almost certainly changed little by the mid-18th century. It was an early borough and market town and from the 16th century to the 20th derived its prosperity from cloth making and food processing


In 1801-2 the Wilts. & Berks. canal was extended to the Town mill at the east end of Cox's Hill from a basin 200 m. south of the mill. The extension was achieved by canalising the Marden. A wharf was built on the west side of that stretch of the canal and, 120 m. south of the mill, a building was erected incorporating a wharfinger's house and what was probably warehousing. Unusually for Calne, the house is of sandstone; its front range has a three bayed ashlar façade with a fluted frieze similar to that of Castle House. The building was in use as a community centre in 1999 (Marden House). About 1806 a new mill was built near the existing mill, which was demolished

When the wharf was built the bridge over the Marden linking Patford Street and Patford Lane was replaced by a new bridge, on the same site or nearby, near the wharfinger's house, and in 1801 a new road was built along the east bank of the canalized river.


Between Port bridge and the Town mill there was a pool in the Marden to serve the mill, and from the 17th century or earlier the adjoining land was called the Strand. From *c*. 1801 the Marden fed the mill and the canal through a long and narrow pond across the Strand, where there was a place for horses to be washed and watered. The water was confined to vaulted culverts between 1840 and 1843, and the Strand, which from about then was used as a market place, became a town square. The Town mill was demolished in 1884, and a new town hall, completed in 1886, was built on the site of the mill.



There are no plans to reinstate Calne Wharf. Navigation will terminate in Castle Park




The hatches where the canal joined the river. The final lock in Castle Park raises the water level to allow boats to use Calne Wharf.

Harris Bacon Factory Calne

It was founded by Sarah Harris in 1770, but by then pigs were already being imported in from Ireland and surrounding farms. She ran her butcher's shop on Butchers Row and from there the company grew over 200 years.

In 1856 there was an experimental ice-house built at the back of a High Street shop with ice from Norway brought in on barges up the Wilts & Berks Canal.

By 1863, the business had grown so much that the railway came to Calne and stayed open for 102 years until 1965. It was built almost opposite the entrance to the factory and provided useful import and export of Harris' products.

At its peak the C&T Harris factory employed 2,000 people, processing 5,000 pigs a week, producing 100 tonnes of pies, sausages and cooked meats. The Harris brand remained strong by changing hands and merging with other companies, surviving until 1982. It was demolished in 1984. After its demolition the site was redeveloped, incorporating a new library, shops and houses. The name lives on in street names, public buildings and a recreation ground gifted to the town.

Chippenham Calne Railway Line

The **Chippenham and Calne line** was a five mile long single-track branch railway line that ran along the valley of the River Marden from Chippenham on the Great Western Main Line to Calne, via two intermediate halts, Stanley Bridge Halt and Black Dog Halt. The railway was built by the Calne Railway Company and opened in 1863, the line was sold in 1892 to the Great Western Railway company

- Stanley Bridge Halt opened 3 April 1905.
- Black Dog Halt: opened early on as a private station for the Bowood Estate of the Marquess of Lansdowne; a temporary platform there had been opened for a fete in 1870 and the station itself seemed to follow soon after; in April 1898 the GWR asked to erect a sign marked *Black Dog Station*, but this was refused; it was finally made a public station on 15 September 1952

The immediate result was an opening to a goods train on 29 October 1863; live pigs for Harris's factory were a major part of the load. Opening to passengers took place on 3 November 1863

From 1900 to the 1930s the line handled much passenger and freight traffic, making Calne one of the busiest stations in Wiltshire. During the Second World War there was heavy passenger traffic for the RAF establishments at Lyneham, Compton Bassett and Yatesbury, which continued into the early 1950s

With the increase in road vehicle usage throughout the 20th century, use of the line by passengers and for freight purposes declined steadily, and in the 1960s it was clear that the future of the line was doubtful. Freight traffic had disappeared by the time the last passenger train ran on 18 September 1965. The track was lifted in 1967. Much of the line is now a cycle path. It is part of Sustrans National Cycle Route no. 403.

Bowood House

Bowood House and Gardens (Source Wikipedia)

Bowood is a Grade I listed Georgian country house in Wiltshire, England, that has been owned for more than 250 years by the Fitzmaurice family. The house, with interiors by Robert Adam, stands in extensive grounds which include a garden designed by Lancelot "Capability" Brown. It is adjacent to the village of Derry Hill, halfway between Calne and Chippenham. The greater part of the house was demolished in 1956.

The remaining house is still large, and the front wing is open to the public with rooms, paintings and sculpture on display. One of the rooms was the laboratory of Joseph Priestley, who discovered oxygen there on 1 August 1774.

Since 1754 the estate has been the seat of the Earls of Shelburne, created Marguess of Lansdowne in 1784.

There are 100 acres of beautiful parkland, designed by 'Capability' Brown, offering a lake, arboretum, pinetum and cascade. Perfect for walks and exploring. Bowood House hosts a wealth of unique items from Queen Victoria's wedding chair to Napoleon's death mask and an extensive art collection.

During the spring (late April to early June) visit the stunning Rhododendron Walks, this woodland oasis offers breathtaking vistas of colour covering over 60 acres.

There are attractive circular walks through the grounds and including the canal and railway.

Charles Barry designed the new entrance at Derry Hill, now called the Golden Gates, which was primarily erected to provide a grand approach from the new train station at Chippenham, which opened in 1841.



3rd Marquess of Lansdowne (1780-1863) restored Bowood Park. He introduced new features such as the Pinetum, designed by his agent and head gardener John Spencer, and the Rhododendron Woodland Gardens.




Case for Support 29/03/2023

The Wilts & Berks Canal Trust has identified £250.6M pa of recurring economic benefits and £45.5M of one-time benefit, resulting from its ongoing 70 mile canal restoration project.

There are 5,000 miles of navigable waterways in mainland Britain. The ongoing regeneration of these canals and rivers, along with bringing a further 500 miles of currently derelict waterways back into use, will provide many benefits. The Wilts & Berks canal restoration will deliver 70 miles of those 500. It is currently the largest such project in Britain.

Abandoned by Act of Parliament in 1914, our canal is at the heart of a partially completed, but strategic, restoration project which will connect the English northern and southern canal cruising rings. Here is a map of the Wilts & Berks canal's route:



The Inland Waterways Association has described the benefits of restored canals under some 12 headings in its 2022 paper, entitled Waterways for Today. We have followed their formula for the description and evaluation of restoration benefits, under 4 broad headings on the following pages, Economic, Natural & Built Environment, Local Communities and Improving People's Lives.

In doing this work we have drawn on many sources, including:

• A Scott Wilson 1999 report to the Wilts & Berks Canal Trust on its economic benefits

- The 2019 Wiltshire Swindon and Oxfordshire Canal Partnership Strategic Plan
- The Canal & River Trust's 2022 Economic modelling
- Comparative data from the fully restored 87 mile Kennet & Avon canal, with which the Wilts & Berks will connect at Semington
- The IWA report, Waterways for Today
- Strategic Housing and Economic Land Availability Assessment (Shelaa) reports from Wiltshire, Swindon and Oxfordshire Councils

Economic Benefits

1. Contribute to economic recovery

Canal & River Trust 2022 modelling, extrapolated for the 70-mile route of the Wilts and Berks, predicts a Gross Value Added (GVA) of **£52M pa recurring** from increased economic activity driven by the tourist attractions of a functioning canal and its associated towpaths.

Please note that the measured resultant new economic activity in the fully restored and 24% longer Kennet & Avon canal, which serves prosperous communities in Bath, Newbury and Reading is some £91M pa. This provides us with a level of confidence that our £52M pa figure is a sensible estimate.

2. Encourage increased spend in local communities

An expected 30,000 new homes along our route with an average of 3 residents spending £2k each locally eventually produces £180M pa when restoration is complete. This is a recurring benefit. For the purposes of this analysis, we have assumed that the average annual benefit during our 20 year restoration is £60M pa recurring.

3. Facilitate savings to the NHS and social care budgets

By extrapolation from modelling by the Canal & River Trust in 2022 we have identified **£38.5M** pa recurring of NHS savings from physical exercise taken by our walkers, cyclists, and boaters.

Natural & Built Environment Benefits

4. Enhance and improve the natural environment

Improvement of the environment along the route of the Wilts & Berks is a core component of our work. We deliver wildflower meadows, pollinator routes and habitat trails and nesting for wildlife. Every project we execute is preceded by an environmental survey which sets out the work required to achieve the maximum of environmental improvement.

5. Protect heritage for future generations, Natural & Built

The 200 year old infrastructure of the Wilts & Berks is seen as our legacy and worthy of best in class protection. Wherever possible we restore and rebuild locks, bridges, culverts and spillways to their original design, often using reclaimed bricks and timber. Where heritage structures have been lost to collapse or materials scavengers we revert to original drawings for rebuilding projects.

6. Improve sustainability and help to combat climate change

Sustainability is at the heart of our restoration project. Our work parties are active throughout the calendar keeping our towpaths clear, dry and safe. We have documented maintenance plans and the equipment required to perform the work our volunteers do in support of their local communities. Our work compounds pursue a low carbon agenda. Many of our tools are now electric and our first electric trip boat became operational in 2022.

Local Communities

7. Connect communities

The Wilts & Berks canal does exactly this. Its route was designed in the 1790s to enable trade between the communities along its route. Our restorations, particularly of towpaths, have improved walking and cycling connections between dozens of our canalside settlements

8. Provide opportunities for education and young people

The Wilts & Berks Canal Trust has an ongoing programme of education involving local schools and young peoples' organisations like the Scouts. Much of this work is focused on the improvement of wildlife habitats and trails, where young people can make a significant and enjoyable contribution.

9. Create jobs, training and apprenticeships in Local Communities

The Scott Wilson 1999 report predicted that the Wilts & Berks restoration project would produce approximately 1,519 person-year-equivalent temporary construction jobs. The financial benefit of this activity, assuming £30,000 pa as the average remuneration of the temporary workforce is a **non-recurring £45.5M**.

Canal restoration requires a range of practical skills which are highly transferable to the wider economy. Canal-based regeneration schemes throughout the UK have provided opportunities for skills development among previously excluded groups.

Improving People's Lives

10. Encourage improved physical health

The anticipated financial benefits from improved physical health are quantified, in item 3 above, at £38.5M pa.

11. Improve mental health and wellbeing

By extrapolation of the 2022 Canal & River Trust report we have **identified £100.1M pa recurring** of benefits from improved mental health and wellbeing.

12. Create better places to live Improving People's Lives

The construction of an expected 30,000 new homes adjacent to the Wilts & Berks, anticipated in Shelaa reports fromWiltshire, Swindon and Oxfordshire Councils, will deliver better places to live over the next 20 years for about 90,000 people. These will be homes either directly on or close to the restored Wilts and Berks canal. We have a showpiece site, now becoming increasingly mature, at Wichelstowe, where up to 4,000 homes will be built on the Canalside development. Canal restoration is embedded in the developer's plans and the relevant

planning consents. We see ongoing collaboration with housing developers as a key enabler for our restoration project.

On Call Recruitment

Have you always wondered if you could join the fire service, but haven't had the opportunity to find out more? Have you found yourself seeking your next challenge, keen to give back to the local community or wanting to learn new skills including leadership and teamwork? Then becoming an on-call firefighter is for you.

As a paid position, on-call firefighters commit anywhere between 60 to 120 hours per week, during which time they must be able to respond to the station immediately.

Many have 'normal' jobs during the day, then upon their return home make themselves available overnight or during the weekends. Some of our crew respond from their workplaces during the day, and we are very grateful to their employers for releasing them to perform their vital duties.

Anyone over 18 years old can apply (although you can also apply once you are 17½) you must be able to respond and attend the fire station within 5-8 minutes, you have a good standard of physical fitness (i.e. you are generally active), and you must have the right to work in the UK.

Demand for our Information & Advice service is growing and we're keen to expand our services so we can support as many people as possible across Wiltshire and Swindon. You may have seen this survey but if you haven't yet completed it, we would love to hear your thoughts.

Expanding our service questionnaire

The Information & Advice service over the last quarter have seen benefits enquiries exceed 50% of total enquiries, and we saw a significant increase in the number of people supported with Attendance Allowance applications.

The Meals+ Service is currently very busy with around 260 clients! See our Service Spotlight below for more about the service.

We now operate **Living Well services** from 15 GP surgeries across Wiltshire, and are providing a wide range of support to patients. See below for a focus on this special service.

"Thank you for your visit today. I really didn't know all these clubs and activity groups were available to me. I have really enjoyed our chat today and your service is fantastic. Thank you!"

Telephone befriending currently have 17 volunteers calling 100 clients and more telephone befrienders have recently joined the team.

"The calls from J are amazing and I always look forward to them, although I've never met her I feel like I've got to know her and I enjoy the updates about her dogs and garden!"

Fitness & Friendship Clubs are now running in 3 sheltered housing centres, (Swindon, Tisbury and Trowbridge). This is in addition to the popular 15 clubs we already have.

"F&F was hysterical yesterday! A real laugh, everyone had a great time. I will definitely be back."

Our new Melksham Community Support Senior Project Worker has started work on the **Melksham Community Support Project** and we'll share more about this in later issues.

Following the merger with Southampton Age UK, there have been some new developments with the Southampton I&A service moving into the Padwell Road Day Centre so the team can all work alongside each other. Recently, the Day Centre held a fundraising event for Breast Cancer Now with games, cupcakes, a stall for the police and entertainment from Eddie Cole which was a great success.

Partnership working

HEALTH AND SOCIAL CARE

At Age UK Wiltshire we work closely with our colleagues in health and social care. As well as delivering services ourselves, we are keen to help to make sure the needs and experiences of older people are taken into account in wider service design and delivery; and to feedback the experiences of the people we support.

Our Chief Executive, Sarah Cardy, is delighted to be the voluntary sector representative on the Wiltshire Health & Wellbeing Board. We are also part of the Neighbourhood Collaborative work in Melksham, around falls prevention.

LIVING WELL SERVICE

One of our flagship services is the Living Well service, with specialist Age UK Wiltshire staff working within 15 GP surgeries across the north and south of Wiltshire.

The Living Well staff work as part of a team of health and social care professionals, offering holistic care and support to older people in those communities. People are referred by GPs for support with a range of issues, including:

- Health falls, anxiety, confidence, eating/drinking
- Practical help domestic, gardening, handyperson
- Housing options, equipment, repairs
- Personal care washing, dressing, hairdresser
- Financial benefit check, Attendance Allowance application
- Social support activities, groups, befriending
- Health professional concern

In Q1, the Age UK Wiltshire Living Well team took 135 new referrals, visiting people in their own homes for a conversation about what's important to them, agreeing how we can support them to promote a sense of health and wellbeing, supporting them to overcome any practical difficulties they are experiencing, and helping people to access a range of activities and services that help to maintain their Independence and connections with their local community.

Rather than simply signposting someone to activities or groups in their area, we recognise that for many people having someone alongside them is crucial, so our Living Well team will often go along with someone while they gain confidence.

"Thank you for sitting and listening to me. This is the first time someone has done this where I was able to discuss my struggles. I really appreciate all you are doing for me."

"Thank you for the time you have spent with me going to the Salvation Army and again today the Hope Centre at St Pauls. I have now got the confidence to go on my own. Your support has been really helpful."

"Everything was looking so gloomy until you came along, you have inspired me. I can't thank everyone enough for all the help I have been offered over the last couple of weeks."

Let's talk about: A Campaign Win! Free prescriptions age frozen at 60

In 2021, the Government announced it was consulting on the option to increase the age for free prescriptions from 60 to 66. Age UK were concerned that this was an unnecessary financial burden to place on older people, particularly those older people on modest incomes or managing multiple long-term conditions. If the government made this change, 2.4 million people over 60 would have been affected and forced to consider not taking important medication.

Following hard work across the Age UK Network over recent years, the Government has confirmed that the qualifying age for free prescriptions will remain at 60.

Those present: WC Officers, Fiona Steven, Mark Stansby, Steve Hind.

Item 1. Abberd Brook Phase 1 progress; Mark Stansby showed maps on screen showing increase widths in places, signage expected and safety measures along the intended route from the Knapp dual use path toward the town centre at the Pippin. Awaiting EA permission and footway closures in place to start work intention for 21st September for 3 weeks. Newsletters to go to householders for any footway diversions. Estimated cost of engineering works £76k with 20% contingency.

Discussion took place to allow access of pedestrians and cycles through any new development at the old COOP site with connectivity from Abberd Brook.

Bids have been considered for funding Abberd Brook Phase 2 (from the Knapp east toward Sandpit Road) from any future developments along or adjacent to Sandpit Road. This route is necessary to join Phase 1 but a more costly project toward and beyond Prince Charles Drive.

It was agreed that any underspend on Phase 1 be put toward design and appraisal for this project. Steve Hind will look at "in house" prelim design works and to get a cost estimate ready for any funds coming forward.

Item 2. Whitehorse Way /Wenhill Lane/ Cycleway signage. Celia confirmed this cycle route is good and better than using the narrow gradient of Spring Lane. Signage and legal issues to be completed.

Item 3. Future Developments: Fiona has submitted Sect 106 bids on the intended Spitfire Road development. Any funds will be put to progress Abberd Brook Phase 2 and other footway issues on route.

AOB: Celia has had meetings with others including Bowood agents concerning the intended dual use path from Church View toward Bentley Lane.

Mark Stansby looked at the possibility of dropped kerbs and widening a cutting toward White Horse Way from the Stoke Meadow development.







<u>Technical Note - A4 Chippenham (Pewsham) to Calne Speed Limit</u> <u>Assessment</u>

The team used the information above to produce the framework drawing indicated at Reference 5 in accordance with the DfT Traffic Advisory Leaflets and Circular. The calculation in the table based on government advice produces assessed speed limits as shown. Recorded injury collisions are a significant part of the assessment process according to the DfT. There is then the opportunity for the experienced engineers to use that assessed limit and other information, such as environmental factors (layout of the road, number of accesses onto the highway, nature of the traffic, etc.) to produce a recommended speed limit.

Traffic volumes were measured over a week and vehicle injury collision data obtained from the police records for the most recent six years.

There were a total of thirty-one injury collisions over the six-year period, one resulting in fatal injuries, six in serious injuries, the other twenty-four involved slight injury. Most of these collisions resulted in more than one casualty, but the numbers shown on the table are for collisions, not casualties.

The mean speed of traffic is measured in accordance with the requirements in the documents above. This is achieved by undertaking journey time surveys. Each section of the route is timed whilst following other vehicles to gain a true reflection of how the road is driven by the general public. This is repeated a number of times to determine an average journey time and hence the mean speed is derived.

The following are comments explaining the recommended speed limits:

Section 1: The existing speed limit is 40mph, the measured speed of traffic was 29.8mph, the assessed limit is 40mph. It is therefore recommended that the speed limit should remain at 40mph.

Section 2: Sections 2A & 2B were initially assessed as one section. It was subsequent to the data collection that it was decided to split the section into Section 2A -East of Norley Lane and Section 2B - West of Norley Lane. It was considered that the highway environment either side of Norley Lane was significantly different. The existing speed limit is 60mph, the measured speed of traffic was 48.0mph and the assessed speed limit is 60mph.

Section 2A: The assessed limit is 60mph which is the same as the existing limit. There are few accesses and dwellings on this section, so the recommended speed limit is 60mph.

Section 2B: Although the assessed limit is 60mph, there are a relatively high number of accesses and dwellings on this section. A reduction in speed limit to 50mph is recommended. The existing speed of traffic fits in with this speed limit. It will also

encourage drivers to keep to a lower speed either side of this section, especially the approach to Studley Lane crossroads.

Section 3: The existing speed limit is 50mph, the measured speed of traffic was 37.7mph, the assessed speed limit is 50mph. It is recommended that the speed limit is lowered to 40mph for this section. Although the assessed speed limit is 50mph, there are a number of accesses and also substantial development on this section. The existing speed of traffic fits in with this 40mph speed limit. The terminal points will be at village name plates/gateway feature. All seven of the reported collisions on this section occurred at or very close to the Studley Lane crossroads, which is within the proposed 40mph speed limit. It is hoped that the lowering of the speed limit will reduce the number of collisions.

Section 4: The existing speed limit is 60mph, the measured speed of traffic was 50.9mph, the assessed speed limit is 60mph. The assessed limit is 60mph which is the same as the existing limit. There are few accesses and dwellings on this section, so the recommended speed limit is 60mph.

Section 5: The existing speed limit is 40mph, the measured speed of traffic was 36.5mph, the assessed speed limit is 50mph. Partly because of the Derry Hill junction in this section, it is recommended that the limit remains at 40mph.

Section 6: The existing speed limit is 50mph, the measured speed of traffic was 44.9mph, the assessed speed limit is 60mph but it is recommended that the speed limit remains as existing at 50mph.

Route 403 Cross Council Working Group Update to Calne Area LHFIG – July 2023

The Working Group was established in 2022 to "preserve and enhance the 403 Sustrans Route between Chippenham and Avebury as a multi-user route for active travel and leisure, well-being and commuting purposes, and to promote its use to, and care by, the local community."

The Group now comprises representatives from Calne Town Council, Calne Without Parish Council, Bremhill Parish Council, Chippenham Town Council, Wiltshire Council's Rights of Way Team, Sustainable Calne and the Chippenham Cycle Network Development Group.

Progress since the previous update (January 2023) includes:

- Additional and replacement signage has been installed along the length of the route between Chippenham and Avebury to improve waymarking for users.
- Sustrans have approved the proposed diversion of the route to the east of Yatesbury, from a field margin onto a parallel byway, offering an improved surface. New signage has been ordered to waymark this diversion on the ground.
- A site visit has been undertaken with Hills Waste Management to review maintenance and surface on the section through their land. Hills have undertaken to cut back overgrown hedges following the end of the nesting season.
- The Group is trying to make contact with the new owner of the meadow immediate east of Low Lane (Valencia Waste Management), with a view to promoting surface improvements.
- The Group has worked with Wiltshire Council's Rights of Way team to improve the track surface at two of the muddiest sections along the disused railway line, near Black Dog Halt and the Hazeland Overbridge.
- The section between Calne and Chippenham has been inspected for barriers to wheelchair or mobility scooter users. Wiltshire Council's Rights of Way team have filled in a cattle grid at the exit from Castlefields Park, which represented a significant barrier. Additional work has been undertaken to address sharp drops at four locations – Black Bridge, Stanley Bridge, Millennium Bridge and Castlefields Park.
- Information boards are being developed to help promote the route to potential users.

Sustrans have completed the Feasibility Study onto possible alternative route options for the NCN Route 403 between Calne and Chippenham. The Working Group has not had sight of the Feasibility Study Report, although we understand that the recommendation is to retain the current alignment along the old railway line.

This section remains reliant on leases with eight landowners, seven of which are five-year leases due for renewal in March 2024. The Working Group is mindful that securing longer-term leases might open up the possibility of longer-term investment into improvements in track surface.
