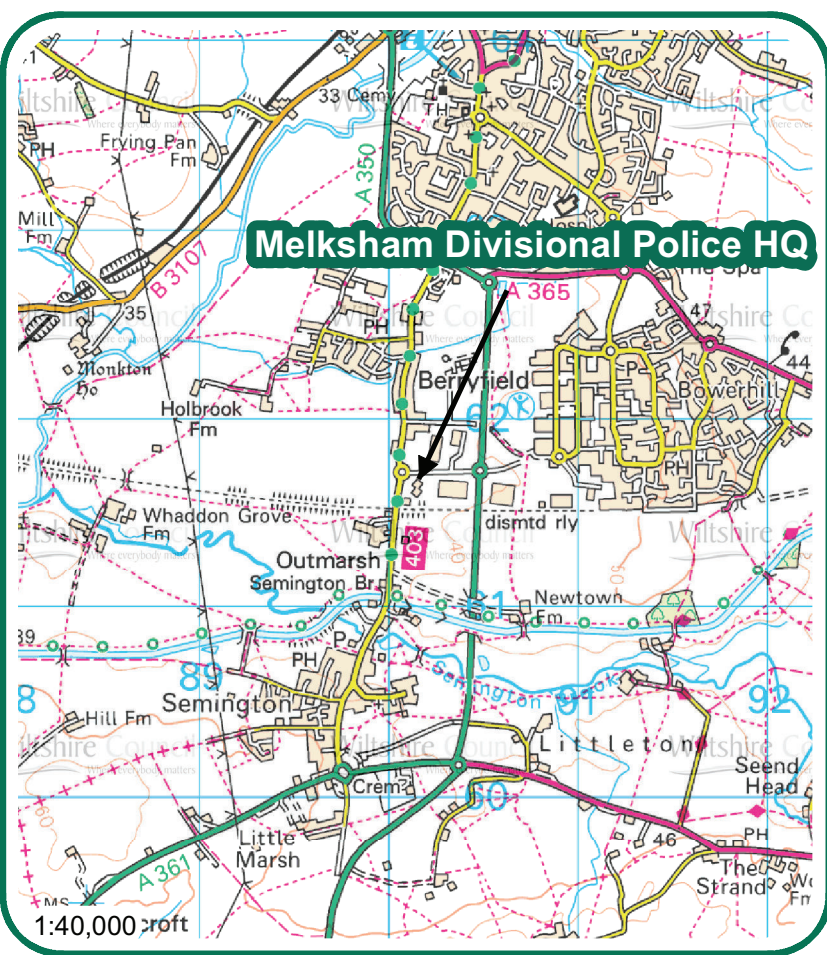
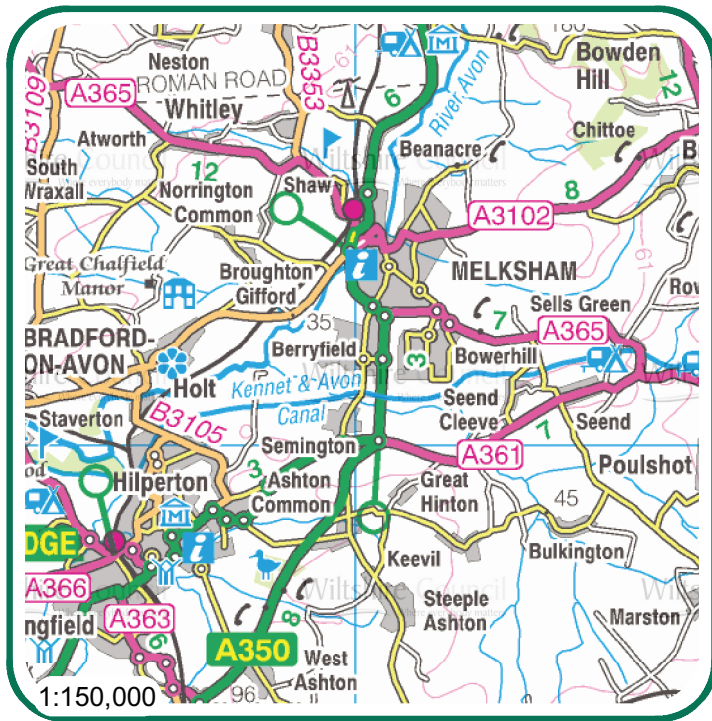

1.	<p data-bbox="336 376 1139 414"><u>Chairman's Welcome, Introduction and Announcements</u></p> <p data-bbox="336 443 1455 591">The Chairman welcomed everyone to the Melksham Oak Community School and then introduced the Wiltshire councillors who made up the area board, supporting Wiltshire Council officers and Cllr Stuart Wheeler, (cabinet member for Campus Development & Culture), who was attending the meeting.</p> <p data-bbox="336 629 1455 777">The Chairman thanked the various stake holders and parish representatives in attendance as well as the Community Area Partnership and the Melksham Skate Park representatives for their respective displays which were viewed before the meeting.</p> <p data-bbox="336 815 1430 853">The following Chairman's announcements contained in the pack were noted:</p> <p data-bbox="336 891 549 929">Core Strategy</p> <p data-bbox="336 967 1455 1032">The core strategy now moves into a consultation period which starts on the 20 February and will run for six weeks.</p> <p data-bbox="336 1070 1455 1135">Copies of the consultation document can be viewed at local libraries as well as Wiltshire Council offices.</p> <p data-bbox="336 1218 616 1256">Localism Act 2011</p> <p data-bbox="336 1294 1251 1332">The Localism Act received Royal Assent on 15 November 2011.</p> <p data-bbox="336 1370 1455 1518">The Act contains a number of <i>enabling provisions</i>. These give the Secretary of State power to introduce regulations and guidance that will make the measures 'live.' We anticipate that the key areas will come into force from April 2012 onwards.</p> <p data-bbox="336 1556 1487 1704">We will provide a more detailed briefing on the implications for Wiltshire early in 2012. Although the Act is 497 pages long, the implications of some of the key measures will not be clear until the Secretary of State has introduced regulations and guidance. We will keep you updated on major developments.</p> <p data-bbox="336 1787 948 1825">Youth Advisory Group (Melksham Pilot)</p> <p data-bbox="336 1863 1487 1928">Melksham is one of four pilot areas trialling a new way in involving young people in decision making in Wiltshire by setting up Youth Advisory Groups (YAG).</p> <p data-bbox="336 1966 1391 2004">Each pilot is focusing on a different aspect of involvement and trying out a</p>

different number of members.

The Melksham YAG will focus on understanding local needs, capabilities and identifying the gaps. The Melksham YAG is working with eight people - 50% of the group are under 19. It is important to remember that the YAG is young people led.

After 3 months we will review all the YAG pilots and see what is working and what could be improved before YAGs are rolled out across the county. The aim is to have a selection of people who represent young people who use both council and voluntary youth services and representatives from Melksham Oak School. The group will meet once a month during the pilot.

The first YAG meeting was held on Tues 31 January 2012. The current membership for the Melksham YAG is:

	<p>offered to mentor the chair of the group.</p> <p>For more information contact Siobainn Chaplin at Canberra youth centre.</p> <p>Help to Live at Home update</p> <p>The council are continuing to work with the NHS, selected providers and residents of Wiltshire to implement the 'Help to live at Home' service. This service will, upon full implementation improve the experiences of people and their carers who require support, whilst ensuring that the changes are sustainable in the future.</p> <p>The main priority at this stage is managing the movement of customers from existing providers to the new Help to Live at Home providers: Enara Complete Care, Ridgeway Care (now re-named Aster Living), Somerset Care at Home and Leonard Cheshire Disability. This is being managed on an individual basis to ensure that customer requirements are taken into account. It is important that these changes are undertaken with as little disruption as possible to the customer concerned.</p> <p>Service to the Community Awards, Wiltshire Police Authority</p> <p>The Wiltshire Police Authority (WPA) Service to the Community Award recognises the exceptional service made by individuals within a Neighbourhood Policing Team.</p> <p>They could be a Police Officer, Police Community Support Officer, Special Constable, or a volunteer - the only criteria is that you believe their service to the Neighbourhood Policing Team has been outstanding.</p> <p>We are now seeking nominations from the public for this Award. 5.	<p><u>Updates from young people's projects funded at the Area Board in May 2011</u></p> <p>Updates were provided by representatives of the young people's groups who had obtained project funding at the May 2011 Area Board meeting for the following projects:</p> <ul style="list-style-type: none"> • Wii Fit • Fun Fitness Dance • Multi Sports Coaching • Aerobic Fitness • Atworth Drama Project <p>Representatives outlined briefly what their projects were and what had been achieved.</p> <p>It was agreed that all the projects had been well received, the Area Board praised the groups for there hard work and for attending to give feedback.</p>
6.	<p><u>Melksham Skate Park Redevelopment</u></p> <p>James Threlfall and Warren Pullinger, Melksham Skate Park Redevelopment Group gave a power point presentation which highlighted the exiting new plans for the revamping of the Melksham skate park. It was envisaged that at a cost of up to £200,000 Melksham could potentially have the best skate park in the South West.</p> <p>The Chairman made the point that this project had massive community benefits and that the Area Board were fully supportive of it. He also asked for the active endorsement and assistance of individual Board members as well as members of the community present to get this new project underway.</p>

8.	<p><u>Digital Literacy - Melksham Pilot Project</u></p> <p>Jenny Wilcockson, Digital Literacy Coordinator, Wiltshire Council gave a power point presentation that outlined the Wiltshire Online project.</p> <p>Points made included:</p> <p>What is Wiltshire Online?</p> <p>By 2015, we will:</p> <ul style="list-style-type: none"> • Improve access to broadband for citizens and businesses in Wiltshire. • Ensure that everyone has the opportunity to become digitally literate and confident users of technology. • Increase uptake and usage of the council’s online services. <p>The Facts</p> <ul style="list-style-type: none"> • Access to more job vacancies: 7m job adverts were posted online in 2009.

- Improved employability: 92 percent of new job recruits are expected to have IT skills.
- People with good computer skills can earn 3 – 10 percent more than those without.
- Shopping online and using price comparison websites can result in savings of up to £560 per year.

- Empowering volunteers to work in their local communities and help local residents and businesses get online.

10.	<p><u>Improving Wiltshire's Rail Offer Letter</u></p> <p>The Melksham Area board received a letter from Councillor Dick Tonge, cabinet member for Highways & Transport requesting that the Area Board supports the Local Sustainable Transport Fund bid – ‘Improving Wiltshire’s Rail Offer’.</p> <p>Decision:</p> <ul style="list-style-type: none"> • That the Melksham Area board supports the Local Sustainable Transport Fund bid – ‘Improving Wiltshire’s Rail Offer’. <p>Cllr Rod Eaton requested that it was noted that whilst he supported the bid for an improved rail service for Melksham, contrary to the letter from the cabinet member for Transport & Highways and the Community Area Manager, he did not accept that sustainable transport was synonymous with public transport and pedal cyclists.</p>
11.	<p><u>Any other urgent items of public concern?</u></p> <p>Mrs Jill Tompkins advised the Area Board of an issue concerning the relocation of RUH, Bath public mortuary and post mortem service to Flax Bourton, Bristol. The Chairman thanked Mrs Tompkins for raising the issue but felt that it was not of an urgent nature and as such should be raised as a community issue, which would then be followed up by the Community Area Manager who would then report back to the Area Board.</p>

14.	<p><u>Cabinet Member Questions</u></p> <p>Cllr Stuart Wheeler, Cabinet Member for Campus Development & Culture, gave a brief outline of his portfolio.</p> <p>Points made by Cllr Wheeler included:</p> <p>Campus</p> <ul style="list-style-type: none"> • That he was pleased that the Melksham House site had become the campus site. • Neighbourhood policing teams were now being co-located in Wiltshire Council offices. <p>Library Service</p> <ul style="list-style-type: none"> • That he was very pleased that Wiltshire Council had kept all its libraries and mobile libraries open, well done to all the volunteer library staff. <p>The Chairman thanked Cllr Wheeler for attendance and update.</p>
15.	<p><u>Grants & Funding</u></p> <p>Community Grants Scheme</p> <p>The Wiltshire Councillors considered five applications seeking 2011/2012 Community Area Grant Funding.</p> <p>Decision Semington Village Hall were awarded £1,222 toward the replacement of the village hall ceiling.</p> <p>Reason <i>The current ceiling is thirty years old and in a poor condition. Members agreed not to fund the full amount, which was £2,443 as they felt there were several other sources of funding that specifically funded village halls that the applicant could have applied to such as Viridor Credits and Community First.</i></p> <p>Decision Splitz were awarded £4075 towards support group for children affected by domestic violence.</p> <p>Reason <i>This application demonstrates a link to the Melksham community plan which prioritised domestic violence as a concern.</i></p>

	<p>Shaw Village Hall were awarded £2,220 towards the installation of a disabled access WC.</p> <p>Reason <i>The project was to improve the disabled facilities of the village hall by relocating the female WC and creating a new unisex wheelchair access WC in the old female toilets. Several groups that use the hall on a regular basis have disabled members. Members agreed not fund the full amount, which was £4,378 as they felt that community grant funds could be better spent on other projects.</i></p> <p>Decision Keevil Parish Council had applied for £444 towards the replacement village signs. <i>This application was withdrawn by the applicant.</i></p> <p>Decision Melksham ComicCon were awarded £1320 towards running the first comic convention in Melksham.</p> <p>Reason <i>This application demonstrates a link to the Melksham community plan which prioritised promoting the local economy and attracting people to Melksham as a concern.</i></p> <p>Cllr Initiated Projects</p> <p>Cllr Hubbard was awarded £425 on behalf of local residents to run a pilot programme for six months which would include installing three dog bag dispensers on litter bins in two locations in Melksham and dispensing dog bags from the town hall in an effort to encourage people to clear up after their dogs and improve the local environment for residents.</p>

Title of Report	Community Area Grants

Purpose of Report

To ask Councillors to consider 3 application seeking 2011/2012 Community Area Grant Funding:

1. **Melksham Adventure Centre** have applied for **£1215** towards upgrading the kitchen. The recommendation is to award the funding.
2. **Melksham CAP** have applied for £500 for a project called Melksham Offers promote shopping in the town centre. The recommendation is to award the funding.
3. **Melksham CAP** have applied for **£106.80** for the purchase of a Volunteer Opportunities Board to Melksham library. The recommendation is to award the funding.

1. Background

- 1.1. Area Boards have authority to approve Area Grants under powers delegated to them by the Deputy Leader and Cabinet member for Community Services (27 February 2010). Under the Scheme of Delegation Area Boards must adhere to the Area Board Grants Guidance for funding.
- 1.2. In accordance with the Scheme of Delegation, any recommendation of an Area Board that is contrary to the funding criteria would need the approval of the Leader, the appropriate Cabinet Member or the Cabinet.
- 1.3. In accordance with the Area Board Grants Guidance officers are required to provide recommendations in their report, however, the decision to support applications and to what level is made by Wiltshire Councillors on this Area Board.
- 1.4. EXAMPLE Two applicants withdrew their applications and hope to reapply at a future date. One application did not meet the funding criteria and was referred to Charities Information Bureau (CIB) for support to seek funding from elsewhere. CIB work on behalf of Wiltshire Council to support community and voluntary groups, town and parish councils to seek funding for community projects and schemes both from the Area Board and other local and national funding sources.
- 1.5. Funding applications will be considered at every other Area Board meeting.
- 1.6. Melksham Area Board has been allocated a 2011/2012 budget of £49,762 for community grants, community partnership core funding and councillor led initiatives. The carry forward from the 2010/2011 budget is £3687. This leaves a total budget of £53,449 for the 2011/2012 budget.
- 1.7. A decision has been made in 2010/2011 that paper copies of funding applications will no longer appear as part of the agenda in an attempt to reduce volume of paper used. However, the application forms will be available on the Wiltshire Council web site and hard copies available upon request.
- 1.8. The 2010/2011 funding criteria and application forms are available on the council's website (www.wiltshire.gov.uk/areaboards) or paper versions are available from the Community Area Manager.

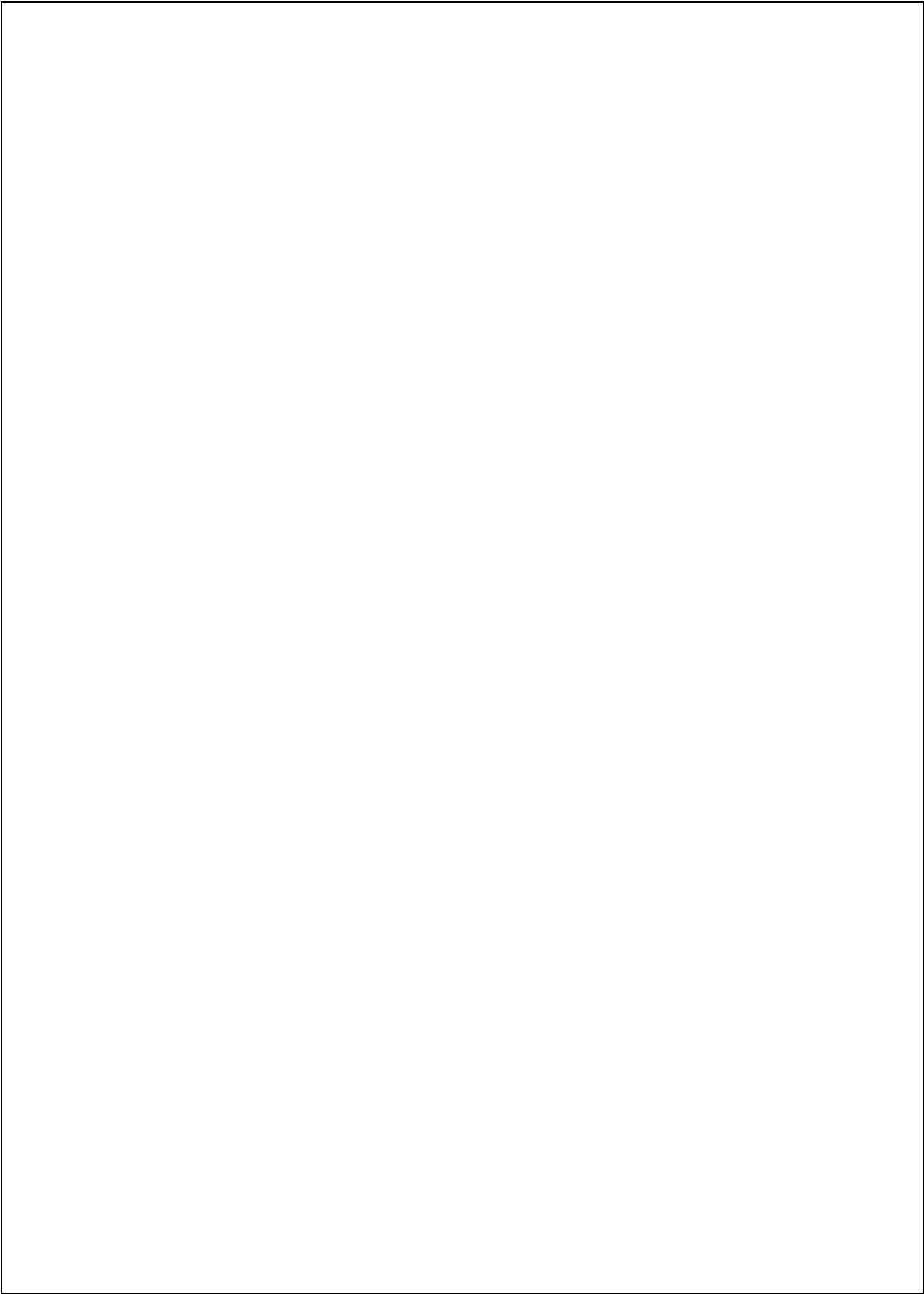

PROPOSAL FOR THE USE OF 50 SPA ROAD, MELKSHAM AS A DEDICATED SUPPORT CENTRE FOR LOOKED AFTER CHILDREN AND YOUNG PEOPLE.

The 'Aspire' Centre

It is proposed that Children and Families Services develops a dedicated support/resource centre "Aspire" specifically and solely for the use of children in the care of Wiltshire Council.

Children and Families Services, has in its portfolio a 5 bedded detached property with an annexe at 50 Spa Road Melksham.

This property was purchased following Cabinet approval in June 2010. At that time there were 27 young people placed in residential children's home provision and there was a projected need to provide further residential places. However, the Children and Families "Change Agenda" has produced more robust case assessment, management planning and review. Improved gate keeping processes and development of a range of creative and innovative placement options have put the service in a far stronger position than could ever be anticipated last year.

Since the Cabinet report of June 2010, there have been significant improvements in the way services are developed and delivered and a positive outcome has been achieved which has reduced the need for a children's home.

The proposed change of use for the property enables Children and Families to now focus more robustly on improvement in two key areas:

- The increase in young people who are in or have been in the care system, to engage in education, employment or training and sustain a high level of engagement. This facility will also enable a higher proportion of Care Leavers to graduate from university due to the support programmes that will be put in place.
- The centre will facilitate support for children who are estranged from their families and for whom, without specific intervention, reunification will not be an option.

The centre will operate in 52 weeks of the year, Monday to Friday 8.00am up to 8.00pm, Saturday 9.00am to 3.00pm with only occasional Sunday opening for specific events. The centre will be managed by the Virtual School Headteacher, working in close partnership with the Head of Children in Care.

Programmes will range from one-to one support in literacy, numeracy and IT, to group activities such as homework club; life-skills workshops including cooking, budgeting and promoting healthy living; gardening; CV writing, performing and creative arts sessions, peer mentoring, and so on.

This is an exciting opportunity to improve the life chances of Wiltshire' children in care.
