5	Chairman's Announcements
	The Chairman welcomed Graeme Morrison, Community Engagement Manager, to Devizes and thanked his predecessor, Richard Rogers, for his hard work for the area.
	Attention was drawn to updates in the agenda pack. The Chairman provided further updates that the Devizes Steering Group for 'Safe Places' was re- launching its campaign which involved 31 local businesses The meeting also heard that an Extra Care Scheme on Victoria Road, Devizes, had received planning permission earlier in the year and the contractor was expected to move on site in October 2015.
6	Partner Updates
	Councillors expressed disappointment that no updates had been received from Wiltshire Police, Fire and Rescue Services and the Clinical Commissioning Group, the Board would be putting these complaints in writing to these partners.
	Angus MacPherson, Police and Crime Commissioner, presented on the Annual Report for 2014/15 and the Police and Crime Plan 2015/17. Key achievements over the previous year had been the prioritisation of neighbourhood policing, a 'Good' rating for Wiltshire Police and the commissioning of a single care unit for victims of crime. A refreshed Police and Crime Plan was necessary for 2015-17 as the service had to continue to make efficiencies and new criminal threats,

	such as cybercrime, were emerging. An outline of the new plan was provided and it was stressed that Neighbourhood policing would be protected. During a question and answer session it was confirmed that the Victim Support organisation would be involved in the new care unit for victims.
	Philip Mackie, Devizes Community Area Partnership, updated that the organisation was undertaking the town benchmarking survey. Wiltshire Council was urged to produce a workable timetable for the Connect 2 bus service which had been changed by the Passenger Transport Unit. Cllr Whitehead, Cabinet Member for Highways and Transport, explained the service was currently heavily subsidized by the Council and needed to become more efficient, he encouraged residents to become involved in the consultation on public transport that was planned for later in the year.
	Sue Marshall, Acting Headteacher at Devizes School, advised the meeting the school had recently been rated 'Good' by Ofsted and had pleasing A Level results however would be working hard to improve further. A process for appointing a permanent Headteacher would begin in November.
	The Chairman commended parish councils for developing a Neighbourhood Plan for Roundway, Devizes and Bishops Cannings, and also Potterne for its draft plan now at consultation stage.
7	Local Youth Network
	Sally Willox, Community Youth Officer, introduced a film produced to support young people with Special Educational Needs and Disability. The Chairman thanked those involved in the filming and other members commended the film, it was explained that the film was to be launched at an employers event later in the year.
	The officer updated on projects in the pipeline, including a leadership programme at local schools and a project with Dorothy House. Cllr Mayes congratulated Sally on her work over the last year, from which over 550 young people had directly benefitted.

Members considered applications to the community area grants scheme. Cllr Anna Cuthbert spoke in support of applications from Bromham and Rowde and Cllr Gamble on the application from West Lavington Village Hall. Members commented how the Caenhill Countryside Centre was a fantastic facility and heard the funding applied for would allow more time to be dedicated to workshop facilities in rural craft. Cllr Laura Mayes expressed disappointment with Devizes' School previous level of engagement with the Area Board and hoped this would improve in future. Alex Eaves, School Bursar, explained a further disabled toilet at the school would be used by community groups using the hall and the school had funded the ramps and curbing necessary for disabled access. Summary of announcement:

Wiltshire residents are encouraged to take advantage of free NHS Health Checks, to help reduce the possibility of them developing life threatening conditions and illnesses.

The NHS Health Check programme, commissioned by Wiltshire Council and provided by local GP practices, helps to check people's risk of developing conditions such as heart disease, diabetes and others, with support and advice also provided to help them reduce or manage that risk.

Everyone between the ages of 40 and 74, who has not already been diagnosed with one of these conditions or is otherwise ineligible, is invited every five years to have a free NHS Health Check. The check only takes about 20 minutes and people will be asked some simple questions related to their lifestyles, family history and medication use. Some simple tests including blood pressure will be taken as well as an instant blood test to check cholesterol levels. The results will be discussed and further advice and support provided. Should they be required, additional tests will be carried out.

Keith Humphries, cabinet member for public health: "We want more people to take up the offer of these free NHS Health Checks as they can prevent people from getting a number of serious conditions. "The check doesn't take long but could have long-term benefits and perhaps offer some reassurance and support to people who may be a little worried about their health."

Dr Daz Harding: "GP practices will invite people to attend their NHS Health Check. Many people decline the invite as they feel fit and healthy, or they are too busy, but attending the NHS Health Check is important as many of diseases such as high blood pressure and type II diabetes can come on gradually with no symptoms. So I would urge everybody, when they receive their invite, to make that appointment and attend."

Wiltshire Police has seen movement throughout the local management team. Inspector Armstrong has moved to a position within Custody. I have now taken over as the Sector Inspector with the responsibility for Devizes, Melksham, Marlborough and Pewsey.

Local Issues and crime:

All the Incidents mentioned below were reported between 01/09/2015 and 01/11/2015

Theft - 73 Offences in total:

This total includes 41 offences of shoplifting in Devizes town centre

There have been two thefts of Deisel reported. With winter on its way people will also be topping up heating oil. This could provide opportunities for thieves. Please secure your tanks.

There have been several offences of bicycles being stolen, most of these were not locked by their owners. A local man was caught by local officers riding a stolen bicycle shortly after he had been seen cutting off the lock and riding away. The suspect in interview admitted the theft of the bicycle as well as a handling stolen goods (2 bottles of whisky found in his bag after arrest) and a shoplifting from Poundland.

Violent Crime -64 Offences in total

This total includes public order offences were there has been no assault, 22 of these offences were in private places and 10 were related to alcohol.

There was also a robbery of an elderly lady in Devizes town centre which resulted in some considerable injuries to the victim. I am pleased to report that the lady is recovering well and also a male was arrested soon after the incident and, due to the wealth of evidence gathered, has pleaded guilty at court

and is awaiting sentence. The man who is not from Devizes is unlikely to be back. Also his girlfriend, who was charged with assisting the offender has stated that she intends to move back out of the county, she has stated she dislikes the level of police attention she and the rest of the criminal element of the town receives.

Burglary - 18 Offences in total.

There have been 11 non dwelling burglaries.

There have also been 7 Dwelling Burglaries. There are no direct links between these offences. Items targeted include jewlery and cash.

One of these burglaries occurred on Halloween night and involved a woman apparently using her 3yr old child as a distraction, the child, dressed as a witch as a 'trick or treater' ran into the house on the door being opened, the suspect then used the distraction to steal the victim's handbag from her hall.

Criminal Damage - 32 Offences in total

There is no pattern surrounding the damage reported.

Antisocial Behaviour – 43 reports of antisocial behaviour in total.

The majority of the reports being classed as personal whereby victims are complaining of individuals behaviour e.g Ex partner texting them.

Report to police, or via Crime stoppers, any information you have or any concerns or suspicions about anyone involved in criminality.

- Secure your property
- Mark your property
- Record details of identifiable property and/or take photos of you belongings.

The website *www.immobilise.com* can be used to record these details and may even prevent offenders taking the item in the first place.



In October, PC Jo Newbery joined the team as the rural Beat Manager replacing PC James Sheate. Jo has served her 10 years in the police in Response in Swindon. Joining us from Salisbury is PCSO Sue Greenway who is now on the town centre beat. Sue replaces PCSO Phil Greenaway who has moved to the Youth Engagement Team.

We have promoted our "No trick or treat here" campaign again this year. I am pleased to say that Halloween was enjoyed in a good spirit and we very few complaints of bad behaviour so the local children have enjoyed a trouble free Halloween. This is a great credit to the young people of Devizes.

Up Coming Changes

You may have heard that Trowbridge and Warminster Policing areas have been piloting a new Community Policing model. It has been decided that this model will be pushed out to Devizes and the surrounding area. Exactly what this will mean is yet to be fully decided and is subject of current planning discussions.

You will also see a change to the structure of future Police reports to the Area Board. Subsequent reports will focus on the Wiltshire Police Control Strategy which describes the current and emerging threats that are of greatest impact to Wiltshire's communities. It is set annually following the analysis of all threats, harms and risks (see below).



Wiltshire Police Control Strategy

Devizes NPT focus on High risk offenders by assisting with offender management.

High Risk victims include domestic violence victims, vulnerable victims and safeguarding issues relating to children. Concerns are regularly highlighted to the relevant departments within Wiltshire Police. In addition we are present at many multi agency meetings and work closley with partner agencies.

Cyber Crime is one area we will be focusing on in the coming months with school visits booked to explain to local children how to stay safe on line and avoid online bullying.

Fire & Rescue Service confirms move to community campus in April 2016

The new Dorset & Wiltshire Fire and Rescue Service will occupy part of the Five Rivers Community Campus in Salisbury, following the signing of a lease with owners Wiltshire Council.

The campus will be home to the Service's 'strategic hub', providing:

- A central workplace for its management team and some support functions;
- A number of flexible working options for the new Service personnel, as part of the wider approach to working across Wiltshire and Dorset; and
- A meeting place for teams, departments and the new Fire Authority.

Darran Gunter, Chief Fire Officer (Designate) for Dorset & Wiltshire Fire and Rescue Service, said: "Since we started on the road to combination, we have been clear that we would need some sort of central 'hub' in the Salisbury area to serve the new organisation. We are delighted to have reached agreement with Wiltshire Council over the use of Five Rivers, and we can now focus on getting the accommodation ready for 1 April 2016, when the new Service comes into being."

He added: "The costs of establishing the new hub are being met from a Transformation Grant from the Government, which is also covering other set-up costs such as consolidating our ICT systems. It is important to state that the hub is not a new headquarters; we want to change the way that we work, to reflect how we will have staff across two counties, and that means moving away from the traditional structures of the past."

Alongside work to progress the new Salisbury hub, a detailed review of the whole Service estate across Wiltshire and Dorset is underway. As such, no decisions have yet been made about the long-term futures of any existing premises.

Mr Gunter said: "It is important to emphasise that we are still in the process of determining which members of staff might be relocated to Salisbury from other parts of Wiltshire and Dorset. It is not a case of just moving a set of offices from one place to another. As the new organisational structure is agreed, it will become clear which functions will need to be based at the hub and where we will be able to explore alternative ways of working, such home working or focused team office days."

Stay safe this Bonfire Night

With Bonfire Night fast approaching, Wiltshire Fire & Rescue Service is warning people not to take risks with fireworks.

While most people treat fireworks with respect, a small minority treat them as toys and forget that they are actually explosives. To stay safe this Bonfire Night, always remember the following advice:

- Keep pets indoors and ensure that children are kept safe.
- Make sure that fireworks are kept in a closed box and use them one at a time.
- Read and follow the instructions on each firework, using a torch if necessary.
- Light the firework at arm's length with a taper and stand well back.
- Keep naked flames, including cigarettes, away from fireworks.
- Never return to a firework once it has been lit.
- Don't put fireworks in pockets and never throw them.
- Direct any rocket fireworks well away from spectators. Be particularly careful if you are anywhere near thatched properties.
- Never put fireworks, even those which are fully spent, on a bonfire.
- Safely dispose of fully spent fireworks.
- Soak misfired or partly spent fireworks in a container of water in an area where they cannot be tampered with (preferably away from the display site) and contact the manufacturer or supplier for advice on disposal.

Bonfires present additional hazards so, if you must light a bonfire in connection with a fireworks display:

- Site well away from houses, garages, sheds, fences, overhead cables, trees and shrubs, and always away from fireworks.
- Before lighting the fire, check that no pets or children are hiding inside it.
- Build the stack so that it is stable and will not collapse outwards or to one side.
- Never use flammable liquids such as paraffin or petrol to light the fire.
- Don't burn foam-filled furniture, aerosols, paint tins or bottles.
- Keep everyone away from the fire, especially children, who must be supervised all the time.
- In case of emergency, keep buckets of water, the garden hose or a fire extinguisher ready.
- Pour water on the embers before leaving the bonfire.

New Learning Disabilities services to launch in Wiltshire

A new modern purpose built service for people with complex learning disabilities and challenging behaviour has moved a step closer for NHS Wiltshire Clinical Commissioning Group (CCG) and Avon and Wiltshire Mental Health Partnership NHS Trust (AWP). Work has commenced on the new building in Devizes and includes accommodation for up to nine people meaning that Wiltshire will be able to provide appropriate care for people with specialist needs closer to home and their families.

The new service will open in the summer of 2016 and will be located on land next to Green Lane Hospital, Devizes.

Wiltshire Clinical Commissioning Group (CCG) and Avon and Wiltshire Mental Health Partnership NHS Trust (AWP) have been developing plans since early 2014 so that Wiltshire people who are currently living out of area can return home to Wiltshire where they can receive services for their complex needs.

Up to nine people will be able to live within a home setting and each living area will be fully equipped with a kitchen, en-suite and lounge allowing independent living and self-management – providing them with a 'home from home'. The local residential setting will encourage people to maintain their family relationships, build a fulfilled life through participation in the community provide an enhanced quality of life. Their care will be planned, proactive and coordinated with their involvement so that they have choice and control over how their care needs are met – putting them at the centre of everything we do.

AWP are investing £3m into the building, and Wiltshire CCG will be commissioning services to the tune of £1.4m annually. The building is due to be completed in June 2016. Get the jab, get Flu Safe

NHS Wiltshire CCG is encouraging people to have their flu jab. Flu is a highly contagious infection that anyone can catch, but it can be very serious for some. For most people flu is a relatively mild illness from which they recover within a week or two – yet every year people, especially those at risk, become seriously ill because they don't get their free flu jab.

Flu is not the same as a cold and it affects people of all ages. If you or someone you care for is in any of the at-risk groups listed below you can get a free flu jab from your GP.

- everyone aged 65 years and over
- all pregnant women irrespective of their stage of pregnancy
- Adults and children over six months with long term heart, lung, kidney, liver or neurological conditions
- people with diabetes
- anyone who has a reduced immunity because of an illness or medical condition
- people with asthma
- anyone in long-stay residential care
- carers of disabled or elderly people and healthcare workers that are in direct contact with patients

Staying Healthy this winter

NHS Wiltshire CCG is urging people to keep warm and well this winter, especially as the nights are starting to draw in and the temperature is dropping.

The cold can have serious consequences as it can increase the risk of strokes and heart attacks as well as causing people to catch colds and flu. Wrapping up warm, keeping the heating turned up, making sure you have enough winter food supplies and keeping a well-stocked medical cabinet in case you do catch a cold or flu are all sensible steps to take.

Some tops tips on staying warm and well this winter.

- Keep your home warm set your central heating to between 65 and 70 degrees Fahrenheit (18-21 degrees centigrade). Heat the room you sit in during the day to 70 degrees, and your bedroom to 65 degrees. When it's very cold, set the heating to come on earlier so that you're not waiting for your home to warm up.
- Have your flu jab. Everyone over 65, or with a wide variety of health conditions, is entitled to one free of charge. Immunity takes effect almost immediately, so even though a flu outbreak is currently well underway, you can still protect yourself by getting the jab – just call your GP to make an appointment.
- 3. If you do fall ill with flu, it's best to stay at home. Flu is caused by a virus, and cannot be treated with antibiotics so a visit to your GP is not necessarily the best course of action.
- 4. Vomiting and diarrhoea bugs caused by norovirus are common and very infectious. This can be a very unpleasant condition, but the best advice is to stay at home and drink plenty of fluids until the symptoms pass. Norovirus is highly infectious, with an incubation period of between one and three days. For that reason, you should wait 48 hours after symptoms have stopped before going back to work or your children go back to school.
- 5. Make sure you have enough winter supplies and keep a well-stocked medicine cabinet, with supplies of ibuprofen, paracetamol and your favourite cold remedy at hand.

Where to go when you're ill - The following points should be helpful when deciding who to contact.

- Pharmacies offer over-the-counter medicines and advice. As well as being open during regular retail hours, they operate an out-of-hours service on a rota basis;
- Call NHS 111 for advice or go to NHS Choices website <u>www.nhs.uk</u>. They can give a wide range of advice and information about many conditions;
- Use the minor injuries units at Chippenham and Trowbridge or the walk-in centres in Swindon and Salisbury for cuts, burns and other injuries – but not for colds, flu or vomiting;
- Make an appointment with your own GP an out-of-hours service is also available;
- If it is a genuine emergency, go to your local A&E department or call 999 for an ambulance

	all of these with staff volunteers. These ideas are young person lead and they don't have much opportunity elsewhere to participate in these activities. The projects will be run one at a time and last half term at a time 4-6 weeks.
