How did you discover there was a need for your project and how will your project benefit your local community?

Parental requests, work with other agencies - Surestart, GP's, Health visitors, nurseries, outreach workers. The Joint Strategic Needs Assessment in Wiltshire highlighted the need for action to reduce childhood obesity, and embedding healthy habits from birth, and educating new parents is the best way to achieve this. Obesity was highlighted as a major cause for concern within Warminster in particular.

The project will target the most needy families - including single parents - fathers and mothers, those with additional needs and teenage parents. It will bring together agencies involved with promoting the wellbeing of young babies and children and demonstrate them working together improving families lives within the community.

Any other information about your project.

The 3 sessions would be a pilot project, run by Anybody Can Cook through the Children's Centre. The sessions would be open to families in the Warminster community area. At the end of the session participants will receive at weaning kit - recipe card, hand blender and ice cube trays to encourage them to use what they have learnt at home. One of the main objectives of the course would be to demonstrate to parents through practical hands on sessions how easy and cost effective it is to produce in homecooked baby food of high nutritional value. Encouraging good feeding habits from the beginning, that will last a lifetime, whilst hopefully encouraging parents to think about the way they eat and how it could be improved if required. Previous family sessions have been over subscribed with parents keen to learn to eat more healthily and evidence to show that the recipes are being re-used at home.
