Bell Clappers are generally made of wrought iron or more recently cast iron or spheral graphite. The clappers impact on the inside of the bell at the sound bow and the impact generates the sound hear outsdie the church. To reduce the volume a leather muffle is attached to the clapper. The old muffles have come to the end of their working life, having served the community well for over a century. By tradition bells are rung half muffled prior to the act of remembrance at the war memorial. Bells are rung half muffled as a mark of respect for officials both locally and nationally and at times of national mourning, such as the passing of a monarch, or as recently, the death of Her Majesty the Queen Mother. Bell ringing involves people of both genders and any denomination or faith, including agnostics and athiests. The young and people with disabilities are encouraged to ring. Acts of remembrance encourage the community to draw together to remember the fallen of all conflicts, and volunteering to learn the ancient art encourages the community to pass the tradition down from generation to generation.						
Any other information about your project. Bell ringing is a great social past time, with benefits to the body and mind as both a physical and mental challenge. By it's nature, ringers come from all social backgrounds and classes, young and old. Religious belief or otherwise is not a barrier, it is in fact the reverse, as ringing draws in people from the whole community.
