Woolley Green has long been a hot spot for accidents and this is now exacerbated with the increase of traffic (6000 vehicles a day) many of them being HGVs as they bypass Hilperton, Trowbridge, Bradford on Avon and Bath on route to the M4 and M5. Below is the most recent collision on July17th when 2 HGVs collided outside the cottages fronting the road by Woolley Park farm where a family with 4 children live. 10	We write concerning the recent proposals relating to a reduction of the speed limits on the B3105 either side of Woolley Green. The partial reduction to a 40mph limit is an acknowledgement that there are a real safety issues for both motorists and pedestrians along this narrow, restricted view section of the road and, specifically, through the tight Z-bend at Woolley Green. However, the proposal falls short of adequately addressing these issues. The section to the south east of Woolley Green is to remain at 50mph. There has recently been a serious HGV collision on this stretch at a point near Woolley Park Cottages, where the visibility of oncoming traffic is particularly poor. Motorists invariably tend to accelerate as they leave the Holt Road junction, often approaching the		
	blind spot on this section at something close to 50mph. The whole stretch of this road, from the Bath Road junction to the Holt Road junction should be reduced to a 40mph limit. 11	It is my understanding that a preliminary decision has been made to reduce the speed on the bend at Wooley Green to 40mph. Please could I express my concern that this speed restriction alone is not sufficient. I regularly visit Wooley Green as I am Auntie to two children who live there. I myself have two young children (2 and 5) and we often need to cross the road to visit the park, the town, walk back from school etc. Cars and other vehicles travel at high speed and there is very little time from when they come round the bend to the point where we need to cross (the crossing point). This means that drivers do not have much time to slow down before they are confronted with small children making their way across the road (this can be a slow process at times with a reluctant 2 year old). All possible measures should be used to reduce the speed of traffic e.g. reduce speed to 30 miles per hour through Wooley Green to indicate to drivers that this is a place where pedestrians regularly cross the road and reduce the speed of impact should a child run into the road. Reduce the speed to 40 on the whole of the road so that drivers will approach the area with caution. Warning signs need to be installed so that drivers are made aware of the speed restrictions and likelihood of people/children crossing. 	Whilst the B3105 Woolley Green - Site Assessment produced by Wiltshire Council Speed Restriction 7. states 'it would be reasonable to expect '20' or more properties with direct frontage access' for 30 mile an hour speed limit there is a larger population than you perhaps are not aware of staying and visiting the hotel on a daily basis, walking along and pulling out onto Woolley Street and directly accessing B3105. Many staff walk to the hotel along Woolley Street. Woolley Street is a single file pavement which inevitably means family groups living locally, staying at the hotel and walking into Bradford-on-Avon (to support the local shops, restaurants and attractions) and those using the spa, end up walking in the road. They are walking with pushchairs and as it's a single file pavement, they are inevitably very close to the road.
