#### **Purpose of Report**

1. To consider 1 comment and 1 objection received in response to the consultation for a 20 mph speed limit zone on various roads known locally as Culverhay, Cricklade and a 20 mph speed limit on a section of Bath Road, Cricklade (see **Appendix 2**).

### Relevance to the Council's Business Plan

2. The introduction of lower speeds will encourage pedestrian and cycle use on the road network, encouraging people out of their cars leading to improved individual fitness and building a more resilient community through improved social interaction.

### Background

3. Under planning application 15/08666 a re-design of the following existing roads in Cricklade is taking place: Cherry Tree Road, White Horse Road, Lady Mead, Pike House Close and Fullers Avenue. As part of the delivery of this re-development a change of speed limit on the roads themselves and the main access route of Bath Road has been proposed to secure suitable vehicle speeds and encourage a safer environment. One letter of support was received and one objection. The objection refers to the non-introduction of a 20 mph speed limit on the road known as Doubledays.

#### **Main Considerations for the Council**

- 4. The objection refers to the lack of application of the speed limit on Doubledays. The road network known as Doubledays does not form part of the new development. The development does not have any impact in terms of traffic use on Doubledays. The Traffic Order Scheme is being funded by the developer and as such the Council must demonstrate a relevance to the development scheme of any Traffic Regulation Order. It is the Council's position that such relevance could not be justified and as such Doubledays was not included in this advertisement/Order.
- 5. The introduction of lower speeds on the roads covered by the Order will improve the safety of both drivers and pedestrians while improving the environment for residents.
