Radio Handsets for Town Centre Night Time Economy Purchase 10 new radio handsets and upgrade the night-time economy security radios so that they are on the same network as those used by the Retail Radio scheme during the day. The existing radios are no longer fit for purpose, they are old, broken and not compatible with the existing Retail Radio Scheme. The new radios will be added to the daytime network and managed by the BID, as is the current Retail Radio network. This will provide seamless coverage across the whole network to monitor anti-social and criminal behaviour across the whole period that the town centre is active. Deployment/locations of the radios will be identified and agreed in collaboration with the Community Policing Team. Users of the radios will be charged a deposit for the handsets. The scheme and maintenance of the radios will be managed by Chippenham BID.
