As you know, the reason the bus mounts the kerbs at the expense of public safety is parked cars on the junction. This fits into the council's reasoning for applying the proposed restrictions and should be implemented at this point to. This area in my opinion is the higher risk. In reference to the link road, it's an A Class road, so no speed pumps etc. If applying the proposed parking restrictions on Oatway for the reasons contained in the proposed planning then it's completely counter productive and creates a worse case "For facilitating the passage on the road or any other road of any class of traffic (including pedestrians)" than we currently have on Oatway. There would be little protection for the parents and children forced to park on the link road and the threat is only increased.

I also think that the no waiting should be extended onto Windmill Drive also. Currently, parents park on Windmill Drive for up to 30 mins in the morning and Evening to drop off/collect their children which causes the road to be blocked as they double park. Also, lorries are using Windmill Drive as an overnight parking bay which again causes issues. Recently the bus parks for their break on Windmill Drive near the roundabout blocking the road and causing a blind spot when trying to overtake it. When Windmill Drive is in full use, the above is going to cause severe issues for traffic, but more importantly issues for local residents trying to get to Phase 2.
