To approve the increase of authority daily processing monetary limits in the BACS electronic payment system (PayGate).

## **Background**

 As the Director for Finance and Procurement, I am responsible for any matters relating to Finance and Procurement in the County of Wiltshire on behalf of Wiltshire Council. The power to make a decision in respect of this matter is delegated to me pursuant to Wiltshire Council's Constitution.

#### Reason for decision

- 2. MHCLG has provided funding to support the Covid-19 Business Grants scheme. This funding will be paid to all Local Authorities responsible for administering the scheme on 1 April 2020. The value of this funding for Wiltshire Council is £106m with payments likely to start to be processed the week beginning 6 April. The payment of these grants to businesses is over and above the normal business of the council and will increase the value of daily payments that are processed through the BACS process. The daily values are likely to be significantly in excess of normal BACS processing monetary values.
- 3. As a result of these additional payments that will be made it is necessary to approve the increase of the authority daily processing monetary limits in the BACS electronic payment system (PayGate) from £25m to £40m.

# APPROVAL FOR THE INCREASE OF AUTHORISATION LIMITS IN THE COUNCIL'S ELECTRONIC BANKING SYSTEM, HSBCnet

#### **Decision made**

To approve the increase of authorisation limits in the electronic banking system (HSBCnet) to align with the changes to the Treasury Management Counterparty monetary limits approved under emergency arrangements by the CEOs on 31 March 2020.

### **Background**

1. As the Director for Finance and Procurement, I am responsible for any matters relating to Finance and Procurement in the County of Wiltshire on behalf of Wiltshire Council. The power to make a decision in respect of this matter is delegated to me pursuant to Wiltshire Council's Constitution.

#### Reason for decision

- 2. MHCLG has provided funding to support the Covid-19 Business Grants scheme. This funding will be paid to all Local Authorities responsible for administering the scheme on 1 April 2020. The value of this funding for Wiltshire Council is £106m with payments likely to start to be processed the week beginning 6 April. Holding this value of cash is in excess of any normal business cash holdings values the council would expect to hold.
- 3. A decision has been made under emergency arrangements by the Chief Executive Officers to increase the value of Treasury Management Counterparty monetary limits that were approved by Council on 25 February 2020 as part of the Treasury Management Strategy 2020/2021. This limits have been increased from £15m per counterparty to £30m. As a result of this decision it is necessary to approve the increase of the monetary limits of authorised officers within the council's electronic banking system, HSBCnet to £30m.
