SCHOOL TERMS AND HOLIDAYS 2021/22

<u>Purpose</u>

- 1. The purpose of this item is:
 - i) to report the findings of the consultation regarding proposed school term and holiday dates for 2021/22.
 - ii) to confirm JCC's support for the recommended school term and holiday dates for Wiltshire's Community, Voluntary Controlled and Community Special Schools for the school year 2021/22.

School Term & Holiday Dates - 2021/22

- 2. In line with the recommendation of the JCC at its meeting in November 2019 a variety of interested parties including schools, neighbouring authorities, diocese plus others have been consulted on proposed term dates for 2021/22 (Appendix 1).
- 3. Appendix 2 details comments received as a result of this consultation.
- 4. A number of our neighbouring authorities have now either completed or are in the process of consulting on their own school term dates for 2021/22. The majority of our neighbours to the south west have consulted on dates similar to Wiltshire's proposal.

<u>Proposal</u>

5. The JCC is invited to consider the responses to the consultation on the proposed school term and holiday dates for 2021/22 and decide whether to confirm its support for the dates detailed in Option 2 of Appendix 1.
