Car Park belongs to Wiltshire Council. Joint partnership working with the Town Council. Anti-Social Behaviour in Bath Road Car Park is impacting upon the quality of lives of the residents in Foghamshire which have private access to their properties via the public car park. The youths congregate under the canopy based next to the Public Toilets. Boy racers skid around causing tyre marks in the car park. Their presence is intimidating noisy and unpleasant for local people. The residents regularly call the police but by the time police arrive they flee the area or stop their activities. A CCTV camera solution is proposed that would give live time imagery back to the main CCTV Control Room and also remote access to the police in Monkton Park. Response times and detailed evidence would be improved. The Town Council have recently invested 20000 plus on the latest wireless CCTV technology in the town centre and this camera solution would feed straight into the existing system. Bath Road Car Park is owned by Wiltshire Council and the Bath Road Toilets are leased to the Town Council so this is a joint funded community project for the benefit of local residents and visitors alike. It will also assist in regenerating the Night Time Economy following Covid 19 and be a positive addition to the next Purple Flag submission for the towns reaccreditation in 2021.

We have levelled the existing car park to remove large pot holes and have dug in extra land drains laid hardcore resurfaced the area with gravel and laid new gravel paths from the car park to the courts. We have also replaced the adjacent boundary fence which was installed in the 1920s and has not been repaired since. The car park has suffered particularly from flooding resulting from heavy rainfall recently which meant that it was not possible to reach the courts without getting wet feet no matter what the means of transport. There has been a historic issue with excess water not being able to drain away which has been particularly bad since work was carried out on neighbouring land resulting in a change of levels the car park is now below the level of the adjacent land which meant that excess water sat on the surface in puddles and was not able to drain away. It has been providing a range of services including food parcels cooked meals library befriending advice dog walking and signposting. The group has around 70 volunteers and is set up with policies and safeguarding in place. The group wishes to now evolve into a charity set up to not only provide support but also be an action group for local need. It is in the process of appointing trustees and writing new policies. The group will need to vacate the Bouverie Hall which it currently occupies, and it therefore needs to find new premises and establish itself both constitutionally and financially. While this is achieved, short term funding is required to help with the rent over the coming months.

Input from Community Engagement Manager:

- Pewsey Area Board has worked closely with the Pewsey CCA and this is continuing as it evolves into a charity.
- The benefit to the wider community has been and will continue to be enormous.
- Premises have been found at the Scout Hall but until Pewsey CCA can establish itself, it will need help with the rental. It is providing funding for its other costs
- This application has been submitted following discussions between the Area Board and the Pewsey CCA and is fully supported by the Area Board members
- The Communities Team is in the process of establishing a Wiltshire fund for support groups such as this that wish to evolve into permanent organisations. If other funding can be obtained, then this will be used instead of Area Board money

Project Summary: Amber provides a temporary safe place to live with up to 30 other young people at our residential centre in Wiltshire. There in a

calm and nurturing environment we provide a mix of support structure new experiences and training that builds our residents motivation self-discipline and skills. Those who come to us have been living chaotic lives many of them have suffered neglect abuse and experienced trauma. A qualified counsellor will enable residents to move forward positively and support them to maximise the different opportunities that Amber is able to offer them.

Please tell us WHO will benefit and HOW they will benefit from your project and benefit your local community:

The Amber Foundations Wiltshire centre Bythesea Lodge in Trowbridge is a safe place where we support young people who have hit rock bottom to positively turn their lives around. The majority of those who come to us do just that and move onto education employment and most importantly a safe secure home of their own. We take referrals from a number of agencies across Wiltshire including Wiltshire Council and Housing Options. Amber also works closely with local charities including Breakthrough and Group 5. We currently have 26 young people living at our centre with the majority of these coming directly from Trowbridge. Regular counselling sessions is a vital service we provide at each Amber centre and is especially important to those first settling in to their new life. They need this specialist support to process their pasts and adjust to life at Amber which involves routines structure and living communally. The Need Young people become homeless for a variety of reasons - family breakdown leaving care trauma mental ill-health addiction prison release losing a job. Sometimes people simply make bad decisions and things go drastically wrong. A recent analysis of our own referrals indicated that 62 have mental health diagnosis issues 57 have substance abuse problems 59 have no qualifications or training 59 have a criminal conviction. The Amber Approach Amber plays a unique role in addressing the very complex needs of these young people and provide them with the support and all the opportunities they need to rebuild their lives. The Amber programme has been developed over the last 24 years. It consists of a mix of support structure new experiences and training that builds our residents motivation self-discipline and skills. We help them address any specific issues that may be holding them back helping them to move on from their troubled pasts and find the self-belief and determination to move forward. The programme that Amber provides ensures that the young people that come to us have a number of volunteering opportunities to build on the work experience and skills set. We have a number of local connections that provide invaluable community work including Group 5 and Julien's House Bike Workshop, Our Counselling Support Those who come to us have been living chaotic lives many of them have suffered neglect abuse and experienced trauma. Our counsellors help residents to move forward positively and support them to maximise the different opportunities that Amber is able to offer them. Additionally having a qualified counsellor available to our residents is invaluable as it ensures that significant mental health issues are recognised and appropriate specialist

support services are consulted without delay. Our counselling will be accessible to all of the young people that come through our doors.
