**CALNE ORDER:
PROPOSED WAITING RESTRICTIONS**

Purpose of Report

To:

- (i) Consider objections to the advertised proposals for parking controls at various locations within Calne.
- (ii) Recommend the making of the Traffic Regulation Order with minor amendments to the advertised proposals.

Consultation

As part of the Town centre parking review the Town Council was consulted prior to the advertisement process and seven locations within Calne were put forward to advertisement.

During the advertisement period a total of 26 items of correspondence were received in response to the proposals contained within the advertised Traffic Regulation Order (TRO). Of the 26 items of correspondence received, 13 expressed support for the Council's proposals, 13 objected to the proposals in their current form.

Details of correspondence can be found in **Appendix 1** together with a summary of comments. Officer response to the comments can be found in **Appendix 2**.

Options Considered

To:

- (i) Implement the proposals as advertised.
- (ii) Not implement the proposals.
- (iii) Implement the proposals with amendments.

CALNE ORDER:
PROPOSED WAITING RESTRICTIONS

Purpose of Report

1. To:
 - (i) Consider objections to the advertised proposals for parking controls at various locations within Calne.
 - (ii) Recommend the making of the Traffic Regulation Order with minor amendments to the advertised proposals.

Relevance to the Council's Business Plan

2. The proposed scheme helps to meet key priorities of the Business Plan, as the local community worked together with Wiltshire Councillors and council officers on the proposals – making it an involved community scheme that was delivered together.

The restrictions will help protect vulnerable road users and will support the local businesses by protecting accesses.

Background

3. The procedure for dealing with requests for Parking and Waiting Restrictions was agreed in 2016 [Decision HT-19-16](#). In order to appropriately manage the demand for changes to parking controls it is necessary to engage the Town and Parish Councils in the prioritisation of local demand for new controls in their area, so that limited resources of the Council are directed to deal with the demands which are supported by Town and Parish Councils and identified locally as a priority.
4. Requests from Town and Parish Councils are continually received and scored by Engineers in the Highway Network Management Team. These locations in Calne were considered as part of the 2019/20 reviews.

Detail

5. The TRO for these proposals was advertised from 24 September to 19 October 2020.
6. During the formal consultation period, 26 items of correspondence were received, 13 expressed support for the Council's proposals, 13 objected to the proposals in its current form and 4 commented on them.

Main Considerations for the Council

7. Consideration needs to be given to the responses received and a decision made on the way forward. Statute states the highway is for the passage and repassage of persons and goods, and consequently any parking on the highway is an obstruction of that right of passage. There are no rights to park on the highway but parking is condoned where the right of passage along the highway is not impeded. The consideration of the objections to the introduction of controls has to be considered in this context.

Safeguarding Considerations

8. There is no risk to the Council as a result of these proposals.

Public Health Implications

9. There is none in this scheme.

Corporate Procurement Implications

10. There is none in this scheme.

Environmental and Climate Change Considerations

11. There is none in this scheme.

Equalities Impact of the Proposal

12. There is none in this scheme.

Risk Assessment

13. There is no risk to the Council as a result of these proposals.

Financial Implications

14. There is an allocation in this year's Traffic and Network Management budget for design, implementation, supervision and monitoring works.

Legal Implications

15. All changes to existing parking restrictions require amendments to the TRO. The process is governed by the Road Traffic Regulation Act 1984 and Associated Procedural Regulations. Failure to adhere to the statutory processes could result in the restrictions being successfully challenged in the High Court.
